 Hydrocondone APAP 7.5/200mg and one (1) bottle of Hydrocondone APAP 7.5/325 mg from

15 his employer, Walgreen's Pharmacy # 4243 in Redding, California.

SECOND CAUSE FOR DISCIPLINE

17 (Violation of Drug Laws)
18 12. Respondent is subject to disciplinary action under section 4301(j), in
19 conjunction with section 4060 and Health and Safety Code section 11170 in that without a
20 prescription, Respondent possessed and self-administered Hydrocondone tablets stolen as alleged
21 in Paragraphs 10 and 11, acts in violation of California statutes regulating controlled substances.

PRAYER

WHEREFORE, Complainant requests that a hearing be held on the matters herein
alleged, and that following the hearing, the Board of Pharmacy issue a decision:

A. Revoking or suspending Pharmacy Technician Registration Number TCH
61069 issued to Respondent Britton R. Parrett;
