17 Complainant alleges:

18 **PARTIES**

- 19 1. Virginia Herold (Complainant) brings this Accusation solely in her official capacity
20 as the Executive Officer of the Board of Pharmacy, Department of Consumer Affairs.
- 21 2. On or about February 17, 1999, the Board of Pharmacy issued Pharmacy Technician
22 Registration Number TCH 28413 to Gail Alexandra MacDonald (Respondent). The Pharmacy
23 Technician Registration was in full force and effect at all times relevant to the charges brought
24 herein and will expire on May 31, 2012, unless renewed.

25 **JURISDICTION**

- 26 3. This Accusation is brought before the Board of Pharmacy (Board), Department of
27 Consumer Affairs, under the authority of the following laws. All section references are to the
28 Business and Professions Code unless otherwise indicated.

1 to the extent that the use impairs the ability of the person to conduct with safety to the public the
2 practice authorized by the license.

3

4 "(k) The conviction of more than one misdemeanor or any felony involving the use,
5 consumption, or self-administration of any dangerous drug or alcoholic beverage, or any
6 combination of those substances.

7 "(l) The conviction of a crime substantially related to the qualifications, functions, and
8 duties of a licensee under this chapter. The record of conviction of a violation of Chapter 13
9 (commencing with Section 801) of Title 21 of the United States Code regulating controlled
10 substances or of a violation of the statutes of this state regulating controlled substances or
11 dangerous drugs shall be conclusive evidence of unprofessional conduct. In all other cases, the
12 record of conviction shall be conclusive evidence only of the fact that the conviction occurred.
13 The board may inquire into the circumstances surrounding the commission of the crime, in order
14 to fix the degree of discipline or, in the case of a conviction not involving controlled substances
15 or dangerous drugs, to determine if the conviction is of an offense substantially related to the
16 qualifications, functions, and duties of a licensee under this chapter. A plea or verdict of guilty or
17 a conviction following a plea of nolo contendere is deemed to be a conviction within the meaning
18 of this provision. The board may take action when the time for appeal has elapsed, or the
19 judgment of conviction has been affirmed on appeal or when an order granting probation is made
20 suspending the imposition of sentence, irrespective of a subsequent order under Section 1203.4 of
21 the Penal Code allowing the person to withdraw his or her plea of guilty and to enter a plea of not
22 guilty, or setting aside the verdict of guilty, or dismissing the accusation, information, or
23 indictment.

24 **REGULATORY PROVISION**

25 8. California Code of Regulations, title 16, section 1770, states:

26 "For the purpose of denial, suspension, or revocation of a personal or facility license
27 pursuant to Division 1.5 (commencing with Section 475) of the Business and Professions Code, a
28 crime or act shall be considered substantially related to the qualifications, functions or duties of a

1 licensee or registrant if to a substantial degree it evidences present or potential unfitness of a
2 licensee or registrant to perform the functions authorized by his license or registration in a manner
3 consistent with the public health, safety, or welfare."

4 **COST RECOVERY**

5 9. Section 125.3 of the Code states, in pertinent part, that the Board may request the
6 administrative law judge to direct a licentiate found to have committed a violation or violations of
7 the licensing act to pay a sum not to exceed the reasonable costs of the investigation and
8 enforcement of the case.

9 **FIRST CAUSE FOR DISCIPLINE**

10 **(Conviction of Substantially Related Crimes)**

11 10. Respondent is subject to disciplinary action under sections 490 and 4301 subdivision
12 (l), in conjunction with California Code of Regulations section 1770, on the grounds of
13 unprofessional conduct, in that Respondent was convicted of crimes substantially related to the
14 qualifications, functions or duties of a pharmacy technician. The circumstances are as follows:

15 a. On or about December 13, 2010, Respondent, in San Luis Obispo County Superior
16 Court Case No. F000452974, plead nolo contendere to a felony violation of Vehicle Code section
17 23152(B) [driving under the influence with a BAC of .08% or higher]. Respondent also admitted
18 felony violations of Vehicle Code sections 23538(B)(2) [Excessive Blood Alcohol over .20] and
19 23152(A) [driving under the influence of alcohol/drugs]. Respondent was sentenced to 280 days
20 in jail; three (3) years formal probation; drivers license suspended for four (4) years; was
21 designed a habitual traffic offender; ordered to attend and complete second offender DUI
22 program; ordered to reside in a sober living facility for six months; and pay a \$1855 fine in
23 addition to court fees. The circumstances of the conviction are that on or about October 18, 2010,
24 Respondent operated her vehicle while under the influence of alcohol and drugs. Respondent's
25 blood alcohol content at the time of her arrest was .245 and .259. At the time of Respondent's
26 arrest, she was on probation for a previous DUI conviction and her drivers license was suspended.

27 b. On or about May 21, 2008, Respondent, in San Luis Obispo County Superior Court
28 Case No. M000417071, plead nolo contendere to a misdemeanor violation of Vehicle Code

1 section 23152(b) [Driving under the Influence with a BAC of .08% or higher]. Respondent was
2 ordered to serve 210 days in jail; placed on formal probation for a period of three years; required
3 to complete a Second Offender Alcohol Program; and pay a fine of \$1971.00. The circumstances
4 of the conviction are that on or about April 27, 2008, Respondent operated her vehicle while
5 under the influence of alcohol. Respondent's blood alcohol content at the time of her arrest was
6 .27. At the time of Respondent's arrest, she was on probation for a previous DUI conviction and
7 her drivers license was suspended.

8 c. On or about July 17, 2007, Respondent, in San Luis Obispo County Superior Court
9 Case No. M000405214, plead nolo contendere to a misdemeanor violation of Vehicle Code
10 section 23152(b) [Driving under the Influence with a BAC of .08% or higher]. Respondent was
11 order to serve 30 days in jail; placed on formal probation for a period of three (3) years; ordered
12 to complete a Second Offender Alcohol Program; and pay a fine of \$3343.00. The circumstances
13 of the conviction are that on or about June 23, 2007, Respondent operated her vehicle while under
14 the influence of alcohol. Respondent's blood alcohol content at the time of her arrest was .166.
15 At the time of Respondent's arrest, she was on probation for a previous DUI conviction.

16 d. On or about December 5, 2006, Respondent, in San Luis Obispo County Superior Court
17 Case No. M000395480, plead nolo contendere to a misdemeanor violation of Vehicle Code
18 section 23152(b) [Driving under the Influence with a BAC of .08% or higher]. Respondent was
19 order to serve 4 days in jail; placed on formal probation; ordered to complete a First Offender
20 Alcohol Program; and pay a fine of \$1648.00. The circumstances of the conviction are that on or
21 about November 1, 2006, Respondent operated her vehicle while under the influence of alcohol.

22 **SECOND CAUSE FOR DISCIPLINE**

23 **(Unprofessional Conduct – Dangerous Use of Alcohol/Drugs)**

24 11. Respondent is subject to disciplinary action under section 4301(h), on the grounds of
25 unprofessional conduct, in that Respondent consumed alcohol and four separate occasions and
26 then operated her motor vehicle while under the influence. Respondent used alcohol/drug in a
27 manner dangerous or injurious to herself and the public. Complainant's allegations as set forth in
28

1 paragraph 10, subparagraphs (a) through (d) are incorporated by reference as though fully set
2 forth.

3 **THIRD CAUSE FOR DISCIPLINE**

4 **(Unprofessional Conduct – Conviction of Alcohol/Drug Related Crimes)**


5 12. Respondent is subject to disciplinary action under section 4301 subdivision (k), on
6 the grounds of unprofessional conduct, in that Respondent was convicted of two misdemeanor
7 and two felony violations involving the use, consumption, or self-administration of alcohol.
8 Complainant's allegations as set forth in paragraph 10, subparagraphs (a) through (d) are
9 incorporated by reference as though fully set forth.

11 **PRAYER**

12 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,
13 and that following the hearing, the Board of Pharmacy issue a decision:

- 14 1. Revoking or suspending Pharmacy Technician Registration Number TCH 28413,
15 issued to Gail Alexandra MacDonald;
- 16 2. Ordering Gail Alexandra MacDonald to pay the Board of Pharmacy the reasonable
17 costs of the investigation and enforcement of this case, pursuant to Business and Professions
18 Code section 125.3; and
- 19 3. Taking such other and further action as deemed necessary and proper.
