1	JURISDICTION
1 2	3. This Accusation is brought before the Board of Pharmacy (Board), Department of
	Consumer Affairs, under the authority of the following laws. All section references are to the
3	
4	Business and Professions Code (Code) unless otherwise indicated.
5	4. Section 4011 of the Code provides that the Board shall administer and enforce both
6	the Pharmacy Law [Bus. & Prof. Code, § 4000 et seq.] and the Uniform Controlled Substances
7	Act [Health & Safety Code, § 11000 et seq.].
8	5. Section 4300, subdivision (a), of the Code provides that every license issued by the
9	Board may be suspended or revoked.
10	6. Section 4300.1 of the Code states:
11	The expiration, cancellation, forfeiture, or suspension of a board-issued
12	license by operation of law or by order or decision of the board or a court of law, the placement of a license on a retired status, or the voluntary surrender of a license
13	by a licensee shall not deprive the board of jurisdiction to commence or proceed with any investigation of, or action or disciplinary proceeding against, the licensee
14	or to render a decision suspending or revoking the license.
15	STATUTORY PROVISIONS
16	7. Section 4060 of the Code states
17	
18	No person shall possess any controlled substance, except that furnished to a person upon the prescription of a physician, dentist, podiatrist, optometrist,
19	veterinarian, or naturopathic doctor pursuant to Section 3640.7, or furnished
20	pursuant to a drug order issued by a certified nurse-midwife pursuant to Section 2746.51, a nurse practitioner pursuant to Section 2836.1, a physician assistant
20	pursuant to Section 3502.1, a naturopathic doctor pursuant to Section 3640.5, or a pharmacist pursuant to either Section 4052.1 or 4052.2. This section shall not
22	apply to the possession of any controlled substance by a manufacturer, wholesaler, pharmacy, pharmacist, physician, podiatrist, dentist, optometrist, veterinarian,
23	naturopathic doctor, certified nurse-midwife, nurse practitioner, or physician
24	assistant, when in stock in containers correctly labeled with the name and address of the supplier or producer.
25	Nothing in this section authorizes a certified nurse-midwife, a nurse
26	practitioner, a physician assistant, or a naturopathic doctor, to order his or her own stock of dangerous drugs and devices.

Section 4301 of the Code states in pertinent part:

The board shall take action against any holder of a license who is guilty of unprofessional conduct or whose license has been procured by fraud or misrepresentation or issued by mistake. Unprofessional conduct shall include, but is not limited to, any of the following:

(h) The administering to oneself, of any controlled substance, or the use of any dangerous drug or of alcoholic beverages to the extent or in a manner as to be dangerous or injurious to oneself, to a person holding a license under this chapter, or to any other person or to the public, or to the extent that the use impairs the ability of the person to conduct with safety to the public the practice authorized by the license.

(j) The violation of any of the statutes of this state, or any other state, or of the United States regulating controlled substances and dangerous drugs.

(o) Violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of or conspiring to violate any provision or term of this chapter or of the applicable federal and state laws and regulations governing pharmacy, including regulations established by the board or by any other state or federal regulatory agency.

9. Health & Safety Code section 11350 states:

Except as otherwise provided in this division, every person who possesses (1) any controlled substance specified in subdivision (b) or (c), or paragraph (1) of subdivision (f) of Section 11054, specified in paragraph (14), (15), or (20) of subdivision (d) of Section 11054, or specified in subdivision (b) or (c) of Section 11055, or specified in subdivision (h) of Section 11056, or (2) any controlled substance classified in Schedule III, IV, or V which is a narcotic drug, unless upon the written prescription of a physician, dentist, podiatrist, or veterinarian licensed to practice in this state, shall be punished by imprisonment pursuant to subdivision (h) of Section 1170 of the Penal Code.

10. Health & Safety Code section 11170 states:

No person shall prescribe, administer, or furnish a controlled substance for himself.

11. California Code of Regulations, title 16, section 1770, states: 1 2 For the purpose of denial, suspension, or revocation of a personal or facility license pursuant to Division 1.5 (commencing with Section 475) of the 3 Business and Professions Code, a crime or act shall be considered substantially related to the qualifications, functions or duties of a licensee or registrant if to a 4 substantial degree it evidences present or potential unfitness of a licensee or 5 registrant to perform the functions authorized by his license or registration in a manner consistent with the public health, safety, or welfare. 6 7 COST RECOVERY 8 12. Section 125.3 of the Code provides, in pertinent part, that the Board may request the 9 administrative law judge to direct a licentiate found to have committed a violation or violations of 10 the licensing act to pay a sum not to exceed the reasonable costs of the investigation and 11 enforcement of the case, with failure of the licentiate to comply subjecting the license to not being 12 renewed or reinstated. If a case settles, recovery of investigation and enforcement costs may be 13 included in a stipulated settlement. 14 DRUG 15 Benzodiazepine is a Schedule IV controlled substance pursuant to Health and Safety 13. 16 Code section 11057(d) and dangerous drug pursuant to Business and Professions Code section 17 4022. 18 FACTUAL ALLEGATIONS 19 At all times mentioned herein, Respondent was employed as a pharmacy technician at 14. 20 the Loma Linda University Medical Center Outpatient Pharmacy located in Loma Linda, 21 California. 22 On or about July 5, 2013 at approximately 1:45 p.m., Respondent was on duty as a 15. 23 pharmacy technician at the outpatient pharmacy. Respondent was observed to have slow physical 24 actions and speech, his eyes were glassy and he required a high level of concentration to complete 25 basic and repetitive tasks. Respondent was then screened for the presence of drugs and alcohol. 26 16. Respondent tested positive for the presence of alcohol and benzodiazepine in his 27 system. Respondent did not possess a prescription for the benzodiazepine. 28

1	FIRST CAUSE FOR DISCIPLINE
2	(Administration of Controlled Substance or Use of Alcohol to Extent or in Manner as to be
3	Dangerous or Injurious or to Extent Use Impaired Ability to Conduct Practice Safely)
4	17. Respondent is subject to disciplinary action under Code section 4301(h), in that he
5	administered a controlled substance to himself, and used alcohol to the extent or in a manner as to
6	be dangerous or injurious to himself or others or to the extent that his use impaired his ability to
7	conduct with safety the practice authorized by his license, as set forth in paragraphs 14 through 16,
8	which are incorporated herein by reference.
9	SECOND CAUSE FOR DISCIPLINE
10	(Violations of Drug Laws)
11	18. Respondent is subject to disciplinary action under Code section 4301(j), for
12	violating statutes regulating controlled substances and dangerous drugs, including Health &
13	Safety Code section 11350(a) and 11170, in that he possessed and administered a controlled
14	substance to himself, without a prescription, as set forth in paragraphs 14 through 16, which are
15	incorporated herein by reference.
16	THIRD CAUSE FOR DISCIPLINE
17	(Violations of Pharmacy Law)
18	19. Respondent is subject to disciplinary action under Code section 4301(o) for
19	violating Pharmacy Law, in that Respondent possessed a controlled substance without a
20	prescription in violation of Code section 4060, as set forth in paragraphs 14 through 16, which are
21	incorporated herein by reference.
22	FOURTH CAUSE FOR DISCIPLINE
23	(Unprofessional Conduct)
24	20. Respondent is subject to disciplinary action under Code section 4301 for
25	unprofessional conduct in that he engaged in the activities described in paragraphs 14 through 16
26	above, which are incorporated herein by reference.
