19 **A C C U S A T I O N**

20 Virginia Herold ("Complainant") alleges:

21 **PARTIES**

22 1. Complainant brings this Accusation solely in her official capacity as the Executive  
23 Officer of the Board of Pharmacy ("Board"), Department of Consumer Affairs.

24 **Pharmacy Technician Registration**

25 2. On or about July 17, 2013, the Board issued Pharmacy Technician Registration  
26 Number TCH 132870 to Justin Ehren Foster, also known as Justin Ehren Propps ("Respondent").  
27 The pharmacy technician registration was in full force and effect at all times relevant to the  
28 charges brought herein and will expire on December 31, 2016, unless renewed.

**JURISDICTION**

3. Business and Professions Code ("Code") section 4300 states, in pertinent part:

(a) Every license issued may be suspended or revoked.

1 (b) The board shall discipline the holder of any license issued by the board,  
2 whose default has been entered or whose case has been heard by the board and found  
3 guilty, by any of the following methods:

4 (1) Suspending judgment.

5 (2) Placing him or her upon probation.

6 (3) Suspending his or her right to practice for a period not exceeding one year.

7 (4) Revoking his or her license.

8 (5) Taking any other action in relation to disciplining him or her as the board in  
9 its discretion may deem proper . . .

10 4. Code section 4300.1 states:

11 The expiration, cancellation, forfeiture, or suspension of a board-issued license  
12 by operation of law or by order or decision of the board or a court of law, the  
13 placement of a license on a retired status, or the voluntary surrender of a license by a  
14 licensee shall not deprive the board of jurisdiction to commence or proceed with any  
15 investigation of, or action or disciplinary proceeding against, the licensee or to render  
16 a decision suspending or revoking the license.

### 17 STATUTORY AND REGULATORY PROVISIONS

18 5. Code section 4301 states, in pertinent part:

19 The board shall take action against any holder of a license who is guilty of  
20 unprofessional conduct or whose license has been procured by fraud or  
21 misrepresentation or issued by mistake. Unprofessional conduct shall include, but is  
22 not limited to, any of the following:

23 (h) The administering to oneself, of any controlled substance, or the use of any  
24 dangerous drug or of alcoholic beverages to the extent or in a manner as to be  
25 dangerous or injurious to oneself, to a person holding a license under this chapter, or  
26 to any other person or to the public, or to the extent that the use impairs the ability of  
27 the person to conduct with safety to the public the practice authorized by the license.

28 (k) The conviction of more than one misdemeanor or any felony involving the  
use, consumption, or self-administration of any dangerous drug or alcoholic beverage,  
or any combination of those substances.

(l) The conviction of a crime substantially related to the qualifications,  
functions, and duties of a licensee under this chapter. The record of conviction of a  
violation of Chapter 13 (commencing with Section 801) of Title 21 of the United  
States Code regulating controlled substances or of a violation of the statutes of this  
state regulating controlled substances or dangerous drugs shall be conclusive  
evidence of unprofessional conduct. In all other cases, the record of conviction shall  
be conclusive evidence only of the fact that the conviction occurred. The board may  
inquire into the circumstances surrounding the commission of the crime, in order to  
fix the degree of discipline or, in the case of a conviction not involving controlled  
substances or dangerous drugs, to determine if the conviction is of an offense

1 substantially related to the qualifications, functions, and duties of a licensee under this  
2 chapter. A plea or verdict of guilty or a conviction following a plea of nolo  
3 contendere is deemed to be a conviction within the meaning of this provision. The  
4 board may take action when the time for appeal has elapsed, or the judgment of  
5 conviction has been affirmed on appeal or when an order granting probation is made  
6 suspending the imposition of sentence, irrespective of a subsequent order under  
7 Section 1203.4 of the Penal Code allowing the person to withdraw his or her plea of  
8 guilty and to enter a plea of not guilty, or setting aside the verdict of guilty, or  
9 dismissing the accusation, information, or indictment.

6. California Code of Regulations, title 16, section 1770, states:

7 For the purpose of denial, suspension, or revocation of a personal or facility  
8 license pursuant to Division 1.5 (commencing with Section 475) of the Business and  
9 Professions Code, a crime or act shall be considered substantially related to the  
10 qualifications, functions or duties of a licensee or registrant if to a substantial degree  
11 it evidences present or potential unfitness of a licensee or registrant to perform the  
12 functions authorized by his license or registration in a manner consistent with the  
13 public health, safety, or welfare.

### 11 COST RECOVERY

12 7. Code section 125.3 provides, in pertinent part, that the Board may request the  
13 administrative law judge to direct a licentiate found to have committed a violation or violations of  
14 the licensing act to pay a sum not to exceed the reasonable costs of the investigation and  
15 enforcement of the case, with failure of the licentiate to comply subjecting the license to not being  
16 renewed or reinstated. If a case settles, recovery of investigation and enforcement costs may be  
17 included in a stipulated settlement.

### 18 FIRST CAUSE FOR DISCIPLINE

19 (Criminal Convictions)

20 8. Respondent is subject to disciplinary action pursuant to Code section 4301(l), on the  
21 grounds of unprofessional conduct, in that Respondent committed a crime substantially related to  
22 the qualifications, functions, and duties of a licensed pharmacy technician, as set forth below.

23 a. On or about June 19, 2014, in a criminal proceeding entitled *People v. Justin Ehren*  
24 *Foster*, Superior Court of California, County of El Dorado, Case No. S14CRM0286, Respondent  
25 was convicted by the court on his plea of no contest to violating Vehicle Code section 23152(b)  
26 (driving under the influence of alcohol while having a blood alcohol level of .08% or higher), a  
27 misdemeanor, with one prior; and, a special allegation of Vehicle Code section 23578 (blood  
28 alcohol content of .15% or higher), in that Respondent's blood alcohol level was over .20%. The

1 circumstances of the crime are that on or about January 1, 2014, an officer with the California  
2 Highway Patrol responded to a report of a solo injury accident. The officer found Respondent  
3 lying in the roadway next to his vehicle. The officer observed that Respondent's eyes were  
4 extremely red and watery, he emitted the strong odor of an alcoholic beverage, his speech was  
5 very slurred, and his behavior erratic. Respondent was only capable of performing two field  
6 sobriety tests. A breath test was administered, revealing that Respondent's blood alcohol level  
7 was .29% and .279%. Respondent was taken to the hospital for evaluation and treatment.

8 b. On or about February 7, 2012, in a criminal proceeding entitled *People v. Justin*  
9 *Ehren Foster*, Superior Court of California, County of Ventura, Case No. 2011040836,  
10 Respondent was convicted by the court on his plea of guilty to violating Vehicle Code section  
11 23152(b) (driving under the influence of alcohol while having a blood alcohol level of .08% or  
12 higher), a misdemeanor, with a special allegation of Vehicle Code section 23578 (blood alcohol  
13 content of .15% or higher). The circumstance of the crime is that on or about November 18, 2011,  
14 Respondent drove a vehicle while under the influence of an alcoholic beverage. His alcohol blood  
15 level was .26%/.24%/.25%.

### 16 **SECOND CAUSE FOR DISCIPLINE**

17 (One or More Convictions Involving the Use of Alcoholic Beverages)

18 9. Respondent is subject to disciplinary action pursuant to Code section 4301(k), on the  
19 grounds of unprofessional conduct, in that he has been convicted more than once of a crime  
20 involving the use of an alcoholic beverage, as more fully set forth in paragraph 8, above.

### 21 **THIRD CAUSE FOR DISCIPLINE**

22 (Use of Alcohol Beverages in a Dangerous or Injurious Manner)

23 10. Respondent is subject to disciplinary action pursuant to Code section 4301(h), in that  
24 on or about January 1, 2014, and February 7, 2012, Respondent used alcoholic beverages in a  
25 manner dangerous or injurious to himself and others, as more fully set forth in paragraph 8,  
26 above.


