18 PARTIES

19 1. Virginia Herold (Complainant) brings this Statement of Issues solely in her official  
20 capacity as the Executive Officer of the Board of Pharmacy, Department of Consumer Affairs.

21 2. On or about December 18, 2014, the Board of Pharmacy, Department of Consumer  
22 Affairs received an application for a Pharmacist Examination and Licensure from Gary Griffin  
23 Ramsey (Respondent). On or about December 18, 2014, Gary Griffin Ramsey certified under  
24 penalty of perjury to the truthfulness of all statements, answers, and representations in the  
25 application. The Board denied the application on July 9, 2015.





1 in the application for licensure in that Respondent answered "No" to question number 17 that  
2 stated:  
3 "Have you ever had a pharmacy permit or any professional or vocational license or registration  
4 denied or disciplined by a government authority in this state or any other state?"

5 In fact, Respondent's California Physician and Surgeon's license was disciplined in  
6 2002, as set forth above in paragraph 6. Additionally, on or about November 4, 2004, the Illinois  
7 Medical Board denied Respondent's application for reinstatement of his Illinois Medical license.  
8 On or about February 4, 2008, the North Carolina Medical Board denied Respondent's  
9 application for reinstatement of his North Carolina Medical license. Respondent signed the  
10 application under penalty of perjury on December 18, 2014.

12 PRAYER

13 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,  
14 and that following the hearing, the Board of Pharmacy issue a decision:

- 15 1. Denying the application of Gary Griffin Ramsey for Examination and Licensure as a  
16 Pharmacist;  
17 2. Taking such other and further action as deemed necessary and proper.
