
**DECISION AND ORDER**

**STIPULATED SURRENDER OF  
LICENSE AND ORDER**

16 Respondent.

17 IT IS HEREBY STIPULATED AND AGREED by and between the parties in this  
18 proceeding that the following matters are true:

19 PARTIES

20 1. Virginia Herold (Complainant) is the Executive Officer of the Board of Pharmacy.  
21 She brought this action solely in her official capacity and is represented in this matter by Kamala  
22 D. Harris, Attorney General of the State of California, by Elena L. Almanzo, Deputy Attorney  
23 General.

24 2. Charles Arthur Sawyer (Respondent) is representing himself in this proceeding and  
25 has chosen not to exercise his right to be represented by counsel.

26 3. On or about November 19, 1970, the Board of Pharmacy issued Pharmacist License  
27 No. RPH 26997 to Charles Arthur Sawyer (Respondent). The Pharmacist License was in full  
28

1 force and effect at all times relevant to the charges brought in Petition to Revoke Probation No.  
2 4027 and will expire on September 30, 2012, unless renewed.

3 JURISDICTION

4 4. Petition to Revoke Probation Case No. 4027 was filed before the Board of Pharmacy  
5 (Board), Department of Consumer Affairs, and is currently pending against Respondent. The  
6 Petition to Revoke Probation and all other statutorily required documents were properly served on  
7 Respondent on July 19, 2011. A copy of Petition to Revoke Probation in Case No. 4027 is  
8 attached as Exhibit A and incorporated by reference.

9 ADVISEMENT AND WAIVERS

10 5. Respondent has carefully read, and understands the charges and allegations in  
11 Petition to Revoke Probation Case No. 4027. Respondent also has carefully read, and  
12 understands the effects of this Stipulated Surrender of License and Order.

13 6. Respondent is fully aware of his legal rights in this matter, including the right to a  
14 hearing on the charges and allegations in the Petition to Revoke Probation; the right to be  
15 represented by counsel, at his own expense; the right to confront and cross-examine the witnesses  
16 against him; the right to present evidence and to testify on his own behalf; the right to the  
17 issuance of subpoenas to compel the attendance of witnesses and the production of documents;  
18 the right to reconsideration and court review of an adverse decision; and all other rights accorded  
19 by the California Administrative Procedure Act and other applicable laws.

20 7. Respondent voluntarily, knowingly, and intelligently waives and gives up each and  
21 every right set forth above.

22 CULPABILITY

23 8. Respondent admits the truth of each and every charge and allegation in Petition to  
24 Revoke Probation Case No. 4027, agrees that cause exists for discipline and hereby surrenders his  
25 Pharmacist License No. RPH 26997 for the Board's formal acceptance.

26 9. Respondent understands that by signing this stipulation he enables the Board to issue  
27 an order accepting the surrender of his Pharmacist License without further process.

28 ///



1           15. Respondent shall lose all rights and privileges as a Pharmacist in California as of the  
2 effective date of the Board's Decision and Order.

3           16. Respondent shall cause to be delivered to the Board his pocket license and, if one was  
4 issued, his wall certificate on or before the effective date of the Decision and Order.

5           17. Respondent understands and agrees that if he ever files an application for licensure or  
6 a petition for reinstatement in the State of California, the Board shall treat it as a new application  
7 for licensure.

8           18. Respondent may not apply for any license, permit, or registration from the board for  
9 three (3) years from the effective date of this decision Respondent stipulates that should he apply  
10 for any license from the board on or after the effective date of this decision, all allegations set  
11 forth in the petition to revoke probation in Case No. 4027 shall be determined to be true, correct  
12 and admitted by respondent when the board determines whether to grant or deny the application.  
13 Respondent shall satisfy all requirements applicable to that license as of the date the application is  
14 submitted to the board, including but not limited to taking and passing the California Pharmacist  
15 Licensure Examination prior to the issuance of a new license. Respondent is required to report  
16 this surrender as a disciplinary action.

17           19. Respondent stipulates that should he apply for any license from the board on or after  
18 the effective date of the decision the investigation and prosecution costs in the amount of \$765.00  
19 shall be paid prior to the issuance of the new license.

20           20. If Respondent should ever apply or reapply for a new license or certification, or  
21 petition for reinstatement of a license, by any other health care licensing agency in the State of  
22 California, all of the charges and allegations contained in Petition to Revoke Probation, Case No.  
23 4027 shall be deemed to be true, correct, and admitted by Respondent for the purpose of any  
24 Statement of Issues or any other proceeding seeking to deny or restrict licensure.



16 IT IS HEREBY STIPULATED AND AGREED by and between the parties in this  
17 proceeding that the following matters are true:

18 PARTIES

19 1. Patricia F. Harris (Complainant) is the Executive Officer of the Board of  
20 Pharmacy. She brought this action solely in her official capacity and is represented in this matter  
21 by Bill Lockyer, Attorney General of the State of California, by Jessica M. Amgwerd, Deputy  
22 Attorney General.

23 2. Charles Arthur Sawyer ("Respondent"), is represented by Donald  
24 Fischbach, of Baker, Manock & Jensen, located at Fig Garden Financial Center, 5260 North  
25 Palm, Suite 421, Fresno, CA 93704.

26 3. On or about November 19, 1970, the Board issued Pharmacist License  
27 RPH 26997 to Respondent. The license will expire on September 30, 2006, unless renewed

1 Respondent agrees that cause exists for discipline of his Pharmacist License No.

3 10. Respondent understands that by signing this stipulation he enables the  
4 Board to issue an order disciplining his Pharmacist License No. RPH 26997.

5 CONTINGENCY

6 11. This stipulation shall be subject to approval by the Board of Pharmacy.  
7 Respondent understands and agrees that counsel for Complainant and the staff of the Board of  
8 Pharmacy may communicate directly with the Board regarding this stipulation and settlement,  
9 without notice to or participation by Respondent. By signing the stipulation, Respondent  
10 understands and agrees that he may not withdraw his agreement or seek to rescind the stipulation  
11 prior to the time the Board considers and acts upon it. If the Board fails to adopt this stipulation  
12 as its Decision and Order, the Stipulated Settlement and Disciplinary Order shall be of no force  
13 or effect, except for this paragraph, it shall be inadmissible in any legal action between the  
14 parties, and the Board shall not be disqualified from further action by having considered this  
15 matter.

16 12. The parties understand and agree that facsimile copies of this Stipulated  
17 Settlement, including facsimile signatures thereto, shall have the same force and effect as the  
18 originals.

19 13. In consideration of the foregoing admissions and stipulations, the parties  
20 agree that the Board may, without further notice or formal proceeding, issue and enter the  
21 following Order:

22 ORDER

23 IT IS HEREBY ORDERED that Pharmacist License No. RPH 26997, issued to  
24 Respondent CHARLES ARTHUR SAWYER, is revoked. The revocation, however, is  
25 immediately stayed and Respondent is placed on a probation for five (5) years. Additionally,  
26 Respondent agrees to the following terms and conditions:

27 ///

28 ///

1           1.       **Suspension.** Pharmacist License No. RPH 26997 issued to Respondent is  
2 suspended for a minimum of thirty (30) days. Additionally, prior to resuming practice,  
3 Respondent must show evidence that the PRP approves a return to practice as a pharmacist.

4           2.       **Obey All Laws.** Respondent shall obey all state and federal laws and  
5 regulations substantially related to or governing the practice of pharmacy.

6           Respondent shall report any of the following occurrences to the Board, in writing,  
7 within 72 hours of such occurrence:

- 8           •       An arrest or issuance of a criminal complaint for violation of any provision of the  
9 Pharmacy Law, state and federal food and drug laws, or state and federal  
controlled substances laws.
- 10          •       A plea of guilty or nolo contendere in any state or federal criminal proceeding to  
11 any criminal complaint, information or indictment.
- 12          •       A conviction of any crime.
- 13          •       Discipline, citation, or other administrative action filed by any state and federal  
14 agency which involves Respondent's pharmacist license or which is related to  
the practice of pharmacy or the manufacturing, obtaining, handling or  
distribution or billing or charging for any drug, device or controlled substance.

15  
16          3.       **Reporting to the Board.** Respondent shall report to the Board  
17 quarterly. The report shall be made either in person or in writing, as directed. Respondent  
18 shall state under penalty of perjury whether there has been compliance with all the terms and  
19 conditions of probation. If the final probation report is not made as directed, probation shall  
20 be extended automatically until such time as the final report is made and accepted by the  
21 Board.

22          4.       **Interview with the Board.** Upon receipt of reasonable notice,  
23 Respondent shall appear in person for interviews with the Board upon request at various  
24 intervals at a location to be determined by the Board. Failure to appear for a scheduled  
25 interview without prior notification to Board staff shall be considered a violation of probation.

26          5.       **Cooperation with Board Staff.** Respondent shall cooperate with the  
27 Board's inspectional program and in the Board's monitoring and investigation of Respondent's

28       ///

1 compliance with the terms and conditions of his probation. Failure to comply shall be  
2 considered a violation of probation.

3           6.     **Continuing Education.** Respondent shall provide evidence of efforts  
4 to maintain skill and knowledge as a pharmacist as directed by the Board.

5           7.     **Notice to Employers.** Respondent shall notify all present and  
6 prospective employers of the decision in Case No. 2943 and the terms, conditions and  
7 restrictions imposed on Respondent by the decision. Within 30 days of the effective date of  
8 this decision, and within 15 days of Respondent undertaking new employment, Respondent  
9 shall cause his direct supervisor, pharmacist-in-charge and/or owner to report to the Board in  
10 writing acknowledging the employer has read the decision in Case No. 2943. If Respondent  
11 works for or is employed by or through a pharmacy employment service, Respondent must  
12 notify the direct supervisor, pharmacist-in-charge, and/or owner at every pharmacy of the and  
13 terms conditions of the decision in Case No. 2943 in advance of the Respondent commencing  
14 work at each pharmacy.

15           "Employment" within the meaning of this provision shall include any full-time, part-  
16 time, temporary, relief or pharmacy management service as a pharmacist, whether the  
17 Respondent is considered an employee or independent contractor.

18           8.     **No Preceptorships, Supervision of Interns, Being Pharmacist-in-**  
19 **Charge (PIC), or Serving as a Consultant.** Respondent shall not supervise any intern  
20 pharmacist or perform any of the duties of a preceptor, nor shall Respondent be the  
21 pharmacist-in-charge of any entity licensed by the Board unless otherwise specified in this  
22 order.

23           9.     **Reimbursement of Board Costs.** Respondent shall pay to the Board  
24 its costs of investigation and prosecution in the amount of Five Thousand Dollars (\$5,000.00).  
25 Said costs shall be paid in quarterly installments over the first two years of probation, at the  
26 rate of \$625.00 quarterly. The first installment shall be due within thirty days after the  
27 effective date of this settlement.

28 ///

1           The filing of bankruptcy by Respondent shall not relieve Respondent of his  
2 responsibility to reimburse the Board its costs of investigation and prosecution.

3           10.   **Probation Monitoring Costs.** Respondent shall pay the costs  
4 associated with probation monitoring as determined by the Board each and every year of  
5 probation. Such costs shall be payable to the Board at the end of each year of probation.  
6 Failure to pay such costs shall be considered a violation of probation.

7           11.   **Status of License.** Respondent shall, at all times while on probation,  
8 maintain an active current license with the Board, including any period during which  
9 suspension or probation is tolled.

10           If Respondent's license expires or is cancelled by operation of law or otherwise,  
11 upon renewal or reapplication, Respondent's license shall be subject to all terms and  
12 conditions of this probation not previously satisfied.

13           12.   **License Surrender while on Probation/Suspension.** Following the  
14 effective date of this decision, should Respondent cease practice due to retirement or health, or  
15 be otherwise unable to satisfy the terms and conditions of probation, Respondent may tender  
16 her license to the Board for surrender. The Board shall have the discretion whether to grant  
17 the request for surrender or take any other action it deems appropriate and reasonable. Upon  
18 formal acceptance of the surrender of the license, Respondent will no longer be subject to the  
19 terms and conditions of probation.

20           Upon acceptance of the surrender, Respondent shall relinquish his pocket  
21 license to the Board within 10 days of notification by the Board that the surrender is accepted.  
22 Respondent may not reapply for any license from the Board for three years from the effective  
23 date of the surrender. Respondent shall meet all requirements applicable to the license sought  
24 as of the date the application for that license is submitted to the Board.

25           13.   **Notification of Employment/Mailing Address Change.** Respondent  
26 shall notify the Board in writing within 10 days of any change of employment. Said  
27 notification shall include the reasons for leaving and/or the address of the new employer,

28   ///

1 supervisor or owner and work schedule if known. Respondent shall notify the Board in  
2 writing within 10 days of a change in name, mailing address or phone number.

3 14. **Tolling of Probation.** Should Respondent, regardless of residency, for  
4 any reason cease practicing pharmacy for a minimum of forty hours per calendar month in  
5 California, Respondent must notify the Board in writing within 10 days of cessation of the  
6 practice of pharmacy or the resumption of the practice of pharmacy. Such periods of time  
7 shall not apply to the reduction of the probation period. It is a violation of probation for  
8 Respondent's probation to remain tolled pursuant to the provisions of this condition for a  
9 period exceeding three years.

10 "Cessation of practice" means any period of time exceeding 30 days in which  
11 Respondent is not engaged in the practice of pharmacy as defined in Section  
12 4052 of the Business and Professions Code.

13 15. **Supervised Practice.** As determined by the PRP, Respondent shall  
14 practice only under the supervision of a pharmacist not on probation with the Board.  
15 Respondent shall not practice until the supervisor is approved by the Board. The supervision  
16 shall be, as required by the Board and/or the PRP, either:

17 Continuous - 75% to 100% of a work week

18 Substantial - At least 50% of a work week

19 Partial - At least 25% of a work week

20 Daily Review - Supervisor's review of probationer's daily activities within 24 hours

21 Within 30 days of the effective date of this decision, Respondent shall have his  
22 supervisor submit notification to the board in writing stating the supervisor has read the  
23 decision in Case No. 2943 and is familiar with the level of supervision as determined by the  
24 Board. If Respondent changes employment, respondent shall have his new supervisor, within  
25 15 days after employment commences, submit notification to the Board in writing stating the  
26 direct supervisor and pharmacist-in-charge have read the decision in Case No. 2943 and is  
27 familiar with the level of supervision as determined by the Board.

28 ///

1           Within 10, days of leaving employment, respondent shall notify the board in  
2 writing.

3           16.   **Tolling of Suspension.** If Respondent leaves California to reside or  
4 practice outside this state, for any period exceeding 10 days (including vacation), Respondent  
5 must notify the Board in writing of the dates of departure and return. Periods of residency or  
6 practice outside the state - or any absence exceeding a period of 10 days shall not apply to the  
7 reduction of the suspension period.

8           Respondent shall not practice pharmacy upon returning to this state until  
9 notified by the Board that the period of suspension has been completed.

10          17.   **Violation of Probation.** If Respondent violates probation in any  
11 respect, the Board, after giving Respondent notice and an opportunity to be heard, may revoke  
12 probation and carry out the disciplinary order which was stayed. If a petition to revoke  
13 probation or an accusation is filed against Respondent during probation, the Board shall have  
14 continuing jurisdiction and the period of probation shall be extended, until the petition to  
15 revoke probation or accusation is heard and decided.

16          If Respondent has not complied with any term or condition of probation, the  
17 Board shall have continuing jurisdiction over Respondent, and probation shall automatically  
18 be extended until all terms and conditions have been satisfied or the Board has taken other  
19 action as deemed appropriate to treat the failure to comply as a violation of probation, to  
20 terminate probation, and to impose the penalty which was stayed.

21          18.   **Completion of Probation.** Upon successful completion of probation,  
22 Respondent's license will be fully restored.

23          19.   **Rehabilitation Program - Pharmacists Recovery Program (PRP).**  
24 Within 30 days of the effective date of this decision, Respondent shall contact the Pharmacists  
25 Recovery Program for evaluation and shall successfully participate in and complete the  
26 treatment contract and any subsequent addendums as recommended and provided by the PRP  
27 and as approved by the Board. The costs for PRP participation shall be borne by the  
28 Respondent.

1 If Respondent is currently enrolled in the PRP, said participation is now  
2 mandatory and is no longer considered a self-referral under Business and Professions Code  
3 section 4363, as of the effective date of this decision. Respondent shall successfully  
4 participate in and complete his current contract and any subsequent addendums with the PRP.  
5 Probation shall be automatically extended until Respondent successfully completes his  
6 treatment contract. Any person terminated from the program shall be automatically suspended  
7 upon notice by the Board. Respondent may not resume the practice of pharmacy until notified  
8 by the Board in writing. The Board shall retain jurisdiction to institute action to terminate  
9 probation for any violation of this term.

10 20. **Random Drug Screening.** Respondent, at his own expense, shall  
11 participate in random testing, including but not limited to biological fluid testing (urine,  
12 blood), breathalyzer, hair follicle testing, or a drug screening program approved by the Board.  
13 The length of time shall be for the entire probation period and the frequency of testing will be  
14 determined by the Board. At all times Respondent shall fully cooperate with the Board, and  
15 shall, when directed, submit to such tests and samples for the detection of alcohol, narcotics,  
16 hypnotics, dangerous drugs or other controlled substances. Failure to submit to testing as  
17 directed shall constitute a violation of probation. Any confirmed positive drug test shall result  
18 in the immediate suspension of practice by Respondent. Respondent may not resume the  
19 practice of pharmacy until notified by the Board in writing.

20 21. **Abstain from Drugs and Alcohol Use.** As determined by the PRP,  
21 Respondent shall completely abstain from the possession or use of alcohol, controlled  
22 substances, dangerous drugs and their associated paraphernalia except when the drugs are  
23 lawfully prescribed by a licensed practitioner as part of a documented medical treatment.  
24 Upon request of the Board, Respondent shall provide documentation from the licensed  
25 practitioner that the prescription was legitimately issued and is a necessary part of the  
26 treatment of the Respondent.







19 **PARTIES**

20 1. Patricia F. Harris ("Complainant") brings this Accusation solely in her  
21 official capacity as the Executive Officer of the Board of Pharmacy ("Board"), Department of  
22 Consumer Affairs.

23 2. On or about November 19, 1970, the Board issued Pharmacist's License  
24 Number RPH 26997 to Charles Arthur Sawyer ("Respondent"). Respondent's pharmacist's  
25 license was in full force and effect at all times relevant to the charges brought herein and will  
26 expire on September 30, 2006, unless renewed.

(j) The violation of any of the statutes of this state or of the United States regulating controlled substances and dangerous drugs.

6. Bus. & Prof. Code section 4060 states, in pertinent part, that no person shall possess any controlled substance, except that furnished to a person upon the prescription of a physician, dentist, podiatrist, optometrist, or veterinarian.

7. Health and Saf. Code section 11350(a) states, the following:

**§ 11350 Possession of designated controlled substances; punishment and fine**

(a) Except as otherwise provided in this division, every person who possesses (1) any controlled substance specified in subdivision (b) or (c), or paragraph (1) of subdivision (f) of Section 11054, specified in paragraph (14), (15), or (20) of subdivision (d) of Section 11054, or specified in subdivision (b) or (c) of Section 11055, or specified in subdivision (h) of Section 11056, or (2) any controlled substance classified in Schedule III, IV, or V which is a narcotic drug, unless upon the written prescription of a physician, dentist, podiatrist, or veterinarian licensed to practice in this state, shall be punished by imprisonment in the state prison.

8. Bus. & Prof. Code section 125.3 states, in pertinent part, that the Board may request the administrative law judge to direct a licentiate found to have committed a violation or violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case.

**CONTROLLED SUBSTANCES AT ISSUE**

9. "Phentermine" is a Schedule IV controlled substance as designated by Health & Saf. Code section 11057, subdivision (f)(4).

10. "Fastin" and "Adipex", are brand names for Phentermine, a Schedule IV controlled substance as designated by Health and Safety Code ("Health & Saf. Code") section 11057, subdivision (f)(4).

11. "Bontril", is a brand name for Phendimetrazine, a Schedule III controlled substance as designated by Health and Safety Code ("Health & Saf. Code") section 11056,

1 subdivision (b)(6).

2 **STATUTORY VIOLATIONS**

3 **FIRST CAUSE FOR DISCIPLINE**

4 **(Acts Involving Moral Turpitude, Dishonesty, Fraud, Deceit, or Corruption)**

5 12. Respondent is subject to disciplinary action pursuant to Bus. & Prof. Code  
6 section 4301, subdivision (f), for unprofessional conduct. The unprofessional conduct is based  
7 upon Respondent committing acts involving moral turpitude, dishonesty, fraud, deceit, or  
8 corruption, from August 26, 2004 through March 25, 2005, by dishonestly and fraudulently  
9 appropriating at least 305 tablets containing Phentermine, from his employer, Longs Pharmacy,  
10 located in Madera, California.

11 **SECOND CAUSE FOR DISCIPLINE**

12 **(Violations of State Laws Regulating Controlled Substances)**

13 13. Respondent is subject to disciplinary action pursuant to Bus. & Prof. Code  
14 section 4301, subdivision (j), on the grounds of unprofessional conduct in that he violated a state  
15 law regulating controlled substances, namely Bus. & Prof. Code section 4060 and Health and  
16 Saf. Code section 11350(a). On multiple dates between August 26, 2004 and March 25, 2005,  
17 Respondent dishonestly or fraudulently appropriated, by direct stock theft, at least 305 tablets  
18 containing Phentermine, while on duty as a licensed pharmacist at Longs Pharmacies of Madera,  
19 California.

20 **PRAYER**

21 WHEREFORE, Complainant requests that a hearing be held on the matters herein  
22 alleged, and that following the hearing, the Board of Pharmacy issue a decision:
