3. On or about February 11, 2011, the Board of Pharmacy issued Pharmacy Technician 1 Registration No. TCH 108623 to Stacey Ann Watson (Respondent). The Pharmacy Technician 2 Registration expired on September 30, 2012, and has not been renewed. 3 JURISDICTION 4 4. Accusation No. 4433 was filed before the Board of Pharmacy (Board), Department of 5 6 Consumer Affairs, and is currently pending against Respondent. The Accusation and all other 7 statutorily required documents were properly served on Respondent on July 12, 2013. 8 Respondent timely filed her Notice of Defense contesting the Accusation. A copy of Accusation 9 No. 4433 is attached as Exhibit A and incorporated by reference. ADVISEMENT AND WAIVERS 10 5. Respondent has carefully read, and understands the charges and allegations in 11 Accusation No. 4433. Respondent also has carefully read, and understands the effects of this 12 Stipulated Surrender of License and Order. 13 6. Respondent is fully aware of her legal rights in this matter, including the right to a 14 hearing on the charges and allegations in the Accusation; the right to be represented by counsel, at 15 her own expense; the right to confront and cross-examine the witnesses against her; the right to 16 present evidence and to testify on her own behalf; the right to the issuance of subpoenas to 17 compel the attendance of witnesses and the production of documents; the right to reconsideration 18 and court review of an adverse decision; and all other rights accorded by the California 19 Administrative Procedure Act and other applicable laws. 20 Respondent voluntarily, knowingly, and intelligently waives and gives up each and 7. 21 every right set forth above. 22 CULPABILITY 23 Respondent admits the truth of each and every charge and allegation in Accusation 8. 24 No. 4433, agrees that cause exists for discipline and hereby surrenders her Pharmacy Technician 25 Registration No. TCH 108623 for the Board's formal acceptance. 26 27 28 2

9. Respondent understands that by signing this stipulation she enables the Board to issue an order accepting the surrender of her Pharmacy Technician Registration without further process.

## RESERVATION

The admissions made by Respondent herein are only for the purposes of this 10. 5 proceeding, or any other proceedings in which the Board of Pharmacy or other professional 7 licensing agency is involved, and shall not be admissible in any other criminal or civil 8 proceeding.

## CONTINGENCY

10 11. This stipulation shall be subject to approval by the Board of Pharmacy. Respondent understands and agrees that counsel for Complainant and the staff of the Board of Pharmacy may 11 12 communicate directly with the Board regarding this stipulation and surrender, without notice to or participation by Respondent. By signing the stipulation, Respondent understands and agrees that 13 she may not withdraw her agreement or seek to rescind the stipulation prior to the time the Board 14 considers and acts upon it. If the Board fails to adopt this stipulation as its Decision and Order, 15 the Stipulated Surrender and Disciplinary Order shall be of no force or effect, except for this 16 paragraph, it shall be inadmissible in any legal action between the parties, and the Board shall not 17 be disqualified from further action by having considered this matter. 18

The parties understand and agree that Portable Document Format (PDF) and facsimile 19 12. copies of this Stipulated Surrender of License and Order, including Portable Document Format 20 21 (PDF) and facsimile signatures thereto, shall have the same force and effect as the originals.

This Stipulated Surrender of License and Order is intended by the parties to be an 13. 22 integrated writing representing the complete, final, and exclusive embodiment of their agreement. 23 It supersedes any and all prior or contemporaneous agreements, understandings, discussions, 24 negotiations, and commitments (written or oral). This Stipulated Surrender of License and Order 25 may not be altered, amended, modified, supplemented, or otherwise changed except by a writing 26 executed by an authorized representative of each of the parties. 27

In consideration of the foregoing admissions and stipulations, the parties agree that 1 the Board may, without further notice or formal proceeding, issue and enter the following Order: 2 3 ORDER IT IS HEREBY ORDERED that Pharmacy Technician Registration No. TCH 108623, 4 issued to Respondent Stacey Ann Watson, is surrendered and accepted by the Board of Pharmacy. 5 The surrender of Respondent's Pharmacy Technician Registration and the acceptance 1. 6 7 of the surrendered license by the Board shall constitute the imposition of discipline against Respondent. This stipulation constitutes a record of the discipline and shall become a part of 8 9 Respondent's license history with the Board of Pharmacy. 2. Respondent shall lose all rights and privileges as a pharmacy technician in California 10 as of the effective date of the Board's Decision and Order. 11 3. Respondent shall cause to be delivered to the Board her pocket license and, if one was 12 issued, her wall certificate on or before the effective date of the Decision and Order. 13 4. Respondent understands and agrees that if she ever applies for licensure or petitions 14 15 for reinstatement in the State of California, the Board shall treat it as a new application for licensure. Respondent must comply with all the laws, regulations and procedures for licensure in 16 17 effect at the time the application or petition is filed, and all of the charges and allegations 18 contained in Accusation No. 4433 shall be deemed to be true, correct and admitted by Respondent when the Board determines whether to grant or deny the application or petition. 19 Respondent may not apply or reapply for, or petition for reinstatement of, any license, 20 permit, or registration from the Board for three (3) years from the effective date of this Decision 21 and Order. 22 23 5. Respondent shall pay the agency its costs of investigation and enforcement in the 24 amount of \$16, 560.00 prior to issuance of a new or reinstated license. 25 6. If Respondent should ever apply or reapply for a new license or certification, or 26 petition for reinstatement of a license, by any other health care licensing agency in the State of 27 California, all of the charges and allegations contained in Accusation, No. 4433 shall be deemed 28 4

4	Business and Professions Code unless otherwise indicated.	
5	4. Section 4011 of the Code provides that the Board shall administer and enforce both	
6	the Pharmacy Law [Bus. & Prof. Code, § 4000 et seq.] and the Uniform Controlled Substances	
7	Act [Health & Safety Code, § 11000 et seq.].	
8	5. Section 4300 of the Code states:	
9	"(a) Every license issued may be suspended or revoked.	
10	"(b) The board shall discipline the holder of any license issued by the board, whose default	
11	has been entered or whose case has been heard by the board and found guilty, by any of the

#### COST RECOVERY

13. Section 125.3 of the Code states, in relevant part, that the Board may request the administrative law judge to direct a licentiate found to have committed a violation or violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case.

### FACTUAL BACKGROUND

9 14. Respondent worked as a pharmacy technician at CVS Pharmacy # 9348 (CVS) in San
10 Ramon, California from June of 2011, until October of 2011. From approximately the middle of
11 August of 2011, to October 18, 2011, Respondent stole drugs from CVS while she was working
12 as a pharmacy technician. Respondent took handful of pills and put thern in her pocket and then
13 left the store with them. She would not take actual bottles of the drugs. The drugs she took
14 included Hydrocodone/Acetaminophen and Hydrocodone/Ibuprofen.

15 CVS had suspected Respondent of possibly taking drugs when drugs were missing
from the pharmacy. On or about October 21, 2011, Shannon Prior, the CVS Loss Prevention
Manager, interviewed Respondent about stealing pills from the pharmacy. At that time,
Respondent admitted to taking pills from the pharmacy and submitted a written statement
explaining the theft of the drugs. In this statement, she indicated that she stole the drugs to give
to three people who were suffering from pain—her grandmother, a cousin, and a friend.
Respondent estimated that she took approximately 925 pills.

### FIRST CAUSE FOR DISCIPLINE (Furnishing Dangerous Drugs without a Prescription) (Bus. & Prof Code 4059, subd. (a))

16. Respondent has subjected her Pharmacy Technician License to disciplinary action
under Code section 4059, subdivision (a), in that she furnished controlled substances and
dangerous drugs to three people without a prescription. The circumstances are explained more
fully in paragraphs 14 and 15, above.

1 2	SECOND CAUSE FOR DISCIPLINE (Unprofessional Conduct—Act of Dishonesty, Fraud, or Deceit) (Bus & Prof. Code 4301, subd. (f))
3	17. Respondent has subjected her Pharmacy Technician License to disciplinary action
4	under Code section 4301, subdivision (f), in that she stole prescription drugs from CVS, her
5	employer. The circumstances are explained more fully in paragraphs 14 and 15, above.
6 7	THIRD CAUSE FOR DISCIPLINE (Possession of Controlled Substance without a Prescription) (Bus. & Prof. Code 4060)
8	18. Respondent has subjected her Pharmacy Technician License to disciplinary action
9	under Code section 4060, in that she possessed controlled substances without a prescription. The
10	circumstances are explained more fully in paragraphs 14 and 15, above.
11 12	FOURTH CAUSE FOR DISCIPLINE (Unprofessional Conduct-Subversion of Investigation) (Bus. & Prof. Code 4301, subd. (q))
12	19. Respondent has subjected her Pharmacy Technician License to disciplinary action
14	under Code section 4301, subdivision (q), in that she subverted or attempted to subvert an
15	investigation by the Board of Pharmacy. Specifically, Respondent failed to respond to
15	correspondence from the Board of Pharmacy regarding her theft of controlled substances from
17	CVS. Correspondence was sent to Respondent on November 28, 2011, February 22, 2012, and
17	May 24, 2012 requesting a meeting. Respondent did not respond to these letters.
10 19	PRAYER
20	WHEREFORE, Complainant requests that a hearing be held on the matters alleged in this
20	Accusation, and that following the hearing, the Board of Pharmacy issue a decision:
21	1. Revoking or suspending Pharmacy Technician Registration Number TCH 108623,
23	issued to Stacey Ann Watson;
24	2. Ordering Stacey Ann Watson to pay the Board of Pharmacy the reasonable costs of
25	the investigation and enforcement of this case, pursuant to Business and Professions Code section
26	125.3;
