**STIPULATED SETTLEMENT AND  
DISCIPLINARY ORDER AS TO GAVIN  
LEE**

23 IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-  
24 entitled proceedings that the following matters are true:

25 **PARTIES**

26 1. Virginia Herold (Complainant) is the Executive Officer of the Board of Pharmacy.  
27 She brought this action solely in her official capacity and is represented in this matter by Kamala  
28

1 D. Harris, Attorney General of the State of California, by Gillian E. Friedman, Deputy Attorney  
2 General.

3 2. Respondents Ralphs Pharmacy 70300720 and Gavin Lee (Respondent Lee) are  
4 represented in this proceeding by attorney Susan Brichler Trujillo, whose address is: Quarles &  
5 Brady LLP, One Renaissance Square, Two North Central Avenue, Phoenix, AZ 85004-2391.

6 3. On or about April 29, 1999, the Board of Pharmacy issued Pharmacy Permit Number  
7 PHY 44207 to Ralphs Pharmacy 70300720 with Gavin Lee as Pharmacist in Charge. Respondent  
8 Lee was the Pharmacist-in-Charge of Ralphs Pharmacy 70300720 commencing on or about  
9 January 11, 2010 and at all times relevant to the charges brought herein. The Pharmacy Permit  
10 was in full force and effect at all times relevant to the charges brought herein and will expire on  
11 January 1, 2015, unless renewed.

12 4. On or about December 3, 2004, the Board of Pharmacy issued Registered Pharmacist  
13 License No. 56644 to Respondent Lee. The Pharmacist License was in full force and effect at all  
14 times relevant to the charges brought in Accusation No. 4785 and will expire on January 1, 2016,  
15 unless renewed.

16 **JURISDICTION**

17 5. Accusation No. 4785 was filed before the Board of Pharmacy (Board), Department of  
18 Consumer Affairs, and is currently pending against Respondent. The Accusation and all other  
19 statutorily required documents were properly served on Respondent Lee on July 11, 2014.  
20 Respondent Lee timely filed his Notice of Defense contesting the Accusation.

21 6. A copy of Accusation No. 4785 is attached as exhibit A and incorporated herein by  
22 reference.

23 **ADVISEMENT AND WAIVERS**

24 7. Respondent Lee has carefully read, fully discussed with counsel, and understands the  
25 charges and allegations in Accusation No. 4785. Respondent Lee has also carefully read, fully  
26 discussed with counsel, and understands the effects of this Stipulated Settlement and Disciplinary  
27 Order.

28

1 8. Respondent Lee is fully aware of his legal rights in this matter, including the right to  
2 a hearing on the charges and allegations in the Accusation; the right to be represented by counsel  
3 at his own expense; the right to confront and cross-examine the witnesses against him; the right to  
4 present evidence and to testify on his own behalf; the right to the issuance of subpoenas to compel  
5 the attendance of witnesses and the production of documents; the right to reconsideration and  
6 court review of an adverse decision; and all other rights accorded by the California  
7 Administrative Procedure Act and other applicable laws.

8 9. Respondent Lee voluntarily, knowingly, and intelligently waives and gives up each  
9 and every right set forth above.

10 **CULPABILITY**

11 10. Respondent Lee understands and agrees that the charges and allegations in  
12 Accusation No. 4785, if proven at a hearing, constitute cause for imposing discipline upon his  
13 Original Pharmacy License.

14 11. For the purpose of resolving the Accusation without the expense and uncertainty of  
15 further proceedings, Respondent Lee agrees that, at a hearing, Complainant could establish a  
16 factual basis for the charges in the Accusation, and that Respondent Lee hereby gives up his right  
17 to contest those charges.

18 12. Respondent Lee agrees that his Registered Pharmacist License No. 56644 is subject  
19 to discipline and he agrees to be bound by the Board's probationary terms as set forth in the  
20 Disciplinary Order below.

21 **RESERVATION**

22 13. The admissions made by Respondent herein are only for the purposes of this  
23 proceeding, or any other proceedings in which the Board of Pharmacy or other professional  
24 licensing agency is involved, and shall not be admissible in any other criminal or civil  
25 proceeding.

26 **CONTINGENCY**

27 14. This stipulation shall be subject to approval by the Board of Pharmacy. Respondent  
28 Lee understands and agrees that counsel for Complainant and the staff of the Board of Pharmacy

1 may communicate directly with the Board regarding this stipulation and settlement, without  
2 notice to or participation by Respondent Lee or his counsel. By signing the stipulation,  
3 Respondent Lee understands and agrees that he may not withdraw his agreement or seek to  
4 rescind the stipulation prior to the time the Board considers and acts upon it. If the Board fails to  
5 adopt this stipulation as its Decision and Order, the Stipulated Settlement and Disciplinary Order  
6 shall be of no force or effect, except for this paragraph, it shall be inadmissible in any legal action  
7 between the parties, and the Board shall not be disqualified from further action by having  
8 considered this matter.

9 15. The parties understand and agree that Portable Document Format (PDF) and facsimile  
10 copies of this Stipulated Settlement and Disciplinary Order, including Portable Document Format  
11 (PDF) and facsimile signatures thereto, shall have the same force and effect as the originals.

12 16. This Stipulated Settlement and Disciplinary Order is intended by the parties to be an  
13 integrated writing representing the complete, final, and exclusive embodiment of their agreement.  
14 It supersedes any and all prior or contemporaneous agreements, understandings, discussions,  
15 negotiations, and commitments (written or oral). This Stipulated Settlement and Disciplinary  
16 Order may not be altered, amended, modified, supplemented, or otherwise changed except by a  
17 writing executed by an authorized representative of each of the parties.

18 17. In consideration of the foregoing admissions and stipulations, the parties agree that  
19 the Board may, without further notice or formal proceeding, issue and enter the following  
20 Disciplinary Order:

21 **DISCIPLINARY ORDER**

22 IT IS HEREBY ORDERED that Registered Pharmacist License No. 56644 issued to  
23 Respondent Gavin Lee is revoked. However, the revocation is stayed and Respondent Lee is  
24 placed on probation for three (3) years on the following terms and conditions.

25 1. **Obey All Laws**

26 Respondent Lee shall obey all state and federal laws and regulations.

27 Respondent Lee shall report any of the following occurrences to the board, in writing,  
28 within seventy-two (72) hours of such occurrence:

- 1 • an arrest or issuance of a criminal complaint for violation of any provision of the
- 2 Pharmacy Law, state and federal food and drug laws, or state and federal controlled
- 3 substances laws
- 4 • a plea of guilty or nolo contendere in any state or federal criminal proceeding to any
- 5 criminal complaint, information or indictment
- 6 • a conviction of any crime
- 7 • discipline, citation, or other administrative action filed by any state or federal agency
- 8 which involves Respondent's Registered Pharmacist License or which is related to
- 9 the practice of pharmacy or the manufacturing, obtaining, handling, distributing,
- 10 billing, or charging for any drug, device or controlled substance.

11 Failure to timely report such occurrence shall be considered a violation of probation.

12 **2. Report to the Board**

13 Respondent Lee shall report to the board quarterly, on a schedule as directed by the board  
14 or its designee. The report shall be made either in person or in writing, as directed. Among other  
15 requirements, Respondent Lee shall state in each report under penalty of perjury whether there  
16 has been compliance with all the terms and conditions of probation. Failure to submit timely  
17 reports in a form as directed shall be considered a violation of probation. Any period(s) of  
18 delinquency in submission of reports as directed may be added to the total period of probation.  
19 Moreover, if the final probation report is not made as directed, probation shall be automatically  
20 extended until such time as the final report is made and accepted by the board.

21 **3. Interview with the Board**

22 Upon receipt of reasonable prior notice, Respondent Lee shall appear in person for  
23 interviews with the board or its designee, at such intervals and locations as are determined by the  
24 board or its designee. Failure to appear for any scheduled interview without prior notification to  
25 board staff, or failure to appear for two (2) or more scheduled interviews with the board or its  
26 designee during the period of probation, shall be considered a violation of probation.

27 ///

1           **4. Cooperate with Board Staff**

2           Respondent Lee shall cooperate with the board's inspection program and with the board's  
3 monitoring and investigation of respondent's compliance with the terms and conditions of his  
4 probation. Failure to cooperate shall be considered a violation of probation.

5           **5. Continuing Education**

6           Respondent Lee shall provide evidence of efforts to maintain skill and knowledge as a  
7 pharmacist as directed by the board or its designee.

8           **6. Notice to Employers**

9           During the period of probation, Respondent Lee shall notify all present and prospective  
10 employers of the decision in case number 4785 and the terms, conditions and restrictions imposed  
11 on Respondent Lee by the decision, as follows:

12           Within thirty (30) days of the effective date of this decision, and within fifteen (15) days of  
13 Respondent Lee undertaking any new employment, Respondent Lee shall cause his direct  
14 supervisor, pharmacist-in-charge (including each new pharmacist-in-charge employed during  
15 respondent's tenure of employment) and owner to report to the board in writing acknowledging  
16 that the listed individual(s) has/have read the decision in case number 4785, and terms and  
17 conditions imposed thereby. It shall be respondent's responsibility to ensure that his employer(s)  
18 and/or supervisor(s) submit timely acknowledgment(s) to the board.

19           If Respondent Lee works for or is employed by or through a pharmacy employment service,  
20 Respondent Lee must notify his direct supervisor, pharmacist-in-charge, and owner at every  
21 entity licensed by the board of the terms and conditions of the decision in case number 4785 in  
22 advance of the Respondent Lee commencing work at each licensed entity. A record of this  
23 notification must be provided to the board upon request.

24           Furthermore, within thirty (30) days of the effective date of this decision, and within fifteen  
25 (15) days of Respondent Lee undertaking any new employment by or through a pharmacy  
26 employment service, Respondent Lee shall cause his direct supervisor with the pharmacy  
27 employment service to report to the board in writing acknowledging that he has read the decision  
28 in case number 4785 and the terms and conditions imposed thereby. It shall be respondent's

1 responsibility to ensure that his employer(s) and/or supervisor(s) submit timely  
2 acknowledgment(s) to the board.

3 Failure to timely notify present or prospective employer(s) or to cause that/those  
4 employer(s) to submit timely acknowledgments to the board shall be considered a violation of  
5 probation.

6 "Employment" within the meaning of this provision shall include any full-time,  
7 part-time, temporary, relief or pharmacy management service as a pharmacist or any  
8 position for which a pharmacist license is a requirement or criterion for employment,  
9 whether the Respondent Lee is an employee, independent contractor or volunteer.

10 **7. No Supervision of Interns, Serving as Pharmacist-in-Charge (PIC), Serving as**  
11 **Designated Representative-in-Charge, or Serving as a Consultant**

12 During the period of probation, Respondent Lee shall not supervise any intern pharmacist,  
13 be the pharmacist-in-charge or designated representative-in-charge of any entity licensed by the  
14 board nor serve as a consultant unless otherwise specified in this order. Assumption of any such  
15 unauthorized supervision responsibilities shall be considered a violation of probation.

16 **8. Reimbursement of Board Costs**

17 As a condition precedent to successful completion of probation, Respondent Lee shall pay  
18 to the board its costs of investigation and prosecution in the amount of \$2,000.00. Respondent  
19 Lee shall be permitted to pay these costs in a payment plan approved by the Board, with  
20 payments to be completed no later than three months prior to the end of the probation term.

21 There shall be no deviation from this schedule absent prior written approval by the board or  
22 its designee. Failure to pay costs by the deadline(s) as directed shall be considered a violation of  
23 probation.

24 The filing of bankruptcy by Respondent Lee shall not relieve Respondent Lee of his  
25 responsibility to reimburse the board its costs of investigation and prosecution.

26 **9. Probation Monitoring Costs**

27 Respondent Lee shall pay any costs associated with probation monitoring as determined by  
28 the board each and every year of probation. Such costs shall be payable to the board on a



1 schedule as directed by the board or its designee. Failure to pay such costs by the deadline(s) as  
2 directed shall be considered a violation of probation.

3 **10. Status of License**

4 Respondent Lee shall, at all times while on probation, maintain an active, current license  
5 with the board, including any period during which suspension or probation is tolled. Failure to  
6 maintain an active, current license shall be considered a violation of probation.

7 If respondent's license expires or is cancelled by operation of law or otherwise at any time  
8 during the period of probation, including any extensions thereof due to tolling or otherwise, upon  
9 renewal or reapplication respondent's license shall be subject to all terms and conditions of this  
10 probation not previously satisfied.

11 **11. License Surrender While on Probation/Suspension**

12 Following the effective date of this decision, should Respondent Lee cease practice due to  
13 retirement or health, or be otherwise unable to satisfy the terms and conditions of probation,  
14 Respondent Lee may tender his license to the board for surrender. The board or its designee shall  
15 have the discretion whether to grant the request for surrender or take any other action it deems  
16 appropriate and reasonable. Upon formal acceptance of the surrender of the license, Respondent  
17 Lee will no longer be subject to the terms and conditions of probation. This surrender constitutes  
18 a record of discipline and shall become a part of the respondent's license history with the board.

19 Upon acceptance of the surrender, Respondent Lee shall relinquish his pocket and wall  
20 license to the board within ten (10) days of notification by the board that the surrender is  
21 accepted. Respondent Lee may not reapply for any license from the board for three (3) years from  
22 the effective date of the surrender. Respondent Lee shall meet all requirements applicable to the  
23 license sought as of the date the application for that license is submitted to the board, including  
24 any outstanding costs.

25 **12. Notification of a Change in Name, Residence Address, Mailing Address or**  
26 **Employment**

27 Respondent Lee shall notify the board in writing within ten (10) days of any change of  
28 employment. Said notification shall include the reasons for leaving, the address of the new

1 employer, the name of the supervisor and owner, and the work schedule if known. Respondent  
2 Lee shall further notify the board in writing within ten (10) days of a change in name, residence  
3 address, mailing address, or phone number.

4 Failure to timely notify the board of any change in employer(s), name(s), address(es), or  
5 phone number(s) shall be considered a violation of probation.

6 **13. Tolling of Probation**

7 Except during periods of suspension, Respondent Lee shall, at all times while on probation,  
8 be employed as a pharmacist in California for a minimum of 40 hours per calendar month. Any  
9 month during which this minimum is not met shall toll the period of probation, i.e., the period of  
10 probation shall be extended by one month for each month during which this minimum is not met.  
11 During any such period of tolling of probation, Respondent Lee must nonetheless comply with all  
12 terms and conditions of probation.

13 Should Respondent Lee, regardless of residency, for any reason (including vacation) cease  
14 practicing as a pharmacist for a minimum of 40 hours per calendar month in California,  
15 Respondent Lee must notify the board in writing within ten (10) days of the cessation of practice,  
16 and must further notify the board in writing within ten (10) days of the resumption of practice.  
17 Any failure to provide such notification(s) shall be considered a violation of probation.

18 It is a violation of probation for respondent's probation to remain tolled pursuant to the  
19 provisions of this condition for a total period, counting consecutive and non-consecutive months,  
20 exceeding thirty-six (36) months.

21 "Cessation of practice" means any calendar month during which Respondent  
22 Lee is not practicing as a pharmacist for at least 40 hours, as defined by Business and  
23 Professions Code section 4000 et seq . "Resumption of practice" means any calendar  
24 month during which Respondent Lee is practicing as a pharmacist for at least 40  
25 hours as a pharmacist as defined by Business and Professions Code section 4000 et  
26 seq.

27 ///

1           **14. Violation of Probation**

2           If Respondent Lee has not complied with any term or condition of probation, the board  
3 shall have continuing jurisdiction over respondent, and probation shall automatically be extended,  
4 until all terms and conditions have been satisfied or the board has taken other action as deemed  
5 appropriate to treat the failure to comply as a violation of probation, to terminate probation, and  
6 to impose the penalty that was stayed.

7           If Respondent Lee violates probation in any respect, the board, after giving Respondent Lee  
8 notice and an opportunity to be heard, may revoke probation and carry out the disciplinary order  
9 that was stayed. Notice and opportunity to be heard are not required for those provisions stating  
10 that a violation thereof may lead to automatic termination of the stay and/or revocation of the  
11 license. If a petition to revoke probation or an accusation is filed against Respondent Lee during  
12 probation, the board shall have continuing jurisdiction and the period of probation shall be  
13 automatically extended until the petition to revoke probation or accusation is heard and decided.

14           **15. Completion of Probation**

15           Upon written notice by the board or its designee indicating successful completion of  
16 probation, respondent's license will be fully restored.

17           **16. Community Services Program**

18           Within sixty (60) days of the effective date of this decision, Respondent Lee shall submit to  
19 the board or its designee, for prior approval, a community service program in which Respondent  
20 Lee shall provide free health-care related services on a regular basis to a community or charitable  
21 facility or agency for at least 48 hours per year for the first two years of probation. Within thirty  
22 (30) days of board approval thereof, Respondent Lee shall submit documentation to the board  
23 demonstrating commencement of the community service program. A record of this notification  
24 must be provided to the board upon request. Respondent Lee shall report on progress with the  
25 community service program in the quarterly reports. Failure to timely submit, commence, or  
26 comply with the program shall be considered a violation of probation.

27           **17. Remedial Education**

28           Within sixty (60) days of the effective date of this decision, Respondent Lee shall submit to

1 the board or its designee, for prior approval, an appropriate program of remedial education related  
2 to pain management, corresponding responsibility and controlled substance dispensing. The  
3 program of remedial education shall consist of at least 10 hours which shall be completed within  
4 two years at respondent's own expense. All remedial education shall be in addition to, and shall  
5 not be credited toward, continuing education (CE) courses used for license renewal purposes.

6 Failure to timely submit or complete the approved remedial education shall be considered a  
7 violation of probation. The period of probation will be automatically extended until such  
8 remedial education is successfully completed and written proof, in a form acceptable to the board,  
9 is provided to the board or its designee.

10 Following the completion of each course, the board or its designee may require the  
11 respondent, at his own expense, to take an approved examination to test the respondent's  
12 knowledge of the course. If the Respondent Lee does not achieve a passing score on the  
13 examination, this failure shall be considered a violation of probation. Any such examination  
14 failure shall require Respondent Lee to take another course approved by the board in the same  
15 subject area.

16 **18. Consultant for Owner or Pharmacist-In-Charge**

17 During the period of probation, Respondent Lee shall not supervise any intern pharmacist,  
18 or serve as a consultant to any entity licensed by the board. In the event that the Respondent Lee  
19 is currently the pharmacist-in-charge of a pharmacy, the pharmacy shall retain an independent  
20 consultant at its own expense who shall be responsible for reviewing pharmacy operations on a  
21 quarterly basis for compliance by Respondent Lee with state and federal laws and regulations  
22 governing the practice of pharmacy and for compliance by Respondent Lee with the obligations  
23 of a pharmacist-in-charge. The consultant shall be a pharmacist licensed by and not on probation  
24 with the board and whose name shall be submitted to the board or its designee, for prior approval.  
25 Within thirty (30) days of the effective date of this decision. Respondent Lee shall not be a  
26 pharmacist-in-charge at more than one pharmacy or at any pharmacy of which he is not the  
27 current PIC. The board may, in case of an employment change by Respondent Lee or for other  
28 reasons as deemed appropriate by the board or its designee, preclude the Respondent Lee from

1 acting as a pharmacist-in-charge. Failure to timely retain, seek approval of, or ensure timely  
2 reporting by the consultant shall be considered a violation of probation.

3 ACCEPTANCE

4 I have carefully read the above Stipulated Settlement and Disciplinary Order and have fully  
5 discussed it with my attorney, Susan Brichler Trujillo. I understand the stipulation and the effect  
6 it will have on my Registered Pharmacist License No. 56644. I enter into this Stipulated  
7 Settlement and Disciplinary Order voluntarily, knowingly, and intelligently, and agree to be  
8 bound by the Decision and Order of the Board of Pharmacy.



26 as the Executive Officer of the Board of Pharmacy, Department of Consumer Affairs.
- 27 2. On or about April 29, 1999, the Board of Pharmacy issued Pharmacy Permit Number  
28 PHY 44207 to Ralphs Pharmacy 70300720 with Gavin Lee as Pharmacist in Charge (Respondent



1 Ralphs). The Pharmacy Permit was in full force and effect at all times relevant to the charges  
2 brought herein and will expire on January 1, 2015, unless renewed.

3 3. On or about December 3, 2004, the Board of Pharmacy issued Registered Pharmacist  
4 License # 56644 to Gavin Lee (Respondent Lee). Respondent Lee was the Pharmacist-in-Charge  
5 of Ralphs pharmacy #720 from 01/11/2010 to current. The Pharmacist License was in full force  
6 and effect at all times relevant to the charges brought herein and will expire on January 1, 2016,  
7 unless renewed.

### 8 JURISDICTION

9 4. This Accusation is brought before the Board of Pharmacy (Board), Department of  
10 Consumer Affairs, under the authority of the following laws. All section references are to the  
11 Business and Professions Code unless otherwise indicated.

12 5. Section 4300 of the Code states:

13 "(a) Every license issued may be suspended or revoked.

14 . . . .

15 6. Section 4301 of the Code states:

16 "The board shall take action against any holder of a license who is guilty of unprofessional  
17 conduct or whose license has been procured by fraud or misrepresentation or issued by mistake.  
18 Unprofessional conduct shall include, but is not limited to, any of the following:

19 . . . .

20 "(d) The clearly excessive furnishing of controlled substances in violation of subdivision (a)  
21 of Section 11153 of the Health and Safety Code.

22 "(e) The clearly excessive furnishing of controlled substances in violation of subdivision (a)  
23 of Section 11153.5 of the Health and Safety Code. Factors to be considered in determining  
24 whether the furnishing of controlled substances is clearly excessive shall include, but not be  
25 limited to, the amount of controlled substances furnished, the previous ordering pattern of the  
26 customer (including size and frequency of orders), the type and size of the customer, and where  
27 and to whom the customer distributes its product.

28 . . . .

1           "(i) Except as otherwise authorized by law, knowingly selling, furnishing, giving away, or  
2 administering or offering to sell, furnish, give away, or administer any controlled substance to an  
3 addict.

4           "(j) The violation of any of the statutes of this state, or any other state, or of the United  
5 States regulating controlled substances and dangerous drugs.

6           ....

7           "(o) Violating or attempting to violate, directly or indirectly, or assisting in or abetting the  
8 violation of or conspiring to violate any provision or term of this chapter or of the applicable  
9 federal and state laws and regulations governing pharmacy, including regulations established by  
10 the board or by any other state or federal regulatory agency.

11          .....

12          7. Health and Safety Code section 11200 states in pertinent part:

13          ....

14          “(b) No prescription for a Schedule III or IV substance may be refilled more than five times  
15 and in an amount, for all refills of that prescription taken together, exceeding a 120-day supply.”

16          .....

17          8. Health and Safety Code section 11153 subdivision (a) states:

18          A prescription for a controlled substance shall only be issued for a legitimate medical  
19 purpose by an individual practitioner acting in the usual course of his or her professional practice.  
20 The responsibility for the proper prescribing and dispensing of controlled substances is upon the  
21 prescribing practitioner, but a corresponding responsibility rests with the pharmacist who fills the  
22 prescription. Except as authorized by this division, the following are not legal prescriptions: (1)  
23 an order purporting to be a prescription which is issued not in the usual course of professional  
24 treatment or in legitimate and authorized research; or (2) an order for an addict or habitual user of  
25 controlled substances, which is issued not in the course of professional treatment or as part of an  
26 authorized narcotic treatment program, for the purpose of providing the user with controlled  
27 substances, sufficient to keep him or her comfortable by maintaining customary use.

28          ///

1 **REGULATORY PROVISIONS**

2 9. California Code of Regulations, title 16, section 1761, subdivision (a), states:

3 "No pharmacist shall compound or dispense any prescription which contains any significant  
4 error, omission, irregularity, uncertainty, ambiguity or alteration. Upon receipt of any such  
5 prescription, the pharmacist shall contact the prescriber to obtain the information needed to  
6 validate the prescription."

7 10. Section 118, subdivision (b), of the Code provides that the suspension/expiration/  
8 surrender/cancellation of a license shall not deprive the Board/Registrar/Director of jurisdiction to  
9 proceed with a disciplinary action during the period within which the license may be renewed,  
10 restored, reissued or reinstated.

11 **COST RECOVERY PROVISION**

12 11. Section 125.3 of the Code states, in pertinent part, that the Board may request the  
13 administrative law judge to direct a licentiate found to have committed a violation or violations of  
14 the licensing act to pay a sum not to exceed the reasonable costs of the investigation and  
15 enforcement of the case.

16 **CONTROLLED SUBSTANCES**

17 12. **OxyContin** a trade name for Oxycodone, is a dangerous drug as defined in section  
18 4022 and a Schedule II controlled substance and narcotic as designated by section 11055  
19 subdivision (b)(1)(M), of the Health and Safety Code. Its indications for use are moderate to  
20 severe pain.

21 13. **OpanaER** is brand name for Oxymorphone is a dangerous drug as defined in section  
22 4022 and a Schedule II controlled substance and narcotic as designated by Health and Safety  
23 Code section 11055, subdivision (b)(1)(N) of the Health and Safety Code. Its indications for use  
24 are severe pain.

25 14. **Dilaudid** is brand name for Hydromorphone is a dangerous drug as defined in section  
26 4022 and a Schedule II controlled substance and narcotic as designated by Health and Safety  
27 Code section 11055, subdivision (b)(1)(J) of the Health and Safety Code. Its indications for use  
28 are severe pain.

1 **FACTUAL SUMMARY**

2 15. Between on or about June 22, 2010 and October 1, 2010, Respondent Ralphs  
3 pharmacy 70300720 located in Rancho Palos Verdes, California (Respondent Ralphs) dispensed  
4 approximately 18,141 tablets of OxyContin 80 mg to consumers who were identified to be  
5 "patients" of Roscoe Clinic, a facility located approximately 40 miles away at 8121 Van Nuys  
6 Blvd., Panorama City, CA 91402. Each of the prescriptions from Roscoe Clinic was written by  
7 either Dr. Gaston Herrera or Physicians Assistant David Niknia.

8 16. The clinic patients were transported as a group to Respondent Ralphs.

9 17. None of the patients lived in either Rancho Palos Verdes nor near Roscoe Clinic.

10 **FIRST CAUSE FOR DISCIPLINE**

11 **(Filling of Erroneous or Uncertain Prescriptions and**

12 **Failure to Assume Co-Responsibility in Legitimacy of a Prescription)**

13 (Respondents Ralphs and Lee)

14 18. Respondent Ralphs and Respondent Lee, while working as Pharmacist-in-Charge of  
15 Respondent Ralphs, are subject to disciplinary action under sections 4300 and 4301, subdivision  
16 (d),(i) and (o) of the Business and Professions Code, for unprofessional conduct, for violating  
17 Health and Safety Code section 11153, subdivision (a) and California Code of Regulations, title  
18 16, section 1761, subdivision (a), in that Respondents filled and dispensed prescriptions that were  
19 uncertain and ambiguous. Respondents failed to question whether the prescriptions served  
20 legitimate purposes and use professional judgment to refuse to fill or refill prescriptions presented  
21 by patients who presented as addicts or habitual users with erroneous/uncertain prescriptions.  
22 The circumstances are as follows:

23 19. From June 11, 2010 to June 8, 2011, Respondents Ralphs and Lee filled numerous  
24 prescriptions for pain medicine for patients of Roscoe Clinic without verifying a legitimate  
25 medical purpose for the use. The following prescriptions for pain killers to approximately 1,000  
26 Roscoe Clinic patients were written on the following dates and prescription numbers as follows  
27 and presented to Respondent Ralphs pharmacists as follows:


