17 **SUSPENSION OF LICENSE**
18 **(Bus. & Prof. Code, § 4311 subd. (a).)**

20 **YOUR PHARMACY TECHNICIAN LICENSE HAS BEEN SUSPENDED.**

21 **NOTICE IS HEREBY GIVEN THAT YOUR LICENSE TO WORK AS A PHARMACY**
22 **TECHNICIAN IN THE STATE OF CALIFORNIA HAS BEEN AUTOMATICALLY SUSPENDED,**
23 **PURSUANT TO CALIFORNIA BUSINESS AND PROFESSIONS CODE SECTION 4311,**
24 **SUBDIVISION (A), DUE TO YOUR INCARCERATION ON OR ABOUT JULY 9, 2015, FOR**
25 **YOUR CONVICTION IN VIOLATION OF VEHICLE CODE SECTION 23153(b) & 23560**
26 **(DRIVING WITH A 0.08% BLOOD ALCOHOL CONTENT CAUSING INJURY WITHIN 10**
27 **YEARS OF ANOTHER DUI OFFENSE), A FELONY, IN CASE NUMBER KA109412, IN**
28 **SUPERIOR COURT OF CALIFORNIA, COUNTY OF LOS ANGELES.**

The suspension will remain in effect for the duration of your incarceration. The information received by the Board indicates a period of incarceration of two years. Accordingly, in the absence of further information, your license will be suspended until at least July 9, 2017. If the period of incarceration is longer or shorter than two years, or has a different start or end date than stated in this Notice, it is your responsibility to provide that information to the Board along with any and all

1 supporting documentation. Where appropriate, certified copies of court documents may be required.
2 The suspension will remain in effect until a final decision on the accusation is rendered thereon.

3 **UNLESS OR UNTIL THIS SUSPENSION IS LIFTED YOU MAY**
4 **NOT WORK UNDER YOUR PHARMACY TECHNICIAN LICENSE.**

5 You have a right at this time to request a hearing under California Business and Professions
6 Code section 4311, subdivision (a) to contest the automatic suspension. The hearing on the automatic
7 suspension shall be limited to whether you are presently incarcerated pursuant to a felony conviction.


15 **ANY REQUEST FOR A HEARING MUST BE RECEIVED BY THE BOARD WITHIN**

18 Notice, a hearing will be held pursuant to the provisions of California Business and Professions Code
19 section 4311 and the California Administrative Procedure Act [Government Code section 11500 et seq.].

20 A copy of California Business and Professions Code section 4311 is enclosed.

21 You may, but need not, be represented by counsel (at your own expense) at any or all stages of
22 any proceeding brought against your license by the State Board of Pharmacy.
