

The Court, having noted the appearance of the Office of Attorney General on behalf of the California Board of Pharmacy, Department of Consumer Affairs, State of California, and having heard and considered the moving papers, and oral argument, finds that good cause exists to issue an order pursuant to Penal Code Section 23 and Business and Professions Code section 320, that imposes appropriate restrictions on the Defendant's Original Pharmacist License No. RPH 50690,

1 **IT IS HEREBY ORDERED THAT:**

- 2 1. Defendant JEANNIE JUNGUN KIM, shall be prohibited from engaging, either
- 3 directly or indirectly, in any activity for which a pharmacist license is required;
- 4 2. This condition shall remain in effect until further order of the Court; and
- 5 3. Notice of any modification of this order shall be mailed to the California Board of
- 6 Pharmacy, Department of Consumer Affairs, 1747 North Market Boulevard, Suite 150,
- 7 Sacramento, CA 95834, *and* to Gillian E. Friedman, Deputy Attorney General, State of
