24 The court having noted the appearance of Virginia K. Herold, Executive Officer of the  
25 Board of Pharmacy, Department of Consumer Affairs, State of California, and having read and  
26 considered the moving papers, oral argument, and having heard and considered any objections of  
27 Defendant Scott Matthew Grimes, finds that good cause exists to issue an order pursuant to Penal  
28

1 Code Section 23, that imposes appropriate restrictions on Defendant Scott Matthew Grimes'  
2 Pharmacy Technician license in the interest of public safety.

3 **IT IS HEREBY ORDERED THAT:**

- 4 1. SCOTT MATTHEW GRIMES shall be prohibited from engaging, either directly or  
5 indirectly, in any activity for which a Pharmacy Technician license is required; and  
6 2. This condition shall remain in effect until there is a final disposition of this criminal  
7 case or until further order by this court.
