GlaxoSmithKline is recalling **Wellbutrin XL® (bupropion hydrochloride extended-release tablets) 300 mg** packaged as **bottles of 30 tablets for lot number P08A011 from the retail and wholesale levels**. This lot is being recalled due to the possibility of embedded foreign material within the tablets.

Please examine your inventory immediately and return all units of **Wellbutrin XL® (bupropion hydrochloride extended-release tablets) 300 mg** from **lot number P08A011**, using the enclosed UPS label, to GlaxoSmithKline, c/o Stericycle, 2670 Executive Drive, Suite A, Indianapolis, IN 46241. Stop distributing and immediately quarantine lot number P08A011 only. Please carry out a physical count and record this data on the business reply card and the packing slip which are included with this letter. It is very important that you complete the requested information on the enclosed postage paid Business Reply Card and return it to us within five (5) business days, **even if you do not have lot P08A011 in stock**.
