

**From the 710 Freeway:** Take Imperial Highway East exit. Follow Imperial Highway approximately one mile to Old River School Road. Turn Left. Enter Rancho grounds and park in the Parking Structure.


**From the 605 Freeway:** Take the 105 Freeway West to Paramount Blvd., exit, turn right, go to Imperial Highway, turn left to Old River School Road, turn right. Enter Rancho grounds and park in the Parking Structure.

### From the 105 Freeway:

**Heading East -** Take Garfield Avenue exit, turn left, go to Imperial Highway, turn right, go to Old River School Road, turn left. Enter Rancho grounds and park in the Parking Structure.

**Heading West -** Take Paramount Blvd., exit, turn right, go to Imperial Highway, turn left, go to Old River School Road, turn right. Enter Rancho grounds and park in the Parking Structure.

DRIVING DIRECTIONS TO RANCHO LOS AMIGOS  
REHABILITATION CENTER

Attached is a map which shows directions to Rancho Los Amigos

**DO NOT TURN ON TO THE MAIN CAMPUS.**

Go to OLD RIVER SCHOOL ROAD – TURN – right onto the campus. Drive up to parking on the left, drive into parking structure. There is no attendant, no fee, park anywhere except where it states “reserved”.

Come out of the parking structure on the side and turn left the SSA Building in on your left, go into that building. As you walk into the building on the right there is a stair way. Go up to the second floor and turn right. Going to the middle of the building, there are the Ladies and Men’s bathrooms. Travel pass the bathrooms and on the left side is the conference room SSA 2207. (There is an elevator in the middle of the building, you will go through the cafeteria to get to the elevator.) Once you exit the elevator the conference room is the next room on the right.
