Subject: Agenda Item VI. Presentation on Research Underway on Senate Bill 159 (Chapter 532, Statutes of 2019) related to HIV Preexposure and Postexposure Prophylaxis

<u>Background</u>

Senate Bill 159 established authority for a pharmacist who completes a training program approved by the Board to independently initiate and furnish HIV PrEP and PEP. Generally, under the provisions of the law the medications may be furnished in specified doses and under specific circumstances, as recommended by the federal Centers for Disease Control and Prevention (CDC).

As required by the statute, the Board developed regulations specifying the criteria for the training program to be concluded approved by the Board as well the recordkeeping requirements for a pharmacist who completes the training program. The Board initially adopted emergency regulations, followed by the permanent regulation which became effective June 8, 2021.

Additionally, as allowed in the statute, on September 17, 2020, Board approved two additional medications that may be provided by a pharmacist pursuant to these provisions.

- PrEP Approve tenofovir alafenamide (TAF) (25 mg) with emtricitabine (FTC) (200 mg) as a drug combination that can be initiated and furnished for preexposure prophylaxis (PrEP) by a pharmacist pursuant to the provisions of BPC 4052.02.
- PEP Approve bictegravir 50mg/emtricitabine 200mg/tenofovir alafenamide 25mg as a drug combination that can be initiated and furnished for postexposure prophylaxis (PEP) by a pharmacist pursuant to the provisions of BPC 4052.03.

Pharmacists-Furnished HIV Prevention and Reproductive Health Services in California



Mixed Methods Study & AIMS

- Qualitative Study (N=30): Conduct semi-structured interviews (lasts approx. 60 min) with CA pharmacists on facilitators and barriers faced provding PrEP/PEP and hormonal contraception/medication abortion
- Quantitative Study (N=1,000): Survey CA pharmacists on their past experiences, knowledge, and preferred implementation models for sexual and reproductive health services provision.

 - Phase 1: Actively recruit practicing pharmacists from CA professional organizations (CPhA; CHSP)
