Section 4129.1(d) of the California Business and Professions Code prohibits the renewal of a nonresident outsourcing facility license until the board reviews specific items and an inspection occurs. To facilitate the timely renewal of your license, the board seeks the following information from you **within 30 days**:

**Submit the following documents:**

1. An electronic copy of the current policy and procedures for compounding (sterile and/or nonsterile). If there have been changes, please identify or list the changes to your policies or procedures.
2. A list of all sterile drugs and nonsterile drugs compounded by the nonresident outsourcing facility as reported to the FDA in the last 12 months.
3. Copies of all federal and state regulatory agency inspection reports, as well as accreditation reports, and certification reports of facilities or equipment of the outsourcing facility’s premises conducted in the prior 12 months.
