## Pharmacy Mobile Units Expanding Access to Care

In December 2023, San Diego County launched the first pharmacy mobile unit in the state after the passage of Senate Bill 872. The mobile unit provides services to individuals who face challenges accessing pharmacy services, such as those who lack transportation, or don't have access to a healthcare provider.

The mobile unit connects pharmacists with the most vulnerable Californians. This includes populations who are without a fixed address, those living in government owned or operated housing, and residents enrolled in Medi-Cal plans. The mobile unit is operated as an extension of the county pharmacy, and with the new amendment to the Business and Professions Code, pharmacists could provide access to life-saving drugs.

A mobile unit and a mobile pharmacy serve different purposes. A mobile pharmacy is used on a temporary basis when a pharmacy is destroyed or damaged and it is necessary to protect the health and safety of the public. A mobile pharmacy can also be deployed during a declared federal, state, or local emergency to continue patient care.

And, with patient care consistently evolving, we introduce you to the first mobile unit program that provides healthcare services to the most vulnerable Californians.

Keeping our youth safe is also always a top priority for the Board. We remind our licensees there is a standing order for epinephrine to be available in California schools. You can find more information inside the newsletter.

We understand the cost of medications can hinder consumer care, in this issue we remind people about SB 393, a bill that passed in 1999, the California law that enables Medicare beneficiaries to obtain their prescription drugs at a cost no higher than what the Medi-Cal would charge the pharmacy. You can find more information about this program [here](#). And there are new provisions for reimbursement for pharmacist services covered in AB 317 (Chapter 322, Statutes of 2023) that we are hopeful could expand services available by pharmacists to the public.

A reminder from the Medical Board of California (MBC), pharmacy licensees are required to provide pharmacy records requested by the MBC within three days of the request. More information is provided inside this newsletter.

As the Board continues to work to protect consumers, there are several important policy issues currently being considered by the Board including the regulation of central fill and nonresident pharmacies, potential changes to the pharmacist to pharmacy technician ratios, compounding regulations and many other topics.

Lastly, we will embark on how best to incorporate the standard of care model into the pharmacist practice. Please keep an eye out for upcoming committee and full board meetings to engage in this discussion. The Board will also soon embark on the Sunset review process. This is a great opportunity for all stakeholders and the public to engage in wide ranging topics involving the practice of pharmacy in how best to provide care to our patients. We strongly encourage you to monitor the Board's policy-making work through its strategic committees.

And we are excited to welcome three new board members, Jeff Hughes, Jason Newell, and Satinder Sandhu! And congratulations to Renee Barker on her reappointment to the Board. These members have taken an oath and we look forward to serving with them. I would also like to take this opportunity to thank all current and past Board members as well as current and past Board officers who served all their time and commitment in protecting California consumers. And finally, my deepest gratitude to those who have trusted me and my commitment to consumer care as I serve as the Board's President.

# Protected Services

## Reproductive or Gender Affirming Health Care Services

Pharmacy practice is continually evolving to include more sophisticated and comprehensive patient care activities. The California State Legislature declared that pharmacists are health care providers who have the authority to provide health care services. This means legally protected activities include the exercise of rights related to reproductive health care services or gender-affirming health care services.

[Senate Bill 345](#) (Skinner, Chapter 260, Statutes of 260) Health Care Services: Legally Protected Health Care Services Status,

prohibits a healing arts board from denying an application for the license or imposing discipline upon a license of a health care practitioner based on a civil judgement, criminal conviction, or disciplinary action in another state, if that action would have been lawful if provided in California.

A healing art board is any board, division, or examining committee in the Department of Consumer Affairs (DCA) that licenses or certifies health professionals. Pharmacy practice is a dynamic, patient-oriented health service that applies a

scientific body of knowledge to improve and promote patient health by means of appropriate drug use, drug-related therapy, and communication for clinical and consultative purposes.

This new measure prohibits the Board from disciplining a licensee solely for performing reproductive health care services that are within their scope. The Board would retain the ability to take action however if the services were provided in a negligent matter, incompetently, or with gross negligence.

The mobile unit is operated as an extension of the pharmacy licensed by the county, city and county, or special hospital authority; independent or chain retail pharmacies are not eligible to provide care using a mobile unit. If a county, city and county, or special hospital authority are interested in operating a mobile unit, the Board of Pharmacy must be notified as soon as possible and no later than five business days after commencing operation.

Pharmacy law does not specify where the unit is required to be parked, however, all dangerous drugs must be removed when the unit is not in active operation. Due to the mobile unit operating as an extension of a pharmacy, the same regulations apply. An inspector has the authority to inspect the unit. The unit must have a sink

with hot and cold running water, staffing must be compliant, and the Notice to Consumer poster must be posted in public view.

AB 663 went into effect January 1, 2024, and was updated to allow pharmacists to dispense buprenorphine to treat opioid addiction while traveling with mobile units. Buprenorphine is classified as a controlled substance and was previously not allowed, however, with the increase in fentanyl overdoses the bill was modified to serve those patients. However, the mobile unit cannot dispense methadone as it is classified as a Schedule II controlled substance. Entities interested in dispensing controlled substances from the mobile unit must ensure they meet all Drug Enforcement Administration (DEA) requirements.

# Medicare Prescriptions at Medi-Cal Cost

## Medicare Recipients to Obtain Prescription Drugs at Medi-Cal Price

In 1999, former Governor Gray Davis signed Senate Bill (SB) 393, which established an outpatient drug discount program for Medicare beneficiaries. It requires that pharmacies charge Medicare beneficiaries no more than the Medi-Cal reimbursement rate plus a small processing fee. Pharmacies that wish to participate in Medi-Cal must participate in this program. Business and Professions Code (BPC) section 4425 is the statute pertaining to SB 393.

### Key Points:

1. Patients **MUST HAVE a Medicare card** and show it to the pharmacy staff. **Please note: Patients DO NOT need to be Medi-Cal beneficiaries.**
2. **Only Medi-Cal provider pharmacies** are required by law to offer and accept the Medi-Cal price as payment for prescription medication for Medicare recipients. However, non-Medi-Cal pharmacies may also offer the Medi-Cal price if they choose.   - how billing works for Medi-Cal pharmacy providers and
  - how to find out what the Medi-Cal Reimbursement rate is for a medication
3. Patients may give their prescription to pharmacy staff, and ask for the Medi-Cal prescription price, and if that is the lowest price the pharmacy will accept for the drug. **Please note:** the Medi-Cal price may or may not be the lowest price and may differ from pharmacy to pharmacy for the same drug and may fluctuate from time to time. Obtaining prices from several pharmacies **may** help patients find the lowest cost, so **patients may request a price quote.**
4. If the Medi-Cal price is lower, patients can pay that price, plus a small processing fee of \$0.15, for the prescribed drug.
5. Medicare beneficiaries can avail of this program even if they have insurance coverage. However, if patients have prescription drug coverage, their insurance company is not eligible to receive the Medi-Cal price.
6. Patients must pay for the prescription in full at the pharmacy:

SB 393, Medicare Discount Program, Medi-Cal Pricing, and Prescription Drug Discount Program are a few names this outpatient drug discount program has been called. Despite the adoption and implementation of SB 393, the board continues to receive complaints from consumers regarding pharmacies not being aware of this program. The board encourages pharmacies to share this article with their staff, to provide education and awareness of this outpatient drug discount program, and to discuss how your pharmacy will implement SB 393.

# Epinephrine Standing Order

The California Department of Public Health (CDPH) in partnership with the California Department of Education (CDE) has issued a statewide standing order to help reduce morbidity and mortality associated with anaphylaxis by facilitating the distribution and administration of epinephrine in California schools. This standing order authorizes a California school (public, charter or private), school district or county office of education to obtain epinephrine auto injectors for elementary schools, junior high schools, middle schools, and high schools.

Administration of epinephrine, via regular epinephrine auto-injector or junior epinephrine auto-injector, to a person suffering, or reasonably believed to be suffering, from an anaphylactic reaction by school nurses or trained personnel is authorized in accordance with [Education Code 49414](#).

## General FAQ's

- This standing order is acceptable at all pharmacies throughout California and will automatically expire one year from the date it is signed.
- County offices of education and local education agencies may generate a standing order for multiple schools.
- This is an out-of-pocket cost and is not covered by Medi-Cal. Free auto-injectors are available to schools at [EpiPen4Schools.com](http://EpiPen4Schools.com).
- Total quantities and type, regular vs junior auto-injectors, are included at the bottom of the standing order and will vary per application.



- The maximum quantity of auto-injectors allowed by this standing order, either regular or junior, is four per school, per calendar year.
- Refills can be obtained within the year if Epinephrine is used in the course of treatment of anaphylaxis at a school site and will not count towards the 4-device limit per school site, per year.
- The standing order can be renewed annually by completing another online application form such that a new set of Epinephrine auto-injectors are available for each school site each year.

# New Continuing Education Requirement Effective January 1, 2024



California licensed pharmacists and pharmacy technicians must complete at least one hour of a cultural competency course during the two years before any renewal due on or after January 1, 2024.

Per BPC sections [4231](#) and [4202](#), "Cultural competency course" means a cultural competency and humility course that meets the following criteria:

- (1) The course focuses on patients who identify as lesbian, gay, bisexual, transgender, gender nonconforming, or queer, or who question their sexual orientation or gender identity and expression.
- (2) The course is approved from an accreditation agency approved by the board.
- (3) The course covers recognized health disparities faced by Black, Indigenous, and people of color.

- (4) The course contains elements demonstrating how sexual identity is directly impacted through intersectionality.

The Board shall not renew a pharmacist license or pharmacy technician license unless the licensee has submitted proof satisfactory to the Board that they have successfully completed the required continuing education (CE). Proof satisfactory to the Board may include specifying completion of the required CE on the renewal application provided by the Board.

The Board is not providing a training or recommending a course. A Board approved course that meets the requirements of the statute can be used. This is similar to other pharmacist continuing education courses. [Click here for updated information on CE.](#)

# Record Production Requirements

## Reminder from the Medical Board of California

As part of [Senate Bill 815](#), which updated various laws related to the Medical Board of California, there is a key provision that impact licensees of the Board of Pharmacy.

Starting January 1, 2024, licensees of the Board of Pharmacy are required to provide pharmacy records requested by the Medical Board of California in the same timeframe as required to provide records requested by the Board of Pharmacy.

Consistent with the current requirements of [Business and Professions Code section 4105\(f\)](#), this new law requires licensees of the Board of Pharmacy to provide records requested by the

Medical Board of California, or their authorized representative, within three business days of the request.

The licensee may request in writing an extension of the three-day timeframe for up to a total of 14 calendar days from the date of the request from the Medical Board of California. The request for extension shall be deemed approved if it is not denied by the Medical Board of California within two business days after it is submitted.

# Two Doses in One Container

## Patient Receives Wrong Medication

The California State Board of Pharmacy (BOP) investigated a complaint about a prescription which was dispensed with two different looking medications. On the fourth day of taking the medication, the patient noticed the prescription had two different looking medications in the prescription container. Upon returning to the pharmacy, the pharmacist confirmed the prescription was dispensed with amoxicillin 500 mg and amoxicillin 875 mg tablets. Consequently, the pharmacist who originally verified the prescription was cited for dispensing the wrong medication.

The pharmacy's investigation showed the contents of a return to stock prescription vial containing amoxicillin 875 mg tablets was inadvertently added to the manufacturers stock bottle of amoxicillin 500 mg tablets. The stock bottle of amoxicillin 500 mg tablets, which now contain amoxicillin 875 mg tablets, is considered misbranded, according to Health and Safety Code § [111395](#); the contents of the original container was partly removed and replaced with another medication, amoxicillin 875 mg tablets.

For best practice, it is recommended to leave the contents of returned to stock in

the prescription vial and cover or replace the prescription label with another label and include the name of the drug, strength, lot number, and expiration date.



# Name and Gender Change

## SB 372

Effective January 1, 2024, under Business and Professions Code section 27.5, licensees may notify the Board of Pharmacy (BOP) of a name and/or gender change and request confidentiality of the previous name or gender information, when meeting certain specified requirements. Upon request by a licensee or registrant whose name or gender, the board shall replace references to the licensee's or registrant's former name or gender with the individual's current name or gender, as applicable, on the publicly viewable information displayed on the internet about the licensee or registrant. The licensee's or registrant's former name or gender, as applicable, shall not be published online.

If the licensee changes their name or gender and was previously the subject in an enforcement action, those records will not be publicly posted on the Board website. The enforcement records are still available to the public through a Public Records Act request.

Records related to the name or gender change notification are confidential. Licensees eligible for a name change and request for confidentiality include:

- Individuals participating in the Secretary of State's Safe at Home program who confidentially change their name in a court proceeding based on concerns related to domestic violence, stalking, sexual assault, or human trafficking, pursuant to Code of Civil Procedure section 1277(b).
- Individuals who change their name in a court proceeding to conform to their gender identity, pursuant to Code of Civil Procedure section 1277.5.
- Individuals who obtain a court order to change their name in connection with a court proceeding to change their gender or sex identifier, pursuant to article 7 of chapter 11 of part 1 of division 102 of the Health and Safety Code. Such court orders are typically issued in connection with a change to a birth certificate or marriage license and certificate.

## New Regulations

The state Office of Administrative Law has approved two regulations adopted by the California State Board of Pharmacy. The regulations are listed in Division 17 of Title 16 of the California Code of Regulations (CCR).

[CCR section 1706.6, Temporary Licenses for Military Spouses/ Domestic Partners](#). This added regulation offers licensing eligibility to military spouses/ domestic partners. This

regulation went into effect March 21, 2024.

[CCR section 1707.6, Notice to Consumers](#). This amended regulation updates the Notice to Consumer requirements. This amended regulation will take place effective July 1, 2024.

# COVID-19 Oral Therapeutics Still Available

Pharmacists can continue to furnish COVID-19 patients with oral therapeutics for another year. [Business and Professional Code \(BPC\) 4052.04](#) allows pharmacists to extend this service until January 1, 2025. Pharmacists have been performing these functions under a waiver issued by the Department of Consumer Affairs as well as provisions of the Public Readiness and Emergency Preparedness (PREP) Act.

Prior to prescribing the medication, the pharmacist is required to confirm that the patient is positive for SARS-CoV-2, the virus that causes COVID-19, using a test that is approved by the federal Food and Drug Administration (FDA). Once the pharmacist provides the medication, they are required to notify the patient's primary care provider or enter the services provided into the patient's record system. If the patient does not have a primary care provider, the pharmacist will provide the patient with a written record of the drugs and advise the patient to consult with a physician.



The pharmacist will document the name and dose of the medication as well as any information regarding the testing services that were provided at the pharmacy. Records of the test and treatment will be required for three years and be accessible for inspectors.

Oral therapeutics are drugs that are approved or authorized by the United States Food and Drug Administration for the treatment of COVID-19 and are administered orally.

## Health Care Services for Consumers

The California State Board of Pharmacy created an [online registry](#) to help consumers find specific health care services that qualified pharmacists may provide to patients without a prescription pursuant to provisions of the Business and Professions Code.

These services may be provided by qualified pharmacists in individual practice as well as at pharmacies.

The health services are:

- Self-administered hormonal contraception

- Emergency contraception
- Vaccinations
- Travel medications
- Nicotine replacement therapy
- Naloxone
- HIV preexposure prophylaxis (PrEP)
- HIV postexposure prophylaxis (PEP)


# Board Welcomes New Members

# Pharmacist Service Coverage

## AB 317

[Assembly Bill 317 \(Weber\), Pharmacist Service Coverage](#) was signed by Gov. Newsom in October 2023. AB 317 requires every health care service plan, and specified disability insurers,

that offer coverage for a service that is within the scope of practice of a pharmacist to pay or reimburse the cost of services performed by a pharmacy at an in-network or out-of-

network pharmacy as specified. The bill was sponsored by the California Pharmacy Association and National Community Pharmacists Association.

# Diabetic Test Strips

## Is it an Authorized Distributor?

Diabetic test strips must only be purchased from an authorized seller. Business and Professions Code (BPC) [section 4160.5](#), requires manufacturers of nonprescription diabetes test devices to post the names of their authorized distributors on the internet and to make those names available for posting on the [California State Board of Pharmacy website](#).

“Nonprescription diabetes test device” means a glucose meter or test strip for use in the treatment of prediabetic or diabetic individuals that may be sold without a prescription and that is labeled for use by the consumer in accordance with the requirements of the laws and rules of this state and the federal government.

## Drug Take-Back Services

Pharmacies are critically important for providing consumers with safe options for the disposal of unwanted drugs. The California State Board of Pharmacy (Board) encourages the growing number of pharmacies providing drug take-back services to stay updated on the latest regulations.

Pharmacies installing drug take-back receptacle shall notify

the Board electronically by [submitting the form online](#). The Board strongly recommends all pharmacies utilize the [self-assessment form](#) to ensure compliance.

Consumers may use the [drug take-back location finder](#) to check whether their pharmacy is listed as a board-verified drug take-back location.

The requirements for drug take-back services are in the [California Code of Regulations, Title 16, Article 9.1](#). Visit the [Drug Take-back section](#) in the Licensees tab for additional information and relevant electronic forms.

# Notice to Licensees Regarding CURES Version Update

Beginning August 1, 2024, all California dispensers of controlled substances will be required to report dispensations to the Controlled Substance Utilization Review and Evaluation System (CURES) using version 4.2B of the American Society of Automation in Pharmacy (ASAP) format. On and after this date, data submitted using the current CURES ASAP version 4.1 format will no longer be accepted.

Prompt action by licensees who dispense controlled substances is recommended. Technical implementation of this update to data submission software may take considerable time. Contact your data submission software provider and confirm they are preparing for this upcoming ASAP version change.

The Office of the Attorney General (OAG) has shared


## Stay Connected Subscribe to the Board's Listserv

# Prevent Medication Errors

## Institute for Safe Medication Practices (ISMP)

The California State Board of Pharmacy encourages licensees to use the resources available for preventing medication errors through the [Institute for Safe Medication Practices](#) (ISMP). ISMP is a nonprofit organization dedicated to preventing medication errors, by providing pharmacists with many valuable tips, training materials, and other resources to help reduce medication errors and improve consumer safety.

As an independent watchdog, ISMP is widely respected among health care professionals as the gold standard in providing

information about medication safety. Its staff and advisory board include pharmacists, physicians, and nurses.

The organization's website, [ismp.org](#), is a portal to publications, tools and resources, and consulting and educational services to help health care professionals improve medication safety and reduce errors.

Free resources for practitioners include a list of Confused Drug Names (medications with look-alike and sound-alike names) and a List of Error-

Prone Abbreviations, Symbols, and Dose Designations, which have been misinterpreted and involved in harmful or potentially harmful medication errors.

ISMP's chief initiative is an error reporting system that enables health care practitioners and consumers to report medication and vaccine errors. The institute analyzes the information to identify causes and contributing factors to an error. ISMP can help reduce medication errors.

# Digital Signatures Now Available

The California State Board of Pharmacy is aware of some licensees' and applicants' desire to submit documents with digital signatures. [Government Code Section 16.5](#) establishes authority for government agencies to accept digital signatures that meet specified conditions. "If a public entity elects to use a digital signature, that digital signature shall have the same force and effect as the use of a manual signature if and only if it embodies all of the following attributes:"


- (1) It is unique to the person using it.
- (2) It is capable of verification.
- (3) It is under the sole control of the person using it.
- (4) It is linked to data in such a manner that if

the data is changed, the digital signature is invalidated,

- (5) It conforms to regulations adopted by the Secretary of State.

The Board will not require any applicant or licensee to provide information using a digital signature in lieu of a manual signature; however, the Board will accept documents that are digitally signed using technology known as Public Key Cryptography consistent with the regulations established by the Secretary of State. (Cal. Code Regs., tit.2 § 22003.)

*The Digital Signature Policy Statement requires that the Board can verify the digital signature. To verify a digital signature, the Board must receive, via email, the original electronic document that was digitally signed. Sending a PDF version or mailing a paper copy to the Board does not allow the Board to verify the digital signature.*



# Disciplinary Terms Explained

**Accusation** – An accusation is the document containing the charges and allegations of violations of the law that is filed when an agency is seeking to discipline a licensee.

**Effective Date of Action** – The date the disciplinary action goes into operation.

**Revocation or Revoked** – The license is taken back by the Board as a result of disciplinary action, and the licensee’s right to practice or operate a Board-licensed entity is ended.

**Revoked, Stayed** – The license is revoked, but the revocation is not effective as long as the licensee complies with specific probationary conditions, which may include a temporary suspension of the licensee’s right to practice.

**Stipulated Settlement** – The Board and a licensee mutually agree to settle a disciplinary case brought by the board by way of a settlement agreement.

**Stayed** – The revocation or suspension action is not immediately effective, and the operation or practice may continue so long as the licensee fully complies with any specified terms and conditions.

**Probation** – The licensee may continue to practice or operate a board-licensed entity under specific terms and conditions for a specific period of time.

**Voluntary Surrender** – The licensee has agreed to surrender his or her license, and the right to practice or operate a Board-licensed entity is ended. The Board may agree to accept the surrender of a license through a “stipulation” or agreement.

**Suspension** – The licensee is prohibited from practicing or from operating a Board-licensed entity for a specific period of time.

**Suspension/Probation** – The right to practice or operate is contingent on compliance with specific terms and conditions during the probationary period, including a term of suspension.

**PC 23 Order Issued** – The licensee is restricted from practicing or operating by the terms of a court order issued under the provisions of Penal Code section 23.

**Public Reprimand** – Resulting from a disciplinary action, the licensee is issued a letter of public reprimand.

**Reinstatement of License** – A previously revoked or suspended license is reinstated with or without specified terms and conditions.

**Statement of Issues** – A legal document that details the factual or legal basis for which a license was denied.
