The Board of Pharmacy has received notice of the following product recall. The Board strongly encourages pharmacies to immediately review their quality assurance and recall policies and procedures to determine if any corrective action is required.

Imprimis NJOF would like to inform you of a recall notice involving Klarity-C (Cyclosporine 0.1%) Sterile Ophthalmic Emulsion. During a recent FDA inspection, investigators observed certain deviations from standard operating procedures regarding the production of Klarity-C (Cyclosporine 0.1%) Sterile Ophthalmic Emulsion.

Imprimis' assessment of this issue revealed the "likelihood of a health hazard is unlikely", however, out of an abundance of caution, Imprimis NJOF ("Imprimis") has initiated a recall of all unexpired lots of Klarity-C that reflect observed issues.

To be clear, all the identified lots obtained passing results for sterility, potency, endotoxin testing, identification, minimum fill, finished product pH, and description/color/clarity testing prior to release. Additionally, each lot was fully reviewed and dispositioned by members of the Quality Assurance department prior to release. Furthermore, no adverse drug events were received that directly correlated to the issue at hand.
