The Board of Pharmacy has received notice of the following product recall. The Board strongly encourages pharmacies to immediately review their quality assurance and recall policies and procedures to determine if any corrective action is required.

Teva Pharmaceuticals USA, Inc. (TEVA USA) is conducting a nationwide Market Withdrawal of all its Digihaler® products that are within expiry to the **RETAIL LEVEL**. The Digihaler® products in this Market Withdrawal were distributed to TEVA USA direct customers under the Teva Pharmaceuticals USA, Inc. label. The reason for the Market Withdrawal is because the Digihaler® App and Dashboard is no longer available, which does not align with the patient information leaflet for each of these Digihaler® products. Teva USA's safety assessment concluded that unavailability of the Digihaler® App and Dashboard is not clinically relevant given that the digihaler devices will still function with no impact to delivery of the medicine. As such, exposure to the subject Digihaler® products of concern is not expected to lead to adverse health consequences outside the known safety profile of the respective drug.

TEVA's distribution records indicate that the specified Digihaler® lots being Withdrawn were shipped to its direct customers from 03/02/2022 - 05/16/2024.
