

The Board of Pharmacy has received notice of the following product recall. The Board strongly encourages pharmacies to immediately review their quality assurance and recall policies and procedures to determine if any corrective action is required.

This is to inform you of a product recall by Imprimis NJOF involving the following products:

This recall is for a total of 6 (six) unexpired lots due to possible particulate matter. Based on the findings of our expanded Health Hazard Evaluation, we have made the decision to recall the affected lots out of an abundance of caution and in the interest of patient safety. The evaluation identified a potential risk of particulate matter, including glass-like particles, in certain ophthalmic injectable products, which may not be reliably detectable by clinicians prior to administration and could pose a risk if introduced intraocularly. While adverse events have been limited, the assessment concluded that, if particulates are present, there is a reasonable risk of patient harm, including inflammation, elevated intraocular pressure, or the need for medical intervention. In alignment with our commitment to quality and regulatory compliance, we are initiating this recall to prevent potential patient impact while we implement corrective actions to address root causes and strengthen our manufacturing and inspection controls. The six unexpired batches have been identified as mentioned below.
