Dear Mr. Day:

On May 18, 2015, the Board of Pharmacy, Department of Consumer Affairs, State of California, filed Second Amended Accusation against New Albertson's, Inc.'s Pharmacy Permit No. PHY 48198. The Second Amended Accusation alleged that New Albertson's, Inc., a subsidiary of Supervalu, Inc. until March 21, 2013, and doing business as Savon.Com #5805, located at 2510 El Camino Real, Suite A, Carlsbad, CA 92008, engaged in unprofessional conduct as follows:

(1) under Business and Professions Code section 4301(j) and (o) on November 16, 2010, when it dispensed prescriptions in prescription containers in the name of DailyMed California in violation of Business and Professions Code section 4076(a)(6).

(2) under Business and Professions Code section 4301(o) on November 15, 2010 and June 14, 2011, when it failed to maintain in California the hard copy, original prescription records for prescriptions, including Schedule III and Schedule IV controlled substances that it dispensed to DailyMed California patients, in violation of Business and Professions Code section 4081(a) and section 4105(d);

(3) under Business and Professions Code section 4301(o) on November 15, 2010 when it failed to properly print out, verify, date, sign and maintain prescription records for refilled Schedule III and Schedule IV controlled substances in violation of Code of Federal Regulations, title 21, section 1306.22;

(4) under Business and Professions Code section 4301(o) when it aided and abetted the illegal wholesaling of dangerous drugs in violation of California Code of Regulations, title 16, section 1783(d);

(5) under Business and Professions Code section 4301(j) when it failed to maintain original prescriptions for Schedule II controlled substances for at least 3 years from the date of filling for prescription in violation of Health and Safety Code section 11179;

(6) under Business and Professions Code section 4301(o) when between January 1, 2010 to May 16, 2011, it failed to submit CURES data for the Schedule II, Schedule III and Schedule IV controlled substances dispensed in violation of Health and Safety Code section 11165(d);

(7) under Business and Professions Code section 4301(o) on November 16, 2010 when it aided and abetted DailyMed California to dispense controlled substances at Savon.Com #5805's licensed facility without a separate Drug Enforcement Agency registration in violation of Code of Federal Regulations, title 21, section 1301.11(a) and section 1301.12(a);

(8) under Business and Professions Code section 4301(o), for the operation of DailyMed California, an unlicensed pharmacy, at Savon.Com #5805's licensed pharmacy location in violation of Business and Professions Code section 4110(a);

(9) under Business and Professions Code section 4301(o), when it shipped prescriptions without written notice informing patients of their right to consultation from a pharmacist who had ready access their medical records, and failed to provide a telephone number of a California pharmacist in violation of California Code of Regulations, title 16, section 1707.2(b)(2);

(10) under Business and Professions Code section 4301 when it dispensed medications in improperly labeled containers, in violation of Business and Professions Code section 4076(a);

(11) under Business and Professions Code section 4301 when on June 14, 2011, it dispensed medications in non-child resistant packaging without proper authorization or warning, in violation of California Code of Regulations, title 16, section 1717(a), and Code of Federal Regulations, title 16, section 1701.1;

(12) under Business and Professions Code section 4301(f) when it engaged in acts involving moral turpitude, dishonesty, fraud, deceit, or corruption by illegally wholesaling dangerous drugs in violation of California Code of Regulations section 1783(d); and by illegally operating DailyMed California, an unlicensed pharmacy, at Savon.Com #5805's licensed pharmacy location in violation of Business and Professions Code section 4110(a);


(13) under Business and Professions Code section 4301(o), when it transferred Schedule II controlled substances to DailyMed California, an unlicensed pharmacy, in violation of Business and Professions Code section 4169(a)(1), and without completing and retaining Drug Enforcement Agency Form 222 in violation of Code of Federal Regulations, title 21, section 1305.13; and

(14) under Business and Professions Code section 4301(j) and (o), when it transferred Schedule III, IV and V controlled substances to DailyMed California, an unlicensed pharmacy, in violation of section 4169(a)(1), and without maintaining records concerning the number of commercial containers distributed, including the date of and number of containers in each reduction from inventory, and the name, address, and registration number of the person to whom the containers were distributed in violation of Code of Federal Regulations, title 21, section 1304.22(a)(2)(vii).

As Savon.Com #5805's authorized representative, you agreed that the charges and allegations in Second Amended Accusation No. 4143, if proven at a hearing, constituted cause for imposing discipline upon Pharmacy Permit No. PHY 48198. You agreed that at a hearing Complainant could establish a factual basis for the charges in the Second Amended Accusation, and gave up Respondent's right to contest those charges. Finally, on behalf of Respondent, you agreed that Respondent's Pharmacy Permit No. PHY 48198 was subject to discipline, and agreed to be bound by the Board's Disciplinary Order.

Accordingly, in resolution of this matter under the authority provided under Business and Professions Code section 495, the Board of Pharmacy, Department of Consumer Affairs issues this letter of public reproof.

18 **IT IS HEREBY STIPULATED AND AGREED** by and between the parties to the above-
19 entitled proceedings that the following matters are true:

20 **PARTIES**

21 1. Virginia Herold (Complainant) is the Executive Officer of the Board of Pharmacy
22 (Board). She brought this action solely in her official capacity and is represented in this matter by
23 Kamala D. Harris, Attorney General of the State of California, by Antoinette B. Cincotta, Deputy
24 Attorney General.

25 2. New Albertson's, Inc., doing business as Savon.Com #5805 (Respondent) is
26 represented in this proceeding by attorneys Marian Zapata-Rossa and Amy R. Cotton Peterson,
27 whose address is: Quarles & Brady LLP, One Renaissance Square, Two North Central Avenue,
28 Phoenix, AZ, 85004-2391, (telephone number 602-229-5200).

1 CULPABILITY

2 8. Respondent's authorized representative, on behalf of Respondent, understands and
3 agrees that the charges and allegations in Second Amended Accusation No. 4143, if proven at a
4 hearing, constitute cause for imposing discipline upon Pharmacy Permit No. PHY 48198.

5 9. For the purpose of resolving the Second Amended Accusation without the expense
6 and uncertainty of further proceedings, Respondent's authorized representative, on behalf of
7 Respondent, agrees that at a hearing Complainant could establish a factual basis for the charges in
8 the Second Amended Accusation, and that Respondent's authorized representative, on behalf of
9 Respondent hereby gives up its right to contest those charges.

10 10. Respondent's authorized representative, on behalf of Respondent, agrees that
11 Pharmacy Permit No. PHY 48198 is subject to discipline, and agrees to be bound by the
12 Disciplinary Order below.

13 RESERVATION

14 11. The admissions made by Respondent herein are only for the purposes of this
15 proceeding, or any other proceedings in which the Board of Pharmacy or other professional
16 licensing agency is involved, and shall not be admissible in any other criminal or civil
17 proceeding.

18 CONTINGENCY

19 12. This stipulation shall be subject to approval by the Board of Pharmacy. Respondent's
20 authorized representative understands and agrees that counsel for Complainant and the staff of the
21 Board of Pharmacy may communicate directly with the Board regarding this Stipulated
22 Settlement and Disciplinary Order for Public Repeval, without notice to or participation by
23 Respondent, Respondent's authorized representative, or its counsel. By signing the stipulation,
24 Respondent's authorized representative understands and agrees that Respondent may not
25 withdraw this agreement or seek to rescind the stipulation prior to the time the Board considers
26 and acts upon it. If the Board fails to adopt this stipulation as its Decision and Order, Stipulated
27 Settlement and Disciplinary Order for Public Repeval shall be of no force or effect, except for

28 ///

1 this paragraph, it shall be inadmissible in any legal action between the parties, and the Board shall
2 not be disqualified from further action by having considered this matter.

3 13. The parties understand and agree that Portable Document Format (PDF) and facsimile
4 copies of this Stipulated Settlement and Disciplinary Order for Public Repeval, including
5 facsimile signatures thereto, shall have the same force and effect as the originals.

6 14. This Stipulated Settlement and Disciplinary Order for Public Repeval is intended by
7 the parties to be an integrated writing representing the complete, final, and exclusive embodiment
8 of their agreement. It supersedes any and all prior or contemporaneous agreements,
9 understandings, discussions, negotiations, and commitments (written or oral). This Stipulated
10 Settlement and Disciplinary Order for Public Repeval may not be altered, amended, modified,
11 supplemented, or otherwise changed except by a writing executed by an authorized representative
12 of each of the parties.

13 15. In consideration of the foregoing admissions and stipulations, the parties agree that
14 the Board may, without further notice or formal proceeding, issue and enter the following Order:

15 ORDER

16 IT IS HEREBY ORDERED that Pharmacy Permit No. PHY 48198 issued to Respondent
17 New Albertson's, Inc., doing business as Savon.Com #5805, shall by way of letter from the
18 Board's Executive Officer be publicly reprovod. The letter shall be in substantially the same
19 form as the letter attached as Exhibit B to this stipulation.


20 IT IS FURTHER ORDERED that Respondent shall pay to the Board fifty (50) percent of
21 the Board's costs of investigation and prosecution in the amount of \$21,624.00 within 90 days of
22 the effective date of this Decision and Order.

23 IT IS FURTHER ORDERED that within 90 days of the effective date of this decision,
24 Respondent shall also pay a fine in the amount of \$5,000.00 to the Board.

25 ACCEPTANCE

26 I, Daniel Day, Vice President, Litigation and Regulatory Compliance, am the authorized
27 representative of Respondent New Albertson's, Inc., doing business as Savon.Com #5805. In my
28 capacity as the authorized representative of Respondent, I have carefully read the above

1 Stipulated Settlement and Disciplinary Order for Public Repeval, and have fully discussed it
2 with attorneys, Marian Zapata-Rossa and Amy R. Cotton Peterson. I understand the stipulation
3 and the effect it will have on Respondent's Pharmacy Permit No. PHY 48198. I enter into this
4 Stipulated Settlement and Disciplinary Order for Public Repeval on behalf of Respondent
5 voluntarily, knowingly, and intelligently, and agree on behalf of Respondent to be bound by the
6 Decision and Order of the Board of Pharmacy.



21 Complainant alleges:

22 **PARTIES**

23 1. Virginia Herold (Complainant) brings this Second Amended Accusation solely in her
24 official capacity as the Executive Officer of the Board of Pharmacy (Board), Department of
25 Consumer Affairs.

26 2. On or about December 19, 2006, the Board issued Pharmacy Permit Number PHY
27 48198 to New Albertson's, Inc., to do business as Savon.Com #5805, and located at 2510 El
28 Camino Real, Suite A, Carlsbad, CA 92008. (Respondent Savon.Com). On December 19, 2006,

1 Perry Wayne Brown associated as the Pharmacist-In-Charge of Respondent Savon.Com. The
2 Pharmacy License was in full force and effect at all times relevant to the charges brought herein,
3 was cancelled on March 27, 2013 pursuant to a change of ownership. Administrative action was
4 previously taken against this permit in the form of Citation No. CI 2010 45191, issued on
5 November 29, 2010.

6 3. On or about August 10, 1979, the Board issued Pharmacist License Number RPH
7 32935 to Perry Wayne Brown (Respondent Brown). Perry Wayne Brown, RPH 32935 was the
8 Pharmacist-in-Charge of Savon.Com #5805 from December 19, 2006 to March 27, 2013. The
9 Pharmacist License was in full force and effect at all times relevant to the charges brought herein
10 and will expire on January 31, 2015, unless renewed.

11 JURISDICTION

12 4. This Second Amended Accusation is brought before the Board under the authority of
13 the following laws. All section references are to the Business and Professions Code unless
14 otherwise indicated.

15 5. Section 4300 of the Code states in relevant part:

16 (a) Every license issued may be suspended or revoked.

17 (b) The board shall discipline the holder of any license issued by the board,
18 whose default has been entered or whose case has been heard by the board and
found guilty, by any of the following methods:

19 (1) Suspending judgment.

20 (2) Placing him or her upon probation.

21 (3) Suspending his or her right to practice for a period not exceeding one
22 year.

23 (4) Revoking his or her license.

24 (5) Taking any other action in relation to disciplining him or her as the board
in its discretion may deem proper.

25 ...

26 (e) The proceedings under this article shall be conducted in accordance with
27 Chapter 5 (commencing with Section 11500) of Part 1 of Division 3 of the
Government Code, and the board shall have all the powers granted therein. The
28 action shall be final, except that the propriety of the action is subject to review by
the superior court pursuant to Section 1094.5 of the Code of Civil Procedure.

6. Section 4300.1 of the Code, effective January 1, 2013, states:

The expiration, cancellation, forfeiture, or suspension of a board-issued license by operation of law or by order or decision of the board or a court of law, the placement of a license on a retired status, or the voluntary surrender of a license by a licensee shall not deprive the board of jurisdiction to commence or proceed with any investigation of, or action or disciplinary proceeding against, the licensee or to render a decision suspending or revoking the license.

STATUTORY AUTHORITIES

7. Section 4022 of the Code states

"Dangerous drug" or "dangerous device" means any drug or device unsafe for self-use in humans or animals, and includes the following:

- (a) Any drug that bears the legend: "Caution: federal law prohibits dispensing without prescription," "Rx only," or words of similar import.
- (b) Any device that bears the statement: "Caution: federal law restricts this device to sale by or on the order of a _____," "Rx only," or words of similar import, the blank to be filled in with the designation of the practitioner licensed to use or order use of the device.
- (c) Any other drug or device that by federal or state law can be lawfully dispensed only on prescription or furnished pursuant to Section 4006.

8. Section 4076 of the Code states in relevant part:

(a) A pharmacist shall not dispense any prescription except in a container that meets the requirements of state and federal law and is correctly labeled with all of the following:

...

(6) The name and address of the pharmacy, and prescription number or other means of identifying the prescription.

....

9. Section 4081 of the Code states in relevant part:

(a) All records of manufacture and of sale, acquisition, or disposition of dangerous drugs or dangerous devices shall be at all times during business hours open to inspection by authorized officers of the law, and shall be preserved for at least three years from the date of making. A current inventory shall be kept by every manufacturer, wholesaler, pharmacy, veterinary food-animal drug retailer, physician, dentist, podiatrist, veterinarian, laboratory, clinic, hospital, institution, or establishment holding a currently valid and unrevoked certificate, license, permit, registration, or exemption under Division 2 (commencing with Section 1200) of the Health and Safety Code or under Part 4 (commencing with Section 16000) of Division 9 of the Welfare and Institutions Code who maintains a stock of dangerous drugs or dangerous devices.

.....
10. Section 4105 of the Code states in relevant part:

.....
(d) Any records that are maintained electronically shall be maintained so that the pharmacist-in-charge, the pharmacist on duty if the pharmacist-in-charge is not on duty, or, in the case of a veterinary food-animal drug retailer or wholesaler, the designated representative on duty, shall, at all times during which the licensed premises are open for business, be able to produce a hard copy and electronic copy of all records of acquisition or disposition or other drug or dispensing-related records maintained electronically.
.....

11. Section 4110 of the Code states in relevant part:

(a) No person shall conduct a pharmacy in the State of California unless he or she has obtained a license from the board. A license shall be required for each pharmacy owned or operated by a specific person. A separate license shall be required for each of the premises of any person operating a pharmacy in more than one location. The license shall be renewed annually. The board may, by regulation, determine the circumstances under which a license may be transferred.
.....

12. Section 4169 of the Code states in relevant part:

(a) A person or entity may not do any of the following:
(1) Purchase, trade, sell, or transfer dangerous drugs or dangerous devices at wholesale with a person or entity that is not licensed with the board as a wholesaler or pharmacy.
.....

13. Section 4301 of the Code states in relevant part:

The board shall take action against any holder of a license who is guilty of unprofessional conduct or whose license has been procured by fraud or misrepresentation or issued by mistake. Unprofessional conduct shall include, but is not limited to, any of the following:
.....
(f) The commission of any act involving moral turpitude, dishonesty, fraud, deceit, or corruption, whether the act is committed in the course of relations as a licensee or otherwise, and whether the act is a felony or misdemeanor or not.
.....

1 (j) The violation of any of the statutes of this state, or any other state, or of
2 the United States regulating controlled substances and dangerous drugs.

3 ...

4 (o) Violating or attempting to violate, directly or indirectly, or assisting in or
5 abetting the violation of or conspiring to violate any provision or term of this
6 chapter or of the applicable federal and state laws and regulations governing
7 pharmacy, including regulations established by the board or by any other state or
8 federal regulatory agency.

9

10 14. Health and Safety Code section 11165 effective January 1, 2010 to December 31,
11 2011, stated in relevant part:

12 (a) To assist law enforcement and regulatory agencies in their efforts to
13 control the diversion and resultant abuse of Schedule II, Schedule III, and
14 Schedule IV controlled substances, and for statistical analysis, education, and
15 research, the Department of Justice shall, contingent upon the availability of
16 adequate funds from the Contingent Fund of the Medical Board of California, the
17 Pharmacy Board Contingent Fund, the State Dentistry Fund, the Board of
18 Registered Nursing Fund, and the Osteopathic Medical Board of California
19 Contingent Fund, maintain the Controlled Substance Utilization Review and
20 Evaluation System (CURES) for the electronic monitoring of the prescribing and
21 dispensing of Schedule II, Schedule III, and Schedule IV controlled substances by
22 all practitioners authorized to prescribe or dispense these controlled substances.

23 ...

24 (d) For each prescription for a Schedule II, Schedule III, or Schedule IV
25 controlled substance, the dispensing pharmacy or clinic shall provide the following
26 information to the Department of Justice on a weekly basis and in a format
27 specified by the Department of Justice:

28 (1) Full name, address, and the telephone number of the ultimate user or
research subject, or contact information as determined by the Secretary of the
United States Department of Health and Human Services, and the gender, and date
of birth of the ultimate user.

(2) The prescriber's category of licensure and license number; federal
controlled substance registration number; and the state medical license number of
any prescriber using the federal controlled substance registration number of a
government-exempt facility.

(3) Pharmacy prescription number, license number, and federal controlled
substance registration number.

(4) NDC (National Drug Code) number of the controlled substance
dispensed.

(5) Quantity of the controlled substance dispensed.

(6) ICD-9 (diagnosis code), if available.

(7) Number of refills ordered.

(8) Whether the drug was dispensed as a refill of a prescription or as a first-time request.

(9) Date of origin of the prescription.

(10) Date of dispensing of the prescription.

(e) This section shall become operative on January 1, 2005.

15. Health and Safety Code section 11179 states:

A person who fills a prescription shall keep it on file for at least three years from the date of filling it.

16. Health and Safety Code section 108695 states:

To the extent that the requirements of this chapter are identical with the federal act, all regulations and any amendments to the regulations adopted pursuant to the federal act, that are in effect on January 1, 1978, or that are adopted on or after that date, shall be the poison prevention packaging regulations of this state.

REGULATIONS

17. California Code of Regulations (CCR), title 16, section 1707.2, states in relevant part:

...

(b)...

(2) When the patient or agent is not present (including but not limited to a prescription drug that was shipped by mail) a pharmacy shall ensure that the patient receives written notice:

(A) of his or her right to request consultation; and

(B) a telephone number from which the patient may obtain oral consultation from a pharmacist who has ready access to the patient's record.

....

18. CCR, title 16, section 1717, states in relevant part:

(a) No medication shall be dispensed on prescription except in a new container which conforms with standards established in the official compendia.

///

///

1 19. CCR, title 16, section 1783, states in relevant part:

2 ...

3 (d) A manufacturer or wholesaler shall not accept payment for or allow the
4 use of an entity's credit to establish an account for the purchase of dangerous drugs
5 or devices from any person other than: (1) the owner(s) of record, chief executive
6 officer, or chief financial officer listed on the permit for the authorized person; and
7 (2) on an account bearing the name of the permittee.

8 20. Code of Federal Regulations (CFR), title 16, section 1701.1, states in relevant part:

9 (a) In order to assist manufacturers of prescription drugs in discharging their
10 responsibilities under the act concerning such drugs that are distributed to
11 pharmacies, the Consumer Product Safety Commission has codified this statement
12 of its policy concerning which prescription drug packages supplied by
13 manufacturers to pharmacies must comply with the "special" (child-resistant)
14 packaging requirements contained in 16 CFR 1700.15.

15 (b) Manufacturers of prescription drugs may package such drugs for
16 distribution to pharmacies in different types of packages, depending on whether
17 the manufacturer intends that the package will be the one in which the drug is
18 ultimately given to the consumer or whether it is intended that the pharmacist will
19 repackage the drug before it is dispensed to the consumer. If the drug is supplied in
20 a bulk package from which individual prescriptions are intended to be repackaged
21 by the pharmacist, the manufacturer need not utilize special packaging. However,
22 the Commission interprets the provision of the act as requiring that all prescription
23 drugs subject to a special packaging standard that are distributed to pharmacies
24 shall be in special packaging if the immediate package in which the drugs are
25 distributed by the manufacturer is intended to be the package in which the drugs
26 are dispensed to the consumer. Examples of such packages include mnemonic
27 dispensing devices; dropper bottles; packages with "tear off" labels; packages
28 which incorporate ancillary instructions for consumer handling, storage, or use on
permanently affixed portions of their labels; and products intended to be
reconstituted in their original containers. The Commission believes that this
interpretation is necessary in order to insure that the pharmacist will actually
dispense the drug in the proper package. If the pharmacist receives a request from
the consumer or an order from the prescribing medical practitioner for
conventional (noncomplying) packaging, section 4(b) of the act permits the
pharmacist to convert the package to conventional packaging or repackage the
drug in conventional packaging.

(c) Manufacturers should also note that section 4(a) of the act (which allows
a product to be marketed in noncomplying packaging of a single size under certain
circumstances) does not apply to prescription drugs subject to section 4(b) of the
act. Thus, since the section 4(a) single-size exemption for over-the-counter drugs
and other household substances does not apply to prescription drugs, every unit of
a prescription drug subject to a special packaging standard which is distributed to a
pharmacy in a package intended by the manufacturer to be dispensed to a
consumer shall be in special packaging.

(d) Nothing in this statement of policy and interpretation should be
interpreted as relieving the pharmacist of the responsibility of insuring that all
prescription drugs subject to a special packaging standard are dispensed to the

consumer in special packaging unless otherwise ordered by the prescribing practitioner or otherwise requested by the consumer.

21. CFR, title 21, section 1301.11 states in relevant part:

(a) Every person who manufactures, distributes, dispenses, imports, or exports any controlled substance or who proposes to engage in the manufacture, distribution, dispensing, importation or exportation of any controlled substance shall obtain a registration unless exempted by law or pursuant to §§ 1301.22 through 1301.26. Except as provided in paragraph (b) of this section, only persons actually engaged in such activities are required to obtain a registration; related or affiliated persons who are not engaged in such activities are not required to be registered. (For example, a stockholder or parent corporation of a corporation manufacturing controlled substances is not required to obtain a registration.)

....

22. CFR, title 21, section 1301.12 states in relevant part:

(a) A separate registration is required for each principal place of business or professional practice at one general physical location where controlled substances are manufactured, distributed, imported, exported, or dispensed by a person.

....

23. CFR, title 21, section 1304.22 states in relevant part:

Each person registered or authorized (by § 1301.13(e) or §§ 1307.11-1307.13 of this chapter) to manufacture, distribute, dispense, import, export or conduct research with controlled substances shall maintain records with the information listed below.

(a) Records for manufacturers. Each person registered or authorized to manufacture controlled substances shall maintain records with the following information:

...

(2) For each controlled substance in finished form,

...

(vii) The number of commercial containers distributed to other persons, including the date of and number of containers in each reduction from inventory, and the name, address, and registration number of the person to whom the containers were distributed;

....

24. CFR, title 21, section 1305.13 states in relevant part:

(a) A purchaser must submit Copy 1 and Copy 2 of the DEA Form 222 to the supplier and retain Copy 3 in the purchaser's files.

25. CFR, title 21, section 1306.22 states in relevant part:

...
(b) Each refilling of a prescription shall be entered on the back of the prescription or on another appropriate document or electronic prescription record. If entered on another document, such as a medication record, or electronic prescription record, the document or record must be uniformly maintained and readily retrievable.

(c) The following information must be retrievable by the prescription number:

- (1) The name and dosage form of the controlled substance.
- (2) The date filled or refilled.
- (3) The quantity dispensed.
- (4) The initials of the dispensing pharmacist for each refill.
- (5) The total number of refills for that prescription.

(d) If the pharmacist merely initials and dates the back of the prescription or annotates the electronic prescription record, it shall be deemed that the full face amount of the prescription has been dispensed.

(e) The prescribing practitioner may authorize additional refills of Schedule III or IV controlled substances on the original prescription through an oral refill authorization transmitted to the pharmacist provided the following conditions are met:

(1) The total quantity authorized, including the amount of the original prescription, does not exceed five refills nor extend beyond six months from the date of issue of the original prescription.

(2) The pharmacist obtaining the oral authorization records on the reverse of the original paper prescription or annotates the electronic prescription record with the date, quantity of refill, number of additional refills authorized, and initials the paper prescription or annotates the electronic prescription record showing who received the authorization from the prescribing practitioner who issued the original prescription.

(3) The quantity of each additional refill authorized is equal to or less than the quantity authorized for the initial filling of the original prescription.

(4) The prescribing practitioner must execute a new and separate prescription for any additional quantities beyond the five-refill, six-month limitation.

///

1 (f) As an alternative to the procedures provided by paragraphs (a) through
2 (e) of this section, a computer application may be used for the storage and retrieval
3 of refill information for original paper prescription orders for controlled substances
4 in Schedule III and IV, subject to the following conditions:

5 (1) Any such proposed computerized application must provide online
6 retrieval (via computer monitor or hard-copy printout) of original prescription
7 order information for those prescription orders that are currently authorized for
8 refilling. This shall include, but is not limited to, data such as the original
9 prescription number; date of issuance of the original prescription order by the
10 practitioner; full name and address of the patient; name, address, and DEA
11 registration number of the practitioner; and the name, strength, dosage form,
12 quantity of the controlled substance prescribed (and quantity dispensed if different
13 from the quantity prescribed), and the total number of refills authorized by the
14 prescribing practitioner.

15 (2) Any such proposed computerized application must also provide online
16 retrieval (via computer monitor or hard-copy printout) of the current refill history
17 for Schedule III or IV controlled substance prescription orders (those authorized
18 for refill during the past six months). This refill history shall include, but is not
19 limited to, the name of the controlled substance, the date of refill, the quantity
20 dispensed, the identification code, or name or initials of the dispensing pharmacist
21 for each refill and the total number of refills dispensed to date for that prescription
22 order.

23 (3) Documentation of the fact that the refill information entered into the
24 computer each time a pharmacist refills an original paper, fax, or oral prescription
25 order for a Schedule III or IV controlled substance is correct must be provided by
26 the individual pharmacist who makes use of such an application. If such an
27 application provides a hard-copy printout of each day's controlled substance
28 prescription order refill data, that printout shall be verified, dated, and signed by
the individual pharmacist who refilled such a prescription order. The individual
pharmacist must verify that the data indicated are correct and then sign this
document in the same manner as he would sign a check or legal document (e.g.,
J.H. Smith, or John H. Smith). This document shall be maintained in a separate file
at that pharmacy for a period of two years from the dispensing date. This printout
of the day's controlled substance prescription order refill data must be provided to
each pharmacy using such a computerized application within 72 hours of the date
on which the refill was dispensed. It must be verified and signed by each
pharmacist who is involved with such dispensing. In lieu of such a printout, the
pharmacy shall maintain a bound log book, or separate file, in which each
individual pharmacist involved in such dispensing shall sign a statement (in the
manner previously described) each day, attesting to the fact that the refill
information entered into the computer that day has been reviewed by him and is
correct as shown. Such a book or file must be maintained at the pharmacy
employing such an application for a period of two years after the date of
dispensing the appropriately authorized refill.

(4) Any such computerized application shall have the capability of
producing a printout of any refill data that the user pharmacy is responsible for
maintaining under the Act and its implementing regulations. For example, this
would include a refill-by-refill audit trail for any specified strength and dosage
form of any controlled substance (by either brand or generic name or both). Such a
printout must include name of the prescribing practitioner, name and address of the

1 patient, quantity dispensed on each refill, date of dispensing for each refill, name
2 or identification code of the dispensing pharmacist, and the number of the original
3 prescription order. In any computerized application employed by a user pharmacy
4 the central recordkeeping location must be capable of sending the printout to the
5 pharmacy within 48 hours, and if a DEA Special Agent or Diversion Investigator
6 requests a copy of such printout from the user pharmacy, it must, if requested to do
7 so by the Agent or Investigator, verify the printout transmittal capability of its
8 application by documentation (e.g., postmark).

9 (5) In the event that a pharmacy which employs such a computerized
10 application experiences system down-time, the pharmacy must have an auxiliary
11 procedure which will be used for documentation of refills of Schedule III and IV
12 controlled substance prescription orders. This auxiliary procedure must ensure that
13 refills are authorized by the original prescription order, that the maximum number
14 of refills has not been exceeded, and that all of the appropriate data are retained for
15 online data entry as soon as the computer system is available for use again.

16 (g) When filing refill information for original paper, fax, or oral prescription
17 orders for Schedule III or IV controlled substances, a pharmacy may use only one
18 of the two applications described in paragraphs (a) through (e) or (f) of this
19 section.

20 (h) When filing refill information for electronic prescriptions, a pharmacy
21 must use an application that meets the requirements of part 1311 of this chapter.

22 COSTS

23 26. Section 125.3 of the Code states, in pertinent part, that the Board may request the
24 administrative law judge to direct a licensee found to have committed a violation or violations of
25 the licensing act to pay a sum not to exceed the reasonable costs of the investigation and
26 enforcement of the case.

27 FACTS

28 November 16, 2010 Inspection/Investigation

29 27. On September 10, 2010, the Board received a complaint alleging Respondent
30 Savon.Com had multiple questionable dispensing procedures. On October 19, 2010, the Board
31 received a second complaint which alleged essentially the same questionable practices.

32 28. On November 16, 2010, the Board's inspectors conducted a routine inspection and
33 complaint investigation of Respondent Savon.Com located at 2510 El Camino Real, Suite A, in
34 Carlsbad, California. Respondent Brown was present, together with a pharmacist, five pharmacy
35 technicians, an IT specialist, a shipping specialist for "DailyMed California," the operations
36 manager from Indianapolis for "DailyMed California," the Vice President of SuperValu, Inc., and

1 the Vice President of Pharmacy Operations for DailyMed Pharmacy (Non-Resident Pharmacy
2 License NRP 956, cancelled); all with the same address as Respondent Savon.Com.

3 29. During the course of the inspection, the Board's investigators learned that two
4 pharmacies operated within Respondent Savon.Com's licensed premise in Carlsbad,
5 California: Respondent Savon.Com and "DailyMed California," (also known as DailyMed
6 Dedicated Facility "DMDF"). DailyMed California has never been licensed by the Board as
7 either a pharmacy or wholesaler. DailyMed California was also never registered with the Federal
8 Drug Enforcement Agency (DEA).

9 30. On or about November 9, 2009, SuperValu Inc., the owners of Respondent
10 Savon.Com, and Arcadia Resources, Inc., dba Arcadia HealthCare, one of the partners in
11 DailyMed Pharmacy, entered into an agreement to provide prescription drug services, to bill, and
12 to adjudicate claims for WellPoint's California Medicaid (Medi-Cal) member patients. Under the
13 terms of the agreement, WellPoint's California Medicaid (Medi-Cal) member patients'
14 prescriptions were processed and stored at DailyMed Pharmacy in Indianapolis, Indiana.
15 Respondent Savon.Com #5805 authorized DailyMed Pharmacy to bill California Medicaid
16 (Medi-Cal) member patients' prescription drugs using Respondent Savon.Com's Medi-Cal
17 Provider Number, and National Counsel for Prescription Drug Programs (NCPDP) Provider
18 Identification Number,¹ as well as the NCPDP Number for SavOn #6741 located in Poway.
19 Under the agreement, DailyMed Pharmacy in Indianapolis was billed for the pharmaceutical
20 drugs shipped to Respondent Savon.Com's licensed location in Carlsbad, California. Respondent
21 SaveOn.com transferred the pharmaceutical drugs to DailyMed California (also known as
22 DailyMed Dedicated Facility, "DMDF"), the unlicensed pharmacy operating inside Respondent
23 Savon.Com. DailyMed California then dispensed the pharmaceutical drugs to WellPoint's
24 California Medicaid (Medi-Cal) member patients by: (1) downloading the patients' prescription

26 ¹ The NCPDP Provider Identification number was developed over 25 years ago to provide
27 pharmacies with a unique, national identifier that would assist pharmacies in their interactions
28 with pharmacy payers and claims processors. The NCPDP Provider ID is a seven-digit numbering
system that is assigned to every licensed pharmacy and qualified Non-Pharmacy Dispensing Sites
(NPDS) in the United States.

1 data from DailyMed in Indianapolis onto computers maintained at Respondent Savon.Com's
2 licensed facility; (2) printing out prescription labels in the name "DailyMed California;"
3 (3) placing the "DailyMed California" labels on containers packaged with the pharmaceutical
4 drugs that had been transferred from Respondent Savon.Com to "DailyMed California;" and
5 (4) once packaged, shipping the pharmaceutical drugs from Respondent Savon.Com's licensed
6 facility to the Medi-Cal member patients using DailyMed Pharmacy's name on the shipping
7 packages.

8 31. Beginning in or about January 2010, and continuing until the time of the inspection
9 on November 16, 2010, Respondent Brown served as the Pharmacist-In-Charge of Respondent
10 Savon.Com and as the General Manager ("Rx CA") of DailyMed California, the unlicensed
11 pharmacy. The two pharmacies operated at Respondent Savon.Com's licensed facility as
12 follows:

13 (a) Respondent Savon.Com and DailyMed California, the unlicensed pharmacy, maintained
14 separate computer systems for the two pharmacies inside Respondent Savon.Com's licensed
15 facility;

16 (b) Respondent Savon.Com and DailyMed California maintained separate labels for the
17 prescriptions dispensed by the two pharmacies;

18 (c) Respondent Savon.Com and DailyMed California maintained separate inventories in the
19 two pharmacies;

20 (d) DailyMed California did not have a pharmacy license or a DEA registration, and
21 therefore did not have the required DEA 222 forms to fill out to purchase Schedule II controlled
22 substances. Respondents Savon.Com and Brown authorized DailyMed California and/or
23 DailyMed Pharmacy to establish a line of credit and order dangerous drugs and controlled
24 substances for DailyMed Pharmacy from five different wholesalers using Respondent
25 Savon.Com's pharmacy license and DEA number. These pharmaceutical drugs were shipped to
26 Respondent Savon.Com and billed to DailyMed Pharmacy in Indianapolis and its subsidiaries.
27 Respondents Brown and Savon.Com transferred these pharmaceutical drugs to DailyMed
28 California without any accompanying DEA 222 form authorizing the transfers;

1 (e) Respondent Savon.Com authorized DailyMed California to dispense the dangerous
2 drugs and controlled substances to patients in DailyMed California's labeled prescription
3 containers from Respondent Savon.Com's licensed facility;

4 (f) The prescriptions that DailyMed California processed at Respondent Savon.Com's
5 pharmacy were entered and retained at DailyMed Pharmacy in Indianapolis, and not in
6 California;

7 (g) Respondents Savon.Com and Brown endorsed DEA 222 forms without the quantity
8 received and the date;

9 (h) The CURES reporting by Respondent Savon.Com did not reflect the pharmaceutical
10 drugs dispensed by DailyMed California at Respondent Savon.Com's facility;

11 (i) Respondent Savon.Com received dangerous drugs and controlled substances in the
12 shipping and receiving section of Respondent Savon.Com's facility, transferred most of these
13 dangerous drugs and controlled substances to DailyMed California, who then shipped out the
14 dangerous drugs and controlled substances to fill mail order prescriptions from Respondent
15 Savon.Com's shipping and receiving location;

16 (j) Respondent Savon.Com did not maintain at its licensed facility the hard-copy
17 printouts for the refill prescriptions dispensed for Schedule III and Schedule IV controlled
18 substances for either Respondent Savon.Com or DailyMed California, the unlicensed pharmacy;

19 (k) Respondents Brown and Savon.Com did not document, by printing, verifying and/or
20 signing the record for the prescriptions they refilled within 72 hours;

21 (l) Respondent Savon.Com and Brown failed to maintain original prescriptions for the
22 Schedule II controlled substances dispensed through DailyMed California, the unlicensed
23 pharmacy, at Respondent SaveOn.com's licensed facility.

24 32. On March 8, 2011, the Board issued a cease and desist notice to DailyMed California
25 under Business and Professions Code section 4110 to stop conducting, operating, practicing, or
26 acting as a pharmacy without being licensed by the Board in the same suite as Respondent
27 Savon.Com located at 2510 El Camino Real, Suite A in Carlsbad.

28 ///

1 33. On March 8, 2011, the Board issued a written notice of violation to Respondent
2 Savon.Com for allowing DailyMed California to operate a pharmacy within Suite A at 2510 El
3 Camino Real, Suite A in Carlsbad when only one site license is permitted per premise.

4 **June 14, 2011 Inspection/Investigation**

5 34. On March 24, 2011, the Board received a complaint from a pharmacist alleging
6 DailyMed Pharmacy was using salesmen to enroll his pharmacy's patients into its pharmacy
7 bubble packing process.

8 35. On June 14, 2011, the Board conducted another compliance inspection and complaint
9 investigation of Respondent Savon.Com located at 2510 El Camino Real, Suite A in Carlsbad,
10 California together with an investigator from the California Department of Health Care Services,
11 and an agent from the Federal Bureau of Narcotic Enforcement.

12 36. On June 14, 2011, at the time of the inspection/investigation, Respondent Brown
13 continued to authorize the original prescription records for Schedule III, Schedule IV, and
14 Schedule V controlled substance prescriptions dispensed by Respondent Savon.Com to be
15 maintained by DailyMed Pharmacy in Indianapolis, and not in California where the drugs were
16 dispensed.

17 37. From January 1, 2010 to May 16, 2011, Respondent Brown and Respondent
18 Savon.Com failed to submit CURES reporting for either the prescriptions processed by DailyMed
19 Pharmacy in Indianapolis or the controlled substances dispensed at Respondent Savon.Com.

20 38. On June 14, 2011, Respondent Brown and Respondent Savon.Com did not include a
21 written notice to patients with all prescriptions dispensed of their right to consultation, and also
22 did not provide a consultation telephone number for a Respondent Savon.Com pharmacist in
23 Carlsbad, California with ready access to the patients' record.

24 39. On June 14, 2011, Respondent Brown and Respondent Savon.Com dispensed
25 prescriptions in boxed containers with shipping labels containing the name DailyMed California,
26 and with prescription strip labels containing DailyMed Pharmacy's name with DailyMed
27 California's address within Respondent Savon.Com.

28 ///

1 SECOND CAUSE FOR DISCIPLINE

2 (Unprofessional Conduct by Respondents Savon.Com and Brown –
3 Maintaining Prescription Records Out-Of-State)

4 45. Respondents Savon.Com and Brown are subject to disciplinary action for
5 unprofessional conduct under Code section 4301, subdivision (o), in that on November 15, 2010
6 and June 14, 2011, Respondents failed to maintain in California the hard copy, original
7 prescription records for prescriptions, including Schedule III and Schedule IV controlled
8 substances that Respondents Savon.Com and Brown dispensed to DailyMed California patients,
9 in violation of Code section 4081, subdivision (a) and section 4105, subdivision (d), as set forth
10 in paragraphs 27 to 43, which are incorporated here by this reference.

11 THIRD CAUSE FOR DISCIPLINE

12 (Unprofessional Conduct by Respondents Savon.Com and Brown –
13 Failing to Properly Verify and Maintain Prescription Records)

14 46. Respondents Savon.Com and Brown are subject to disciplinary action for
15 unprofessional conduct under Code section 4301, subsection (o), in that on November 15, 2010,
16 Respondents failed to properly print out, verify, date, sign and maintain prescription records for
17 refilled Schedule III and Schedule IV controlled substances in violation of CFR, title 21, 1306.22,
18 as set forth in paragraphs 27 to 43, which are incorporated here by this reference.

19 FOURTH CAUSE FOR DISCIPLINE

20 (Unprofessional Conduct by Respondents Savon.Com and Brown –
21 Aiding and Abetting the Illegal Wholesaling of Dangerous Drugs)

22 47. Respondents Savon.Com and Brown are subject to disciplinary action for
23 unprofessional conduct under Code section 4301, subsection (o), in that Respondents aided and
24 abetted the illegal wholesaling of dangerous drugs in violation of CCR, title 16, section 1783,
25 subdivision (d), as set forth in paragraphs 27 to 43, which are incorporated here by this reference.

26 ///

28 ///

1 FIFTH CAUSE FOR DISCIPLINE

2 (Unprofessional Conduct by Respondents Savon.Com and Brown –
3 Failure to Maintain Original Prescriptions for Controlled Substances)

4 48. Respondents Savon.Com and Brown are subject to disciplinary action for
5 unprofessional conduct under Code section 4301, subdivision (j), in that Respondents
6 failed to maintain original prescriptions for Schedule II controlled substances for at least 3 years
7 from the date of filling for prescription in violation of Health and Safety Code section 11179, as
8 set forth in paragraphs 27 to 43, which are incorporated here by this reference.

9 SIXTH CAUSE FOR DISCIPLINE

10 (Unprofessional Conduct by Respondents Savon.Com and Brown –
11 Failure to Submit CURES Data on Controlled Substances Dispensed)

12 49. Respondents Savon.Com and Brown are subject to disciplinary action for
13 unprofessional conduct under Code section 4301, subdivision (o), in that between January 1, 2010
14 to May 16, 2011, Respondents failed to submit CURES data for the Schedule II, Schedule III and
15 Schedule IV controlled substances dispensed in violation of Health and Safety Code Section
16 11165(d), as set forth in paragraphs 27 to 43, which are incorporated here by this reference.

17 SEVENTH CAUSE FOR DISCIPLINE

18 (Unprofessional Conduct by Respondents Savon.Com and Brown –
19 Authorizing the Dispensing of Controlled Substances Without a DEA Registration)

20 50. Respondents Savon.Com and Brown are subject to disciplinary action for
21 unprofessional conduct under Code section 4301, subsection (o), in that on November 16, 2010,
22 Respondents aided and abetted DailyMed California to dispense controlled substances at
23 Respondent Savon.Com's licensed facility without a separate DEA registration in violation of
24 CFR, title 21, section 1301.11, subdivision (a) and section 1301.12, subdivision (a), as set forth in
25 paragraphs 27 to 43, which are incorporated here by this reference.

26 ///

1 **EIGHTH CAUSE FOR DISCIPLINE**

2 **(Unprofessional Conduct by Respondents Savon.Com and Brown –**
3 **the Operation of an Unlicensed Pharmacy)**

4 51. Respondents Savon.Com and Brown are subject to disciplinary action for
5 unprofessional conduct under Code section 4301, subdivision (o), for the operation of DailyMed
6 California, an unlicensed pharmacy, at Respondent Savon.Com's licensed pharmacy location in

13 unprofessional conduct under Code section 4301, subsection (o), in that Respondents shipped
14 prescriptions without written notice informing patients of their right to consultation from a
15 pharmacist who had ready access their medical records, and failed to provide a telephone number
16 of a California pharmacist in violation of CCR, title 16, Section 1707.2, subdivision (b)(2), as set
17 forth in paragraphs 27 to 43, which are incorporated here by this reference.

18 **TENTH CAUSE FOR DISCIPLINE**

19 **(Unprofessional Conduct by Respondents Savon.Com and Brown –**
20 **Failing to Dispense Medications in Properly Labeled Containers)**

21 53. Respondents Savon.Com and Brown are subject to disciplinary action for
22 unprofessional conduct under Code section 4301, subdivision (o), in that Respondents dispensed
23 medications in improperly labeled containers, in violation of Code Section 4076, subdivision (a),
24 as set forth in paragraphs 27 to 43, which are incorporated here by this reference, and as follows:

25 a. Respondents shipped prescriptions with the name DailyMed California on the boxed
26 containers and shipping labels, and the name DailyMed Carlsbad on the prescription strip labels;

7 of Code section 4169, subdivision (a)(1), and without completing and retaining DEA Form 222 in
8 violation of CFR, title 21, section 1305.13, as set forth in paragraphs 27 to 43, which are
9 incorporated here by this reference.

10 **FOURTEENTH CAUSE FOR DISCIPLINE**

11 **(Unprofessional Conduct by Respondents Savon.Com and Brown –**
12 **Illegal Transfers of Schedule III, IV and V Controlled Substances)**

13 57. Respondents Savon.Com and Brown are subject to disciplinary action for
14 unprofessional conduct under Code section 4301, subdivisions (j) and (o) in that Respondents
15 transferred Schedule III, IV and V controlled substances to DailyMed California, an unlicensed
16 pharmacy, in violation of Code section 4169, subdivision (a)(1), and without maintaining records
17 concerning the number of commercial containers distributed, including the date of and number of
18 containers in each reduction from inventory, and the name, address, and registration number of
19 the person to whom the containers were distributed in violation of CFR, title 21, section 1304.22,
20 subdivision (a)(2)(vii), as set forth in paragraphs 27 to 43, which are incorporated here by this
21 reference.

22 **PRAYER**

23 **WHEREFORE**, Complainant requests that a hearing be held on the matters herein alleged,
24 and that following the hearing, the Board of Pharmacy issue a decision:



Dear Mr. Day:

On May 18, 2015, the Board of Pharmacy, Department of Consumer Affairs, State of California, filed Second Amended Accusation against New Albertson's, Inc.'s Pharmacy Permit No. PHY 48198. The Second Amended Accusation alleged that New Albertson's, Inc., a subsidiary of Supervalu, Inc. until March 21, 2013, and doing business as Savon.Com #5805, located at 2510 El Camino Real, Suite A, Carlsbad, CA 92008, engaged in unprofessional conduct as follows:

(1) under Business and Professions Code section 4301(j) and (o) on November 16, 2010, when it dispensed prescriptions in prescription containers in the name of DailyMed California in violation of Business and Professions Code section 4076(a)(6).

(2) under Business and Professions Code section 4301(o) on November 15, 2010 and June 14, 2011, when it failed to maintain in California the hard copy, original prescription records for prescriptions, including Schedule III and Schedule IV controlled substances that it dispensed to DailyMed California patients, in violation of Business and Professions Code section 4081(a) and section 4105(d);

(3) under Business and Professions Code section 4301(o) on November 15, 2010 when it failed to properly print out, verify, date, sign and maintain prescription records for refilled Schedule III and Schedule IV controlled substances in violation of Code of Federal Regulations, title 21, section 1306.22;

(4) under Business and Professions Code section 4301(o) when it aided and abetted the illegal wholesaling of dangerous drugs in violation of California Code of Regulations, title 16, section 1783(d);

(5) under Business and Professions Code section 4301(j) when it failed to maintain original prescriptions for Schedule II controlled substances for at least 3 years from the date of filling for prescription in violation of Health and Safety Code section 11179;

(6) under Business and Professions Code section 4301(o) when between January 1, 2010 to May 16, 2011, it failed to submit CURES data for the Schedule II, Schedule III and Schedule IV controlled substances dispensed in violation of Health and Safety Code section 11165(d);

(7) under Business and Professions Code section 4301(o) on November 16, 2010 when it aided and abetted DailyMed California to dispense controlled substances at Savon.Com #5805's licensed facility without a separate Drug Enforcement Agency registration in violation of Code of Federal Regulations, title 21, section 1301.11(a) and section 1301.12(a);

(8) under Business and Professions Code section 4301(o), for the operation of DailyMed California, an unlicensed pharmacy, at Savon.Com #5805's licensed pharmacy location in violation of Business and Professions Code section 4110(a);

(9) under Business and Professions Code section 4301(o), when it shipped prescriptions without written notice informing patients of their right to consultation from a pharmacist who had ready access their medical records, and failed to provide a telephone number of a California pharmacist in violation of California Code of Regulations, title 16, section 1707.2(b)(2);

(10) under Business and Professions Code section 4301 when it dispensed medications in improperly labeled containers, in violation of Business and Professions Code section 4076(a);

(11) under Business and Professions Code section 4301 when on June 14, 2011, it dispensed medications in non-child resistant packaging without proper authorization or warning, in violation of California Code of Regulations, title 16, section 1717(a), and Code of Federal Regulations, title 16, section 1701.1;

(12) under Business and Professions Code section 4301(f) when it engaged in acts involving moral turpitude, dishonesty, fraud, deceit, or corruption by illegally wholesaling dangerous drugs in violation of California Code of Regulations section 1783(d); and by illegally operating DailyMed California, an unlicensed pharmacy, at Savon.Com #5805's licensed pharmacy location in violation of Business and Professions Code section 4110(a);

(13) under Business and Professions Code section 4301(o), when it transferred Schedule II controlled substances to DailyMed California, an unlicensed pharmacy, in violation of Business and Professions Code section 4169(a)(1), and without completing and retaining Drug Enforcement Agency Form 222 in violation of Code of Federal Regulations, title 21, section 1305.13; and

(14) under Business and Professions Code section 4301(j) and (o), when it transferred Schedule III, IV and V controlled substances to DailyMed California, an unlicensed pharmacy, in violation of section 4169(a)(1), and without maintaining records concerning the number of commercial containers distributed, including the date of and number of containers in each reduction from inventory, and the name, address, and registration number of the person to whom the containers were distributed in violation of Code of Federal Regulations, title 21, section 1304.22(a)(2)(vii).

As Savon.Com #5805's authorized representative, you agreed that the charges and allegations in Second Amended Accusation No. 4143, if proven at a hearing, constituted cause for imposing discipline upon Pharmacy Permit No. PHY 48198. You agreed that at a hearing Complainant could establish a factual basis for the charges in the Second Amended Accusation, and gave up Respondent's right to contest those charges. Finally, on behalf of Respondent, you agreed that Respondent's Pharmacy Permit No. PHY 48198 was subject to discipline, and agreed to be bound by the Board's Disciplinary Order.

Accordingly, in resolution of this matter under the authority provided under Business and Professions Code section 495, the Board of Pharmacy, Department of Consumer Affairs issues this letter of public reproof.
