**DEFAULT DECISION AND ORDER**

[Gov. Code, § 11520]

**FINDINGS OF FACT**

1. On or about August 8, 2013, Complainant Virginia K. Herold, in her official capacity as the Executive Officer of the Board of Pharmacy, Department of Consumer Affairs, filed Petition to Revoke Probation No. 4542 against Jerrell Andre Scott (Respondent) before the Board of Pharmacy. (The Petition to Revoke Probation attached as Exhibit A.)
2. On or about April 23, 2012, the Board of Pharmacy (Board) issued Pharmacy Technician Registration No. TCH 95574 to Respondent. The Pharmacy Technician Registration expired on September 20, 2012, and has not been renewed.
3. On or about August 22, 2013, Respondent was served with a copy of the Petition to Revoke Probation No. 4542, Statement to Respondent, Notice of Defense, Request for Discovery,

1 Respondent's address of record which, pursuant to Business and Professions Code section 4100  
2 and California Code of Regulations, title 16, section 1704, is required to be reported and  
3 maintained with the Board. Respondent's address of record was and is:

4 68790 Panorama Drive  
5 Desert Hot Springs, CA 92240

6 4. Service of the Petition to Revoke Probation was effective as a matter of law under the  
7 provisions of Government Code section 11505, subdivision (c) and/or Business & Professions  
8 Code section 124.

9 5. On or about August 24, 2013, the Domestic Return Receipt for the documents served  
10 by Certified Mail was signed acknowledging delivery.

11 6. Government Code section 11506 states, in pertinent part:

12 (c) The respondent shall be entitled to a hearing on the merits if the respondent  
13 files a notice of defense, and the notice shall be deemed a specific denial of all parts  
14 of the accusation not expressly admitted. Failure to file a notice of defense shall  
constitute a waiver of respondent's right to a hearing, but the agency in its discretion  
may nevertheless grant a hearing.

15 7. Respondent failed to file a Notice of Defense within 15 days after service upon him  
16 of the Petition to Revoke Probation, and therefore waived his right to a hearing on the merits of  
17 Petition to Revoke Probation No. 4542.

18 8. California Government Code section 11520 states, in pertinent part:

19 (a) If the respondent either fails to file a notice of defense or to appear at the  
20 hearing, the agency may take action based upon the respondent's express admissions  
or upon other evidence and affidavits may be used as evidence without any notice to  
21 respondent.

22 9. Pursuant to its authority under Government Code section 11520, the Board finds  
23 Respondent is in default. The Board will take action without further hearing and, based on the  
24 relevant evidence contained in the Default Decision Investigatory Evidence Packet in this matter,  
25 as well as taking official notice of all the investigatory reports, exhibits and statements contained  
26 therein on file at the Board's offices regarding the allegations contained in Petition to Revoke  
27 Probation No. 4542, finds that the charges and allegations in Petition to Revoke Probation No.  
28 4542 are separately and severally, found to be true and correct by clear and convincing evidence.

1 **DETERMINATION OF ISSUES**

2 1. Based on the foregoing findings of fact, Respondent Jerrell Andre Scott has subjected  
3 his Pharmacy Technician Registration No. TCH 95574 to discipline.

4 2. The agency has jurisdiction to adjudicate this case by default.

5 3. The Board of Pharmacy is authorized to revoke Respondent's Pharmacy Technician  
6 Registration based upon the following violations alleged in the Petition to Revoke Probation  
7 which are supported by the Default Decision Investigatory Evidence Packet in this case.

8 a. Respondent's probation is subject to revocation because he failed to comply  
9 with Probation Condition 3 in that Respondent did not file any Quarterly Reports.

10 b. Respondent's probation is subject to revocation because he failed to comply  
11 with Probation Condition 8 in that he allowed his pharmacy technician registration to expire on  
12 September 20, 2012.

13 c. Respondent's probation is subject to revocation because he failed to comply  
14 with Probation Condition 14 in that on multiple occasions, he failed to make daily check-ins with  
15 the contracted drug testing vendor or submit to random drug screening.

16 d. Respondent's probation is subject to revocation because he failed to comply  
17 with Probation Condition 15 in that he failed to submit proof of attendance in a substance abuse  
18 recovery group.

19 e. Respondent's probation is subject to revocation because he failed to comply  
20 with Probation Condition 19 in that he failed to submit a community service program for Board  
21 approval.

**ORDER**



20 **PARTIES**

21 1. Virginia Herold (Complainant) brings this Petition to Revoke Probation solely in her  
22 official capacity as the Executive Officer of the Board of Pharmacy, Department of Consumer  
23 Affairs.

24 2. On or about April 23, 2012, the Board of Pharmacy issued Pharmacy Technician  
25 Registration Number TCH 95574 to Jerrell Andre Scott (Respondent). Pursuant to Family Code  
26 section 17520, Respondent was issued a temporary 30/150 day license. The Pharmacy  
27 Technician Registration expired on September 20, 2012, and has not been renewed.

28 ///







1 times Respondent shall fully cooperate with the Board or its designee, and shall,  
2 when directed, submit to such tests and samples for the detection of alcohol,  
3 narcotics, hypnotics, dangerous drugs or other controlled substances as the Board or  
4 its designee may direct. Failure to timely submit to testing as directed shall be  
5 considered a violation of probation. Upon request of the Board or its designee,  
6 Respondent shall provide documentation from a licensed practitioner that the  
7 prescription for a detected drug was legitimately issued and is a necessary part of the  
8 treatment of the Respondent. Failure to timely provide such documentation shall be  
9 considered a violation of probation. Any confirmed positive test for alcohol or for  
10 any drug not lawfully prescribed by a licensed practitioner as part of a documented  
11 medical treatment shall be considered a violation of probation and shall result in the  
12 automatic suspension of work by Respondent. Respondent may not resume work as a  
13 pharmacy technician until notified by the Board in writing.

8 During suspension, Respondent shall not enter any pharmacy area or any  
9 portion of or any other Board licensed premises (wholesaler, veterinary food-animal  
10 drug retailer or any other distributor of drugs) any drug manufacturer, or any other  
11 location where dangerous drugs and devices or controlled substances are maintained.  
12 Respondent shall not do any act involving drug selection, selection of stock,  
13 manufacturing, compounding or dispensing; nor shall Respondent manage,  
14 administer, or assist any licensee of the Board. Respondent shall not have access to  
15 or control the ordering, manufacturing or dispensing of dangerous drugs and devices  
16 or controlled substances. Respondent shall not resume work until notified by the  
17 Board.

14 Respondent shall not direct, control or perform any aspect of the practice of  
15 pharmacy. Subject to the above restrictions, Respondent may continue to own or  
16 hold an interest in any licensed premises in which he holds an interest at the time this  
17 decision becomes effective unless otherwise specified in this order.

16 Failure to comply with this suspension shall be considered a violation of  
17 probation.

18 12. Respondent's probation is subject to revocation because he failed to comply with  
19 Probation Condition 14, referenced above, in that he failed to make daily check-ins with the  
20 contracted drug testing vendor on April 25, 2012 through May 2, 2012, May 5, 2012, July 4,  
21 2012, and July 12, 2012 to the present. Respondent further failed to submit to random drug  
22 screening on May 1, 2012, July 12, 2012, July 20, 2102, July 23, 2012, July 31, 2012, August 8,  
23 2012, August 14, 2012, August 22, 2012, August 23, 2012, September 4, 2012, and September  
24 10, 2012.

1 **FOURTH CAUSE TO REVOKE PROBATION**

2 **(Attend Substance Abuse Recovery Relapse Prevention and Support Groups)**

3 13. At all times after the effective date of Respondent's probation, Condition 15 stated:

4 Should Respondent test positive for alcohol, dangerous drugs or other  
5 controlled substances during a random drug screening, Respondent shall begin  
6 regular attendance at a recognized and established substance abuse recovery support  
7 group in California, (e.g., Alcoholics Anonymous, Narcotics Anonymous, etc.) which  
8 has been approved by the Board or its designee. Respondent must attend at least one  
9 group meeting per week unless otherwise directed by the Board or its designee.  
10 Respondent shall continue regular attendance and submit signed and dated  
11 documentation confirming attendance with each quarterly report for the duration of  
12 probation. Failure to attend or submit documentation thereof shall be considered a  
13 violation of probation.

14 14. Respondent's probation is subject to revocation because he failed to comply with  
15 Probation Condition 15, referenced above, in that Respondent failed to submit proof of attendance  
16 in a substance abuse recovery group.

17 **FIFTH CAUSE TO REVOKE PROBATION**

18 **(Community Services Program)**

19 15. At all times after the effective date of Respondent's probation, Condition 19 stated:

20 Within sixty (60) days of the effective date of this decision, Respondent shall  
21 submit to the Board or its designee, for prior approval, a community service program  
22 in which Respondent shall provide free health-care related services on a regular basis  
23 to a community or charitable facility or agency for at least 25 hours per year for the  
24 first two years of probation. Within thirty (30) days of Board approval thereof,  
25 Respondent shall submit documentation to the Board demonstrating commencement  
26 of the community service program. A record of this notification must be provided to  
27 the Board upon request. Respondent shall report on progress with the community  
28 service program in the quarterly reports. Failure to timely submit, commence, or  
comply with the program shall be considered a violation of probation.

16 16. Respondent's probation is subject to revocation because he failed to comply with  
17 Probation Condition 19, referenced above, in that he failed to submit a community service  
18 program for Board approval.


2 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,



**STIPULATED SETTLEMENT AND  
DISCIPLINARY ORDER**

17 IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-  
18 entitled proceedings that the following matters are true:

19 **PARTIES**

20 1. Virginia Herold (Complainant) is the Executive Officer of the Board of Pharmacy.  
21 She brought this action solely in her official capacity and is represented in this matter by Kamala  
22 D. Harris, Attorney General of the State of California, by Amanda Dodds, Senior Legal Analyst.

23 2. Jerrell Andre Scott (Respondent) is representing himself in this proceeding and has  
24 chosen not to exercise his right to be represented by counsel.

25 3. On or about August 18, 2009, Respondent filed an application dated August 13, 2009,  
26 with the Board of Pharmacy to obtain a Pharmacy Technician Registration.

**JURISDICTION**

4. Statement of Issues No. 4000 was filed before the Board of Pharmacy (Board), Department of Consumer Affairs, and is currently pending against Respondent. The Statement of Issues and all other statutorily required documents were properly served on Respondent on June 28, 2011. A copy of Statement of Issues No. 4000 is attached as Exhibit A and incorporated herein by reference.

**ADVISEMENT AND WAIVERS**

5. Respondent has carefully read, and understands the charges and allegations in Statement of Issues No. 4000. Respondent has also carefully read, and understands the effects of this Stipulated Settlement and Disciplinary Order.

6. Respondent is fully aware of his legal rights in this matter, including the right to a hearing on the charges and allegations in the Statement of Issues; the right to be represented by counsel at his own expense; the right to confront and cross-examine the witnesses against him; the right to present evidence and to testify on his own behalf; the right to the issuance of subpoenas to compel the attendance of witnesses and the production of documents; the right to reconsideration and court review of an adverse decision; and all other rights accorded by the California Administrative Procedure Act and other applicable laws.

7. Respondent voluntarily, knowingly, and intelligently waives and gives up each and every right set forth above.

**CULPABILITY**

8. Respondent admits the truth of each and every charge and allegation in Statement of Issues No. 4000.

9. Respondent agrees that his Pharmacy Technician Registration is subject to denial and he agrees to be bound by the Board's probationary terms as set forth in the Disciplinary Order below.

**CONTINGENCY**

10. This stipulation shall be subject to approval by the Board of Pharmacy. Respondent understands and agrees that counsel for Complainant and the staff of the Board of Pharmacy may

1 communicate directly with the Board regarding this stipulation and settlement, without notice to  
2 or participation by Respondent. By signing the stipulation, Respondent understands and agrees  
3 that he may not withdraw his agreement or seek to rescind the stipulation prior to the time the  
4 Board considers and acts upon it. If the Board fails to adopt this stipulation as its Decision and  
5 Order, the Stipulated Settlement and Disciplinary Order shall be of no force or effect, except for  
6 this paragraph, it shall be inadmissible in any legal action between the parties, and the Board shall  
7 not be disqualified from further action by having considered this matter.

8 11. The parties understand and agree that facsimile copies of this Stipulated Settlement  
9 and Disciplinary Order, including facsimile signatures thereto, shall have the same force and  
10 effect as the originals.

11 12. This Stipulated Settlement and Disciplinary Order is intended by the parties to be an  
12 integrated writing representing the complete, final, and exclusive embodiment of their agreement.  
13 It supersedes any and all prior or contemporaneous agreements, understandings, discussions,  
14 negotiations, and commitments (written or oral). This Stipulated Settlement and Disciplinary  
15 Order may not be altered, amended, modified, supplemented, or otherwise changed except by a  
16 writing executed by an authorized representative of each of the parties.

17 13. In consideration of the foregoing admissions and stipulations, the parties agree that  
18 the Board may, without further notice or formal proceeding, issue and enter the following  
19 Disciplinary Order:

20 **DISCIPLINARY ORDER**

21 ~~IT IS HEREBY ORDERED~~ that upon satisfaction of all statutory and regulatory  
22 requirements for issuance of a license, a license shall be issued to Respondent Jerrell Andre Scott  
23 and immediately revoked; the order of revocation is stayed and Respondent is placed on  
24 probation for three (3) years upon the following terms and conditions:

25 1. **Certification Prior to Resuming Work**

26 Respondent shall be automatically suspended from working as a pharmacy technician until  
27 he is certified as defined by Business and Professions Code section 4202(a)(4) and provides  
28 satisfactory proof of certification to the Board. Respondent shall not resume working as a



1 pharmacy technician until notified by the Board. Failure to achieve certification within one (1)  
2 year shall be considered a violation of probation. Respondent shall not resume working as a  
3 pharmacy technician until notified by the Board.

4 During suspension, Respondent shall not enter any pharmacy area or any portion of any  
5 other Board licensed premises (wholesaler, veterinary food-animal drug retailer or any other  
6 distributor of drugs) any drug manufacturer, or any other location where dangerous drugs and  
7 devices or controlled substances are maintained. Respondent shall not do any act involving drug  
8 selection, selection of stock, manufacturing, compounding or dispensing; nor shall Respondent  
9 manage, administer, or assist any licensee of the Board. Respondent shall not have access to or  
10 control the ordering, manufacturing or dispensing of dangerous drugs and devices or controlled  
11 substances. Respondent shall not resume work until notified by the Board.

12 Subject to the above restrictions, Respondent may continue to own or hold an interest in  
13 any licensed premises by the Board in which he holds an interest at the time this decision  
14 becomes effective unless otherwise specified in this order.

15 Failure to comply with this suspension shall be considered a violation of probation.

16 **2. Obey All Laws**

17 Respondent shall obey all state and federal laws and regulations.

18 Respondent shall report any of the following occurrences to the Board, in writing, within  
19 seventy-two (72) hours of such occurrence:

- 20  an arrest or issuance of a criminal complaint for violation of any provision of the  
21 Pharmacy Law, state and federal food and drug laws, or state and federal controlled  
22 substances laws  
23  a plea of guilty or nolo contendere in any state or federal criminal proceeding to any  
24 criminal complaint, information or indictment  
25  a conviction of any crime  
26  discipline, citation, or other administrative action filed by any state or federal agency  
27 which involves Respondent's pharmacy technician license or which is related to the  
28 practice of pharmacy or the manufacturing, obtaining, handling, distributing, billing,  
or charging for any drug, device or controlled substance.

Failure to timely report any such occurrence shall be considered a violation of probation.

1           3.    **Report to the Board**

2           Respondent shall report to the Board quarterly, on a schedule as directed by the Board or its  
3   designee. The report shall be made either in person or in writing, as directed. Among other  
4   requirements, Respondent shall state in each report under penalty of perjury whether there has  
5   been compliance with all the terms and conditions of probation. Failure to submit timely reports  
6   in a form as directed shall be considered a violation of probation. Any period(s) of delinquency  
7   in submission of reports as directed may be added to the total period of probation. Moreover, if  
8   the final probation report is not made as directed, probation shall be automatically extended until  
9   such time as the final report is made and accepted by the Board.

10          4.    **Interview with the Board**

11          Upon receipt of reasonable prior notice, Respondent shall appear in person for interviews  
12   with the Board or its designee, at such intervals and locations as are determined by the Board or  
13   its designee. Failure to appear for any scheduled interview without prior notification to Board  
14   staff, or failure to appear at two (2) or more scheduled interviews with the Board or its designee  
15   during the period of probation, shall be considered a violation of probation.

16          5.    **Cooperate with Board Staff**

17          Respondent shall cooperate with the Board's inspection program and with the Board's  
18   monitoring and investigation of Respondent's compliance with the terms and conditions of his  
19   probation. Failure to cooperate shall be considered a violation of probation.

20          6.    **Notice to Employers**

21          During the period of probation, Respondent shall notify all present and prospective  
22   employers of the decision in case number 4000 and the terms, conditions and restrictions imposed  
23   on Respondent by the decision, as follows:

24          Within thirty (30) days of the effective date of this decision, and within fifteen (15) days of  
25   Respondent undertaking any new employment, Respondent shall cause his direct supervisor,  
26   pharmacist-in-charge (including each new pharmacist-in-charge employed during Respondent's  
27   tenure of employment) and owner to report to the Board in writing acknowledging that the listed  
28   individual(s) has/have read the decision in case number 4000 and the terms and conditions

1 imposed thereby. It shall be Respondent's responsibility to ensure that his employer(s) and/or  
2 supervisor(s) submit timely acknowledgement(s) to the Board.

3 If Respondent works for or is employed by or through a pharmacy employment service,  
4 Respondent must notify his direct supervisor, pharmacist-in-charge and owner at every pharmacy  
5 of the terms and conditions of the decision in case number 4000 in advance of the Respondent  
6 commencing work at each pharmacy. A record of this notification must be provided to the Board  
7 upon request.

8 Furthermore, within thirty (30) days of the effective date of this decision, and within fifteen  
9 (15) days of Respondent undertaking any new employment by or through a pharmacy  
10 employment service, Respondent shall cause his direct supervisor with the pharmacy employment  
11 service to report to the Board in writing acknowledging that he has read the decision in case  
12 number 4000 and the terms and conditions imposed thereby. It shall be Respondent's  
13 responsibility to ensure that his employer(s) and/or supervisor(s) submit timely  
14 acknowledgment(s) to the Board.

15 Failure to timely notify present or prospective employer(s) or to cause that/those  
16 employer(s) to submit timely acknowledgements to the Board shall be considered a violation of  
17 probation.

18 "Employment" within the meaning of this provision shall include any full-time,  
19 part-time, temporary or relief service or pharmacy management service as a pharmacy  
20 technician or in any position for which a pharmacy technician license is a requirement  
21 or criterion for employment, whether the Respondent is considered an employee,  
22 independent contractor or volunteer.

### 23 7. Probation Monitoring Costs

24 Respondent shall pay any costs associated with probation monitoring as determined by the  
25 Board each and every year of probation. Such costs shall be payable to the Board on a schedule  
26 as directed by the Board or its designee. Failure to pay such costs by the deadline(s) as directed  
27 shall be considered a violation of probation.

28 ///

1           8.     **Status of License**

2           Respondent shall, at all times while on probation, maintain an active, current pharmacy  
3 technician license with the Board, including any period during which suspension or probation is  
4 tolled. Failure to maintain an active, current license shall be considered a violation of probation.

5           If Respondent's pharmacy technician license expires or is cancelled by operation of law or  
6 otherwise at any time during the period of probation, including any extensions thereof due to  
7 tolling or otherwise, upon renewal or reapplication Respondent's license shall be subject to all  
8 terms and conditions of this probation not previously satisfied.

9           9.     **License Surrender While on Probation/Suspension**

10          Following the effective date of this decision, should Respondent cease work due to  
11 retirement or health, or be otherwise unable to satisfy the terms and conditions of probation,  
12 Respondent may tender his pharmacy technician license to the Board for surrender. The Board or  
13 its designee shall have the discretion whether to grant the request for surrender or take any other  
14 action it deems appropriate and reasonable. Upon formal acceptance of the surrender of the  
15 license, Respondent will no longer be subject to the terms and conditions of probation. This  
16 surrender constitutes a record of discipline and shall become a part of the Respondent's license  
17 history with the Board.

18          Upon acceptance of the surrender, Respondent shall relinquish his pharmacy technician  
19 license to the Board within ten (10) days of notification by the Board that the surrender is  
20 accepted. Respondent may not reapply for any license, permit, or registration from the Board for  
21 ~~three (3) years from the effective date of the surrender.~~ Respondent shall meet all requirements  
22 applicable to the license sought as of the date the application for that license is submitted to the  
23 Board.

24          10.   **Notification of a Change in Name, Residence Address, Mailing Address or**  
25 **Employment**

26          Respondent shall notify the Board in writing within ten (10) days of any change of  
27 employment. Said notification shall include the reasons for leaving, the address of the new  
28 employer, the name of the supervisor and owner, and the work schedule if known. Respondent

1 shall further notify the Board in writing within ten (10) days of a change in name, residence  
2 address and mailing address, or phone number.

3 Failure to timely notify the Board of any change in employer(s), name(s), address(es), or  
4 phone number(s) shall be considered a violation of probation.

#### 5 11. Tolling of Probation

6 Except during periods of suspension, Respondent shall, at all times while on probation, be  
7 employed as a pharmacy technician in California for a minimum of fifteen (15) hours per  
8 calendar month. Any month during which this minimum is not met shall toll the period of  
9 probation, i.e., the period of probation shall be extended by one month for each month during  
10 which this minimum is not met. During any such period of tolling of probation, Respondent must  
11 nonetheless comply with all terms and conditions of probation.

12 Should Respondent, regardless of residency, for any reason (including vacation) cease  
13 working as a pharmacy technician for a minimum of 15 hours per calendar month in California,  
14 Respondent must notify the Board in writing within ten (10) days of cessation of work and must  
15 further notify the Board in writing within ten (10) days of the resumption of the work. Any  
16 failure to provide such notification(s) shall be considered a violation of probation.

17 It is a violation of probation for Respondent's probation to remain tolled pursuant to the  
18 provisions of this condition for a total period, counting consecutive and non-consecutive months,  
19 exceeding thirty-six (36) months.

20 "Cessation of work" means calendar month during which Respondent is not  
21 working for at least fifteen (15) hours as a pharmacy technician, as defined in  
22 Business and Professions Code section 4115. "Resumption of work" means any  
23 calendar month during which Respondent is working as a pharmacy technician for at  
24 least fifteen (15) hours as a pharmacy technician as defined by Business and  
25 Professions Code section 4115.

#### 26 12. No Ownership of Licensed Premises

27 Respondent shall not own, have any legal or beneficial interest in, or serve as a manager,  
28 administrator, member, officer, director, trustee, associate, or partner of any business, firm,

1 partnership, or corporation currently or hereinafter licensed by the Board. Respondent shall sell  
2 or transfer any legal or beneficial interest in any entity licensed by the Board within ninety (90)  
3 days following the effective date of this decision and shall immediately thereafter provide written  
4 proof thereof to the Board. Failure to timely divest any legal or beneficial interest(s) or provide  
5 documentation thereof shall be considered a violation of probation.

6 **13. Abstain from Drugs and Alcohol Use**

7 Respondent shall completely abstain from the possession or use of alcohol, controlled  
8 substances, dangerous drugs and their associated paraphernalia except when the drugs are  
9 lawfully prescribed by a licensed practitioner as part of a documented medical treatment. Upon  
10 request of the Board or its designee, Respondent shall provide documentation from the licensed  
11 practitioner that the prescription for the drug was legitimately issued and is a necessary part of the  
12 treatment of the Respondent. Failure to timely provide such documentation shall be considered a  
13 violation of probation. Respondent shall ensure that he is not in the same physical location as  
14 individuals who are using illicit substances even if Respondent is not personally ingesting the  
15 drugs. Any possession or use of alcohol, controlled substances, or their associated paraphernalia  
16 not supported by the documentation timely provided, and/or any physical proximity to persons  
17 using illicit substances, shall be considered a violation of probation.

18 **14. Random Drug Screening**

19 Respondent, at his own expense, shall participate in random testing, including but not  
20 limited to biological fluid testing (urine, blood), breathalyzer, hair follicle testing, or other drug  
21 screening program as directed by the Board or its designee. Respondent may be required to  
22 participate in testing for the entire probation period and the frequency of testing will be  
23 determined by the Board or its designee. At all times Respondent shall fully cooperate with the  
24 Board or its designee, and shall, when directed, submit to such tests and samples for the detection  
25 of alcohol, narcotics, hypnotics, dangerous drugs or other controlled substances as the Board or  
26 its designee may direct. Failure to timely submit to testing as directed shall be considered a  
27 violation of probation. Upon request of the Board or its designee, Respondent shall provide  
28 documentation from a licensed practitioner that the prescription for a detected drug was

1 legitimately issued and is a necessary part of the treatment of the Respondent. Failure to timely  
2 provide such documentation shall be considered a violation of probation. Any confirmed positive  
3 test for alcohol or for any drug not lawfully prescribed by a licensed practitioner as part of a  
4 documented medical treatment shall be considered a violation of probation and shall result in the  
5 automatic suspension of work by Respondent. Respondent may not resume work as a pharmacy  
6 technician until notified by the Board in writing.

7 During suspension, Respondent shall not enter any pharmacy area or any portion of or any  
8 other Board licensed premises (wholesaler, veterinary food-animal drug retailer or any other  
9 distributor of drugs) any drug manufacturer, or any other location where dangerous drugs and  
10 devices or controlled substances are maintained. Respondent shall not do any act involving drug  
11 selection, selection of stock, manufacturing, compounding or dispensing; nor shall Respondent  
12 manage, administer, or assist any licensee of the Board. Respondent shall not have access to or  
13 control the ordering, manufacturing or dispensing of dangerous drugs and devices or controlled  
14 substances. Respondent shall not resume work until notified by the Board.

15 Respondent shall not direct, control or perform any aspect of the practice of pharmacy.  
16 Subject to the above restrictions, Respondent may continue to own or hold an interest in any  
17 licensed premises in which he holds an interest at the time this decision becomes effective unless  
18 otherwise specified in this order.

19 Failure to comply with this suspension shall be considered a violation of probation.

20 **15. Attend Substance Abuse Recovery Relapse Prevention and Support Groups**

21 Should Respondent test positive for alcohol, dangerous drugs or other controlled substances  
22 during a random drug screening, Respondent shall begin regular attendance at a recognized and  
23 established substance abuse recovery support group in California, (e.g., Alcoholics Anonymous,  
24 Narcotics Anonymous, etc.) which has been approved by the Board or its designee. Respondent  
25 must attend at least one group meeting per week unless otherwise directed by the Board or its  
26 designee. Respondent shall continue regular attendance and submit signed and dated  
27 documentation confirming attendance with each quarterly report for the duration of probation.  
28 Failure to attend or submit documentation thereof shall be considered a violation of probation.

1           16.   **Work Site Monitor**

2           Within ten (10) days of the effective date of this decision, Respondent shall identify a work  
3 site monitor, for prior approval by the Board, who shall be responsible for supervising  
4 Respondent during working hours. Respondent shall be responsible for ensuring that the work  
5 site monitor reports in writing to the Board quarterly. Should the designated work site monitor  
6 determine at any time during the probationary period that Respondent has not maintained  
7 sobriety, he shall notify the Board immediately, either orally or in writing as directed. Should  
8 Respondent change employment, a new work site monitor must be designated, for prior approval  
9 by the Board, within ten (10) days of commencing new employment. Failure to identify an  
10 acceptable initial or replacement work site monitor, or to ensure quarterly reports are submitted to  
11 the Board, shall be considered a violation of probation.

12           17.   **Notification of Departure**

13           Prior to leaving the probationary geographic area designated by the Board or its designee  
14 for a period greater than twenty-four (24) hours, Respondent shall notify the Board verbally and  
15 in writing of the dates of departure and return. Failure to comply with this provision shall be  
16 considered a violation of probation.

17           18.   **Tolling of Suspension**

18           During the period of suspension, Respondent shall not leave California for any period  
19 exceeding ten (10) days, regardless of purpose (including vacation). Any such absence in excess  
20 of ten (10) days during suspension shall be considered a violation of probation. Moreover, any  
21 absence from California during the period of suspension exceeding ten (10) days shall toll the  
22 suspension, i.e., the suspension shall be extended by one day for each day over ten (10) days  
23 Respondent is absent from California. During any such period of tolling of suspension,  
24 Respondent must nonetheless comply with all terms and conditions of probation.

25           Respondent must notify the Board in writing within ten (10) days of departure, and must  
26 further notify the Board in writing within ten (10) days of return. The failure to provide such  
27 notification(s) shall constitute a violation of probation. Upon such departure and return,  
28 Respondent shall not return to work until notified by the Board that the period of suspension has



1 been satisfactorily completed.

2 19. **Community Services Program**

3 Within sixty (60) days of the effective date of this decision, Respondent shall submit to the  
4 Board or its designee, for prior approval, a community service program in which Respondent  
5 shall provide free health-care related services on a regular basis to a community or charitable  
6 facility or agency for at least 25 hours per year for the first two years of probation. Within thirty  
7 (30) days of Board approval thereof, Respondent shall submit documentation to the Board  
8 demonstrating commencement of the community service program. A record of this notification  
9 must be provided to the Board upon request. Respondent shall report on progress with the  
10 community service program in the quarterly reports. Failure to timely submit, commence, or  
11 comply with the program shall be considered a violation of probation.

12 20. **Violation of Probation**

13 If a Respondent has not complied with any term or condition of probation, the Board shall  
14 have continuing jurisdiction over Respondent, and probation shall automatically be extended,  
15 until all terms and conditions have been satisfied or the Board has taken other action as deemed  
16 appropriate to treat the failure to comply as a violation of probation, to terminate probation, and  
17 to impose the penalty that was stayed.

18 If Respondent violates probation in any respect, the Board, after giving Respondent notice  
19 and an opportunity to be heard, may revoke probation and carry out the disciplinary order that  
20 was stayed. Notice and opportunity to be heard are not required for those provisions stating that a  
21 violation thereof may lead to automatic termination of the stay and/or revocation of the license. If  
22 a petition to revoke probation or an accusation is filed against Respondent during probation, the  
23 Board shall have continuing jurisdiction, and the period of probation shall be automatically  
24 extended until the petition to revoke probation or accusation is heard and decided.

25 21. **Completion of Probation**

26 Upon written notice by the Board indicating successful completion of probation,  
27 Respondent's pharmacy technician license will be fully restored.



18 **PARTIES**

19 1. Virginia Herold (Complainant) brings this Statement of Issues solely in her official  
20 capacity as the Executive Officer of the Board of Pharmacy, Department of Consumer Affairs.  
21 2. On or about August 18, 2009, the Board of Pharmacy, Department of Consumer  
22 Affairs received an application for a Pharmacy Technician Registration from Jerrell Andre Scott  
23 (Respondent). On or about August 13, 2009, Jerrell Andre Scott certified under penalty of  
24 perjury to the truthfulness of all statements, answers, and representations in the application. The  
25 Board denied the application on October 18, 2010.

1 JURISDICTION

2 3. This Statement of Issues is brought before the Board of Pharmacy (Board),  
3 Department of Consumer Affairs, under the authority of the following laws. All section  
4 references are to the Business and Professions Code (Code) unless otherwise indicated.

5 4. Section 4300, subdivision (c) of the Code states, in pertinent part, that the Board may  
6 refuse a license to any applicant guilty of unprofessional conduct.

7 5. Section 475 of the Code states:

8 (a) Notwithstanding any other provisions of this code, the provisions of this  
9 division shall govern the denial of licenses on the grounds of:

10 (1) Knowingly making a false statement of material fact, or knowingly  
11 omitting to state a material fact, in an application for a license.

12 (2) Conviction of a crime.

13 (3) Commission of any act involving dishonesty, fraud or deceit with the  
14 intent to substantially benefit himself or another, or substantially injure another.

15 (4) Commission of any act which, if done by a licentiate of the business or  
16 profession in question, would be grounds for suspension or revocation of license.

17 . . . .

18 STATUTORY PROVISIONS

19 6. Section 480 states, in pertinent part:

20 (a) A board may deny a license regulated by this code on the grounds that the  
21 applicant has one of the following:

22 (1) Been convicted of a crime. A conviction within the meaning of this  
23 section means a plea or verdict of guilty or a conviction following a plea of nolo  
24 contendere. Any action that a board is permitted to take following the establishment  
25 of a conviction may be taken when the time for appeal has elapsed, or the judgment  
26 of conviction has been affirmed on appeal, or when an order granting probation is  
27 made suspending the imposition of sentence, irrespective of a subsequent order under  
28 the provisions of Section 1203.4 of the Penal Code.

(2) Done any act involving dishonesty, fraud or deceit with the intent to  
substantially benefit himself or herself or another, or substantially injure another.

(3)(A) Done any act which if done by a licentiate of the business or profession  
in question, would be grounds for suspension or revocation of license.

(B) The board may deny a license pursuant to this subdivision only if the  
crime or act is substantially related to the qualifications, functions or duties of the  
business or profession for which application is made. . . .

7. Section 482 of the Code states:

Each board under the provisions of this code shall develop criteria to evaluate the rehabilitation of a person when:

- (a) Considering the denial of a license by the board under Section 480; or
- (b) Considering suspension or revocation of a license under Section 490.

Each board shall take into account all competent evidence of rehabilitation furnished by the applicant or licensee.

8. Section 4301 of the Code states:

The board shall take action against any holder of a license who is guilty of unprofessional conduct or whose license has been procured by fraud or misrepresentation or issued by mistake. Unprofessional conduct shall include, but is not limited to, any of the following:

.....  
(j) The violation of any of the statutes of this state, or any other state, or of the United States regulating controlled substances and dangerous drugs.

.....  
(l) The conviction of a crime substantially related to the qualifications, functions, and duties of a licensee under this chapter. The record of conviction of a violation of Chapter 13 (commencing with Section 801) of Title 21 of the United States Code regulating controlled substances or of a violation of the statutes of this state regulating controlled substances or dangerous drugs shall be conclusive evidence of unprofessional conduct. In all other cases, the record of conviction shall be conclusive evidence only of the fact that the conviction occurred. The board may inquire into the circumstances surrounding the commission of the crime, in order to fix the degree of discipline or, in the case of a conviction not involving controlled substances or dangerous drugs, to determine if the conviction is of an offense substantially related to the qualifications, functions, and duties of a licensee under this chapter. A plea or verdict of guilty or a conviction following a plea of nolo contendere is deemed to be a conviction within the meaning of this provision. The board may take action when the time for appeal has elapsed, or the judgment of conviction has been affirmed on appeal or when an order granting probation is made suspending the imposition of sentence, irrespective of a subsequent order under Section 1203.4 of the Penal Code allowing the person to withdraw his or her plea of guilty and to enter a plea of not guilty, or setting aside the verdict of guilty, or dismissing the accusation, information, or indictment. . . .

REGULATORY PROVISIONS

9. California Code of Regulations, title 16, section 1769 states:

(a) When considering the denial of a facility or personal license under Section 480 of the Business and Professions Code, the board, in evaluating the rehabilitation of the applicant and his present eligibility for licensing or registration, will consider the following criteria:

1 (1) The nature and severity of the act(s) or offense(s) under consideration  
2 as grounds for denial.

3 (2) Evidence of any act(s) committed subsequent to the act(s) or crime(s)  
4 under consideration as grounds for denial under Section 480 of the Business and  
5 Professions Code.

6 (3) The time that has elapsed since commission of the act(s) or crime(s)  
7 referred to in subdivision (1) or (2).

8 (4) Whether the applicant has complied with any terms of parole,  
9 probation, restitution or any other sanctions lawfully imposed against the applicant.

10 (5) Evidence, if any, of rehabilitation submitted by the applicant.

11 .....  
12  
13 10. California Code of Regulations, title 16, section 1770 states:

14 For the purpose of denial, suspension, or revocation of a personal or facility  
15 license pursuant to Division 1.5 (commencing with Section 475) of the Business and  
16 Professions Code, a crime or act shall be considered substantially related to the  
17 qualifications, functions or duties of a licensee or registrant if to a substantial degree  
18 it evidences present or potential unfitness of a licensee or registrant to perform the  
19 functions authorized by his license or registration in a manner consistent with the  
20 public health, safety, or welfare.

#### 21 DRUG

22 11. Marijuana is a Schedule I controlled substance as designated by Health and Safety  
23 Code section 11054, subdivision (d)(13), and is a dangerous drug pursuant to Business &  
24 Professions Code section 4022.

#### 25 FIRST CAUSE FOR DENIAL OF APPLICATION

26 (June 8, 2005 Criminal Conviction for Selling Marijuana)

27 12. Respondent's application for registration as a pharmacy technician is subject to denial  
28 under sections 480, subdivision (a)(1) of the Code in that Respondent was convicted of a crime  
that is substantially related to the qualifications, duties, and functions of a pharmacy technician.  
The circumstances are as follows:

a. On or about June 8, 2005, in a criminal proceeding entitled *People of the State  
of California vs. Jerrell Andre Scott*, in San Bernardino County Superior Court, case number  
FMB007390, Respondent was convicted on his plea of nolo contendere to violating Health and  
Safety Code section 11360, selling and/or furnishing marijuana, a felony.

1 b. As a result of the conviction, on or about July 20, 2005, Respondent was  
2 sentenced to 120 days in the San Bernardino County Jail, with credit for three days, and he was  
3 placed on 36 months supervised probation. Respondent was further ordered to comply with  
4 standard felony probation terms, including random controlled substance tests, participation in a  
5 counseling program, and submission to a Fourth Amendment waiver. On or about April 27,  
6 2009, the court granted Respondent's motion to reduce the felony conviction to a misdemeanor  
7 and probation was terminated. The court set aside the conviction and dismissed the case pursuant  
8 to Penal Code sections 1203.4 and 1203.4, subdivision (a).

9 c. The circumstances that led to the conviction are that Respondent became a  
10 subject of an ongoing investigation conducted by the Naval Criminal Investigative Service  
11 (NCIS), which targeted military and civilian personnel who were selling illegal drugs to Navy and  
12 Marine Corps personnel at Marine Air Ground Task Force Training Command at Twenty-Nine  
13 Palms. Respondent admitted to NCIS agents that he sold marijuana on multiple occasions to a  
14 sailor he knew as "Justin." The matter was turned over to the San Bernardino County Sheriff's  
15 Department and Respondent was subsequently arrested and prosecuted.

16 **SECOND CAUSE FOR DENIAL OF APPLICATION**

17 **(Commission of Acts Which if Done by a Licensee Would be**  
18 **Grounds for Suspension or Revocation of License)**

19 13. Respondent's application is subject to denial under sections 480, subdivision (a)(3)(A)  
20 of the Code in that he committed acts, that if done by a licensed pharmacy technician, would be  
21 grounds for suspension or revocation of the license. The circumstances are as follows:

22 a. On or about June 8, 2005, as detailed in paragraph 12, above, Respondent was  
23 convicted of a crime substantially related to the qualifications, functions, and duties of a licensed  
24 pharmacy technician, which is a violation of section 4301, subdivision (1) of the Code for a  
25 licensee.

26 b. On or about June 8, 2005, as detailed in paragraph 12, above, Respondent was  
27 convicted of violating Health and Safety Code section 11360, a statute regulating controlled


substances and dangerous drugs crime, which is a violation of section 4301, subdivision (j) of the Code for a licensee.
