19 In the interest of a prompt and speedy settlement of this matter, consistent with the public  
20 interest and the responsibility of the Board of Pharmacy of the Department of Consumer Affairs,  
21 the parties hereby agree to the following Stipulated Surrender and Disciplinary Order which will  
22 be submitted to the Board for approval and adoption as the final disposition of the Accusation.

23 PARTIES

24 1. Virginia Herold (Complainant) is the Executive Officer of the Board of Pharmacy.  
25 She brought this action solely in her official capacity and is represented in this matter by Kamala  
26 D. Harris, Attorney General of the State of California, by Ron Espinoza, Deputy Attorney  
27 General.

1 14. In consideration of the foregoing admissions and stipulations, the parties agree that  
2 the Board may, without further notice or formal proceeding, issue and enter the following Order:

3 **ORDER**

4 IT IS HEREBY ORDERED that Pharmacy Technician Registration No. TCH 28654, issued  
5 to Respondent Daisy L. Lee, is surrendered and accepted by the Board of Pharmacy.

6 1. The surrender of Respondent's Pharmacy Technician Registration and the acceptance  
7 of the surrendered license by the Board shall constitute the imposition of discipline against  
8 Respondent. This stipulation constitutes a record of the discipline and shall become a part of  
9 Respondent's license history with the Board of Pharmacy.

10 2. Respondent shall lose all rights and privileges as a registered pharmacy technician in  
11 California as of the effective date of the Board's Decision and Order.

12 3. Respondent shall cause to be delivered to the Board his pocket license and, if one was  
13 issued, his wall certificate on or before the effective date of the Decision and Order.

14 4. If Respondent ever applies for licensure or petitions for reinstatement in the State of  
15 California with the Board, the Board shall treat it as a new application for licensure. Respondent  
16 stipulates that should she apply for any license or registration from the Board on or after the  
17 effective date of this Decision, all the allegations set forth in Accusation No. 5429 shall be  
18 deemed to be true, correct and admitted by Respondent when the Board determines whether to  
19 grant or deny the application. Respondent shall satisfy all requirements applicable to that license  
20 or registration as of the date the application is submitted to the Board, including, but not limited  
21 to, certification by a nationally recognized body, prior to the issuance of a new license or  
22 registration. Respondent is required to report this surrender as disciplinary action.

23 5. Respondent shall pay the Board its costs of investigation and enforcement in this  
24 matter in the amount of \$3,062.25 only prior to issuance of a new or reinstated license or  
25 registration from the Board.

26 6. Respondent shall not apply for licensure or petition for reinstatement with the Board  
27 for three (3) years from the effective date of the Board of Pharmacy's Decision and Order.

18 Complainant alleges:

19 **PARTIES**

20 1. Virginia Herold (Complainant) brings this Accusation solely in her official capacity  
21 as the Executive Officer of the Board of Pharmacy, Department of Consumer Affairs.

22 2. On or about March 12, 1999, the Board of Pharmacy issued Pharmacy Technician  
23 Registration Number TCH 28654 to Daisy L. Lee (Respondent). The Pharmacy Technician  
24 Registration expired on November 30, 2014, and was cancelled on March 1, 2015.

25 **JURISDICTION**

26 3. This Accusation is brought before the Board of Pharmacy (Board), Department of  
27 Consumer Affairs, under the authority of the following laws. All section references are to the  
28 Business and Professions Code unless otherwise indicated.

1         4. Section 118, subdivision (b), of the Code provides that the suspension, expiration,  
2 surrender or cancellation of a license shall not deprive the Board of jurisdiction to proceed with a  
3 disciplinary action during the period within which the license may be renewed, restored, reissued  
4 or reinstated.

5         5. Section 4300 of the Code states:

6         “(a) Every license issued may be suspended or revoked.”

7   STATUTORY PROVISIONS

8         6. Section 4301 of the Code states:

9         “The board shall take action against any holder of a license who is guilty of unprofessional  
10 conduct or whose license has been procured by fraud or misrepresentation or issued by mistake.  
11 Unprofessional conduct shall include, but is not limited to, any of the following:

12         “... ”

13         “(f) The commission of any act involving moral turpitude, dishonesty, fraud, deceit, or  
14 corruption, whether the act is committed in the course of relations as a licensee or otherwise, and  
15 whether the act is a felony or misdemeanor or not.

16         “... ”

17         “(o) Violating or attempting to violate, directly or indirectly, or assisting in or abetting the  
18 violation of or conspiring to violate any provision or term of this chapter or of the applicable  
19 federal and state laws and regulations governing pharmacy, including regulations established by  
20 the board or by any other state or federal regulatory agency.

21         “... ”

22         “(q) Engaging in any conduct that subverts or attempts to subvert an investigation of the  
23 board.

24         “... ”

25         7. Section 4059 of the Code states:

26         “(a) A person may not furnish any dangerous drug, except upon the prescription of a  
27 physician, dentist, podiatrist, optometrist, veterinarian, or naturopathic doctor pursuant to Section  
28 3640.7. A person may not furnish any dangerous device, except upon the prescription of a

1 physician, dentist, podiatrist, optometrist, veterinarian, or naturopathic doctor pursuant to Section  
2 3640.7.”

3 DRUGS

4 8. Lexapro, brand name for escitalopram, is an antidepressant belonging to a group of  
5 drugs called selective serotonin reuptake inhibitors (SSRIs). Lexapro is used to treat anxiety in  
6 adults. Lexapro is a dangerous drug pursuant to Business and Professions Code section 4022.

7 9. Metformin is an oral diabetes medicine to control blood sugar levels. Metformin  
8 is used for type 2 diabetes. Metformin is a dangerous drug pursuant to Business and Professions  
9 Code section 4022.

10 10. Glimperide is an antidiabetic drug used for treating type 2 diabetes. Glimperide is  
11 a dangerous drug pursuant to Business and Professions Code section 4022.

12 COST RECOVERY

13 11. Section 125.3 of the Code states, in pertinent part, that the Board may request the  
14 administrative law judge to direct a licensee found to have committed a violation or violations of  
15 the licensing act to pay a sum not to exceed the reasonable costs of the investigation and  
16 enforcement of the case.

17 FACTS

18 12. On February 18, 2014, CVS contacted the Board of Pharmacy regarding the loss of  
19 a controlled substance. Respondent was interviewed by the Loss Prevention Manager of CVS,  
20 and on March 25, 2014, she provided a written statement wherein she admitted to stealing from  
21 the store two bottles of generic Lexapro, 20mg; four bottles of Metformin 850mg; and four  
22 bottles of Glimperide while working as a pharmacy technician at CVS. Respondent admitted to  
23 furnishing these stolen drugs to her son.

24 13. On or about September 23, 2014, a Pharmacy Board Inspector sent a letter to  
25 Respondent requesting that she contact the inspector no later than 72 hours after receipt of the  
26 letter in order to meet and discuss her investigation into the missing drugs. No response was  
27 received by Respondent.

28 ///

1 14. On or about October 3, 2014, the Pharmacy Board inspector sent a second letter to  
2 Respondent requesting that she contact the inspector no later than 72 hours after receipt of the  
3 letter in order to meet and discuss her investigation into the missing drugs. Again, no response  
4 was received by Respondent.

5 15. On or about October 14, 2014, the Pharmacy Board inspector sent a third letter to  
6 Respondent requesting that she contact the inspector no later than 72 hours after receipt of the  
7 letter to meet and discuss her investigation. Respondent again failed to respond to the request.

8 **FIRST CAUSE FOR DISCIPLINE**

9 **(Failure to Cooperate with an Investigation)**

10 16. Respondent is subject to disciplinary action under Code section 4301(q) for  
11 unprofessional conduct in that Respondent engaged in conduct that subverted an investigation of  
12 the Board by failing to respond to contact by the Board on three separate occasions, specifically  
13 September 23, October 3 and October 14, 2014, as more fully set forth in paragraphs 12-15,  
14 above, and incorporated by this reference as though set forth in full herein.

15 **SECOND CAUSE FOR DISCIPLINE**

16 **(Acts Involving Dishonesty, Fraud and Deceit)**

17 17. Respondent is subject to disciplinary action under Code section 4301(f) for  
18 unprofessional conduct by committing acts involving dishonesty, fraud and deceit when  
19 Respondent stole dangerous drugs from her employer CVS, which included Lexapro, Metformin  
20 and Glimpiride, as more fully set forth in paragraphs 12-15, above, and incorporated by this  
21 reference as though set forth in full herein.

22 **THIRD CAUSE FOR DISCIPLINE**

23 **(Furnishing Dangerous Drugs Without Prescription)**

24 18. Respondent is subject to disciplinary action under Code section 4301(o), in  
25 conjunction with Code section 4059, for unprofessional conduct in that Respondent stole  
26 Lexapro, Metformin and Glimperide from her employer CVS, and furnished these dangerous  
27 drugs without prescription to her son, as more fully set forth in paragraphs 12-15, above, and  
28 incorporated by this reference as though set forth in full herein.


WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged, and that following the hearing, the Board of Pharmacy issue a decision:
