22	<u>FINDINGS OF FACT</u>			
23	1. On or about October 7, 2017, Complainant Virginia Herold, in her official capacity as			
24	the Executive Officer of the Board of Pharmacy (Board), Department of Consumer Affairs, filed			
25	Accusation No. 6159 before the Board against Sunset Pharmacy and Tom Thanh Nguyen			
26	("Respondent") as the Individual Licensed Owner and Pharmacist-In-Charge ("PIC"), and Tom			
27	Thanh Nguyen, Pharmacist. (Accusation attached as Exhibit A.)			
28	2. On or about April 24, 2013, the Board issued Pharmacy Permit Number PHY 51210			
	.1	1		

to Tom Thanh Nguyen as the Individual Licensed Owner and Pharmacist-In-Charge ("PIC") doing business as Sunset Pharmacy. The Pharmacy Permit ("pharmacy permit") was in full force and effect at all times relevant to the charges brought herein, expired on April 1, 2015, and was cancelled on October 11, 2016.

- 3. On or about October 5, 2011, the Board issued Pharmacist License Number RPH 66162 to Tom Thanh Nguyen. The Pharmacist License ("pharmacist license") was in full force and effect at all times relevant to the charges brought herein and will expire on November 30, 2018, unless renewed.
- 4. On or about February 21, 2018, Respondent was served by Certified and First Class Mail copies of the Accusation No. 6159, Statement to Respondent, Notice of Defense, Request for Discovery, and Discovery Statutes (Government Code sections 11507.5, 11507.6, and 11507.7) at Respondent's residence address which was maintained with the Board which was and is: 6284 Lone Tree Blvd. Rocklin CA 95765.
- 5. On or about May 3, 2018, Respondent was served by Certified and First Class Mail copies of the Accusation No. 6159, Statement to Respondent, Notice of Defense, Request for Discovery, and Discovery Statutes (Government Code sections 11507.5, 11507.6, and 11507.7) at Respondent's address of record which, pursuant to Business and Professions Code section 4100, is required to be reported and maintained with the Board. Respondent's address of record was and is: 8760 Center Parkway, Elk Grove, CA 95758.¹
 - 6. Government Code section 11506(c) states, in pertinent part:
 - (c) The respondent shall be entitled to a hearing on the merits if the respondent files a notice of defense . . . and the notice shall be deemed a specific denial of all parts of the accusation . . . not expressly admitted. Failure to file a notice of defense . . . shall constitute a waiver of respondent's right to a hearing, but the agency in its discretion may nevertheless grant a hearing.
- 7. The Board takes official notice of its records and the fact that Respondent failed to file a Notice of Defense within 15 days after service upon him of the Accusation, and therefore waived his right to a hearing on the merits of Accusation No. 6159.

¹ Previously, on or about December 21, 2017, Respondent was served by Certified and First Class Mail copies of the same documents at Respondent's previous address of record which was: P.O. Box 580418 Elk Grove, CA 95758.

- 8. California Government Code section 11520(a) states, in pertinent part:
- (a) If the respondent either fails to file a notice of defense . . . or to appear at the hearing, the agency may take action based upon the respondent's express admissions or upon other evidence and affidavits may be used as evidence without any notice to respondent
- 9. Pursuant to its authority under Government Code section 11520, the Board finds Respondent is in default. The Board will take action without further hearing and, based on the relevant evidence contained in the Default Decision Evidence Packet in this matter, as well as taking official notice of all the investigatory reports, exhibits and statements contained therein on file at the Board's offices regarding the allegations contained in Accusation No. 6159, finds that the charges and allegations in Accusation No. 6159, are separately and severally, found to be true and correct by clear and convincing evidence.
- 10. The Board finds that the actual costs for Investigation and Enforcement are \$7,632.75 as of February 9, 2018.

DETERMINATION OF ISSUES

- Based on the foregoing findings of fact, Respondent Sunset Pharmacy, Tom Thanh Nguyen, Owner/Pharmacist-in-Charge has subjected Pharmacy Permit No. PHY51210 to discipline.
- 2. Based on the foregoing findings of fact, Respondent Tom Thanh Nguyen has subjected his Pharmacist Permit No. RPH66162 to discipline
 - 3. The agency has jurisdiction to adjudicate this case by default.
- 4. The Board of Pharmacy is authorized to revoke Respondent's Pharmacist License based upon the following violations alleged in the Accusation which are supported by the evidence contained in the Default Decision Evidence Packet in this case:
 - a. A violation of Code section 4301, subdivision (j) and (o), on the grounds of unprofessional conduct, in that Respondent violated Health and Safety Code section 11165, subdivision (d) as follows: Respondent failed to report to CURES any Schedule II, III, and IV controlled substances dispensed during the time Sunset Pharmacy was open for business;

1	<u>ORDER</u>		
2	IT IS SO ORDERED that Pharmacy Permit Number PHY 51210, heretofore issued to		
3	Respondent Tom Thanh Nguyen as the Individual Licensed Owner and Pharmacist-In-Charge,		
4	doing business as Sunset Pharmacy, is hereby REVOKED.		
5	IT IS FURTHER ORDERED that Pharmacist License Number RPH 66162, heretofore		
6	issued to Respondent Tom Thanh Nguyen, is hereby REVOKED.		
7	Pursuant to Government Code section 11520, subdivision (c), Respondent may serve a		
8	written motion requesting that the Decision be vacated and stating the grounds relied on within		
9	seven (7) days after service of the Decision on Respondent. The agency in its discretion may		
10	vacate the Decision and grant a hearing on a showing of good cause, as defined in the statute.		
11	This Decision shall become effective at 5:00 p.m. on September 5, 2018.		
12	It is so ORDERED on August 6, 2018.

27	1. Complainant brings this Accusation solely in her official capacity as the Executive		
28	Officer of the Board of Pharmacy ("Board"), Department of Consumer Affairs.		
	(STINGET DUADAMACV and TOM THANKI NICHWEND ACCURATION		

Original Pharmacy Permit

2. On or about April 24, 2013, the Board issued Pharmacy Permit Number PHY 51210 to Tom Thanh Nguyen ("Respondent") as the Individual Licensed Owner and Pharmacist-In-Charge ("PIC") doing business as Sunset Pharmacy. The Pharmacy Permit ("pharmacy permit") was in full force and effect at all times relevant to the charges brought herein, expired on April 1, 2015, and was cancelled on October 11, 2016.

Original Pharmacist License

3. On or about October 5, 2011, the Board issued Pharmacist License
Number RPH 66162 to Tom Thanh Nguyen ("Respondent"). The Pharmacist License
("pharmacist license") was in full force and effect at all times relevant to the charges brought herein and will expire on November 30, 2018, unless renewed.

JURISDICTION

- 4. This Accusation is brought before the Board under the authority of the following laws. All section references are to the Business and Professions Code ("Code") unless otherwise indicated.
 - 5. Code section 4300 states, in pertinent part:
 - (a) Every license issued may be suspended or revoked.
 - (b) The board shall discipline the holder of any license issued by the board, whose default has been entered or whose case has been heard by the board and found guilty, by any of the following methods:
 - (1) Suspending judgment.
 - (2) Placing him or her upon probation.
 - (3) Suspending his or her right to practice for a period not exceeding one year.
 - (4) Revoking his or her license.
 - (5) Taking any other action in relation to disciplining him or her as the board in its discretion may deem proper. . . .
 - 6. Code section 4300.1 states:

The expiration, cancellation, forfeiture, or suspension of a board-issued license by operation of law or by order or decision of the board or a court of law, the placement of a license on a retired status, or the voluntary surrender of a license by a

under suspension, or who has been a manager, administrator, owner, member, officer, director, associate, partner, or any other person with management or control of any partnership, corporation, trust, firm, or association whose application for a license has been denied or revoked, is under suspension or has been placed on probation, and while acting as the manager, administrator, owner, member, officer, director,

associate, partner, or any other person with management or control had knowledge of or knowingly participated in any conduct for which the license was denied, revoked, suspended, or placed on probation, shall be prohibited from serving as a manager, administrator, owner, member, officer, director, associate, partner, or in any other position with management or control of a licensee as follows:

- (1) Where a probationary license is issued or where an existing license is placed on probation, this prohibition shall remain in effect for a period not to exceed five years.
- (2) Where the license is denied or revoked, the prohibition shall continue until the license is issued or reinstated.
- 11. Code section 4333 states, in pertinent part, that all prescriptions filled by a pharmacy and all other records required by Section 4081 shall be maintained on the premises and available for inspection by authorized officers of the law for a period of at least three years. In cases where the pharmacy discontinues business, these records shall be maintained in a board-licensed facility for at least three years.
 - 12. Health and Safety Code section 11165, subdivision (d) states:

For each prescription for a Schedule II, Schedule III, or Schedule IV controlled substance, as defined in the controlled substances schedules in federal law and regulations, specifically Sections 1308.12, 1308.13, and 1308.14, respectively, of Title 21 of the Code of Federal Regulations, the dispensing pharmacy, clinic, or other dispenser shall report the following information to the Department of Justice as soon as reasonably possible, but not more than seven days after the date a controlled substance is dispensed, in a format specified by the Department of Justice:

- (1) Full name, address, and, if available, telephone number of the ultimate user or research subject, or contact information as determined by the Secretary of the United States Department of Health and Human Services, and the gender, and date of birth of the ultimate user.
- (2) The prescriber's category of licensure, license number, national provider identifier (NPI) number, if applicable, the federal controlled substance registration number, and the state medical license number of any prescriber using the federal controlled substance registration number of a government-exempt facility.
- (3) Pharmacy prescription number, license number, NPI number, and federal controlled substance registration number.
 - (4) National Drug Code (NDC) number of the controlled substance dispensed.

COST RECOVERY

18. Code section 125.3 states, in pertinent part, that the Board may request the administrative law judge to direct a licentiate found to have committed a violation or violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case.

BACKGROUND

- 19. On or about April 8, 2016, the Board received a complaint from C.T. alleging the following: Respondent scammed C.T. into loaning him \$100,000 to open pharmacy stores in California and Nevada; Respondent staged two burglaries in order to sell controlled substances to Vietnam; and Respondent informed C.T. that he had multiple investors to assist with selling drugs to and from the United States, Vietnam, Laos and Cambodia.
- On or about April 14, 2016, the Board opened an investigation into the allegations 20. made by C.T.

INSPECTION OF MAY 4, 2012 / BOARD INVESTIGATION

- On or about May 4, 2016, Board Inspectors P.P. and J.H. went to Sunset Pharmacy 21. located at 3101 Sunsent Boulevard, Suite 4C in Rocklin, California. Upon arrival, the inspectors realized another business, Sunshine Nails, was in the location where Sunset Pharmacy was supposed to be located. The inspectors entered Sunshine Nails and spoke with an employee who stated Sunset Pharmacy had been out of business for approximately one (1) year.
- On or about May 4, 2016, Board Inspector J.H. contacted the Board to determine 22. whether Respondent submitted a Discontinuance of Business ("DOB") and the Board confirmed they have no such record of Sunset Pharmacy closing.
- 23. On or about May 10, 2016, Board Inspector J.H. requested from the Board the CURES report and compliance report for Sunset Pharmacy. No CURES data was located by the Board for Sunset Pharmacy during the time it was open for business, April 24, 2013 through December 23, 2014.
- On or about May 10, 2016, Board Inspector J.H. received a telephone call from Respondent admitting that Sunset Pharmacy closed on December 23, 2014; Respondent placed all

remaining drugs in his inventory, including controlled substances and records, in a storage unit in Rocklin, California; and Respondent did not have enough time to look for other options because he "had a plane to catch in Asia;"

- 25. On or about May 18, 2016, Respondent submitted his DOB form to Board Inspector J.H. via email indicating his business closed on December 23, 2014. Respondent's DOB submission was two years and 116 days past due. The DOB stated that all records were stored at Rocklin Storage in Rocklin, California. Respondent listed his address on the DOB as 8760 Center Parkway, #241 in Elk Grove, California rather than the address of record with the Board of his P.O. Box or physical address of 6284 Lone Tree Boulevard in Rocklin, California. In his email, Respondent admitted that he did not have a list of inventory for the drugs stored in storage unit.
- 26. On or about November 28, 2013, Respondent made a report to the Rocklin Police Department of a burglary at Sunset Pharmacy where the following drugs were reported as taken: five (5) bottles of promethazine with codeine and four (4) bottles of promethazine DM.
- 27. On or about July 4, 2014, Respondent made a report to the Rocklin Police

 Department of a burglary at Sunset Pharmacy where the it was reported that a couple of bottles of promethazine with codeine were taken.

FIRST CAUSE FOR DISCIPLINE

(Failure to Report Controlled Substances to CURES)

28. Respondent's pharmacy permit and pharmacist's license are subject to disciplinary action under to Code section 4301, subdivision (j) and (o), on the grounds of unprofessional conduct, in that Respondent violated Health and Safety Code section 11165, subdivision (d) as follows: Respondent failed to report to CURES¹ any Schedule II, III, and IV controlled substances dispensed during the time Sunset Pharmacy was open for business (April 24, 2013 through December 23, 2014).

 $^{^1}$ CURES is California's Prescription Drug Monitoring Program for controlled substances. The program requires weekly reporting of all Schedule $\Pi - \Pi$ controlled substances.

SECOND CAUSE FOR DISCIPLINE

(Failure to Maintain a Facility to Safely Store Drugs)

29. Respondent's pharmacy permit and pharmacist's license are subject to disciplinary action under Code sections 4301, subdivision (o), on the grounds of unprofessional conduct, in that Respondent violated CCR, title 16, section 1714(b), in that Respondent failed to comply with the requirements to maintain a facility, space, fixtures, and equipment so that drugs are safely and properly secured as more particularly set forth above in paragraphs 24 and 25.

THIRD CAUSE FOR DISCIPLINE

(Discontinuance of Business and Maintenance of Records)

30. Respondent's pharmacy permit and pharmacist's license are subject to disciplinary action under Code sections 4301, subdivisions (j) and (o), on the grounds of unprofessional conduct, in that Respondent violated CCR, title 16, section 1708.2 as it relates to Code sections 4081, subdivision (a) and 4333, subdivision (a), in that Respondent failed to comply with the requirements for discontinuance of a business and maintenance of the records, as more particularly set forth above in paragraphs 24 and 25.

FOURTH CAUSE FOR DISCIPLINE

(Failure to Report Drug Loss)

31. Respondent's pharmacy permit and pharmacist's license are subject to disciplinary action under to Code section 4301, subdivisions (j) and (o) on the grounds of unprofessional conduct in that Respondent violated CCR, title 16, section 1715.6, by failing to report to the Board the burglary or theft of controlled substances from Sunset Pharmacy on November 28, 2013, and July 4, 2014, as more particularly set forth above in paragraphs 26 and 27.

FIFTH CAUSE FOR DISCIPLINE

(Failure to Notify of Change of Address)

32. Respondent's pharmacist's license is subject to disciplinary action under Code section 4301, subdivision (o), on the grounds of unprofessional conduct in that Respondent violated CCR, title 16, section 1704 by failing to notify the Board of any and all changes of residence address within 30 days, as more particularly set forth above in paragraph 25.

OTHER MATTERS

- 33. Pursuant to Code section 4307, if discipline is imposed on Pharmacy Permit Number PHY 51210 issued to Sunset Pharmacy, with Tom Thanh Nguyen as the Individual Licensed Owner and PIC, Sunset Pharmacy, with Tom Thanh Nguyen as the Individual Licensed Owner and PIC shall be prohibited from serving as a manager, administrator, owner, member, officer, director, associate, or partner of a licensee for five years if Pharmacy Permit Number PHY 51210 is placed on probation or until Pharmacy Permit Number PHY 51210 is reinstated if it is revoked.
- 34. Pursuant to Code section 4307, if discipline is imposed on Pharmacist License Number RPH 66162 issued to Tom Thanh Nguyen, while Tom Thanh Nguyen has been an officer and owner and had knowledge of or knowingly participated in any conduct for which the license was disciplined, Tom Thanh Nguyen shall be prohibited from serving as a manager, administrator, owner, member, officer, director, associate, or partner of a licensee for five years if Pharmacist License Number PHY 66162 is placed on probation or until Pharmacist License Number PHY 66162 is reinstated if it is revoked.

PRAYER

WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged, and that following the hearing, the Board issue a decision:

- 1. Revoking or suspending Pharmacist License Number RPH 66162, issued to Tom Thanh Nguyen;
- 2. Revoking or suspending Pharmacy License Number PHY 51210, issued to Tom Thanh Nguyen doing business as Sunset Pharmacy;
- 3. Prohibiting Tom Thanh Nguyen from serving as a manager, administrator, owner, member, officer, director, associate, or partner of a licensee for five years if Pharmacy Permit Number PHY 51210 is placed on probation or until Pharmacy Permit Number PHY 51210 is reinstated if it is revoked;
- 4. Prohibiting Tom Thanh Nguyen from serving as a manager, administrator, owner, member, officer, director, associate, or partner of a licensee for five years if Pharmacist License
