21	487, subdivision (a) [grand theft of personal property] in the criminal proceeding entitled <i>The</i>	
22	People of the State of California v. Jessica Samantha Cabadas (Super. Ct. San Bernardino, 2022,	
23	No. FWV20001664). The court sentenced Respondent to serve 90 days in jail, and placed her on	
24	12 months' probation, with terms and conditions. The circumstances surrounding the conviction	
25	are that on or about March 3, 2020, officers responded to a report of an illegitimate rental	
26	agreement where the victim arrived at the property looking to rent the back house on the property.	
27	The homeowner informed the victim that there was no backhouse and that he had never listed or

subsequent investigation, police officers discovered that Respondent posted a fraudulent listing of
 said rental property on Craigslist and charged several individuals money for backgrounds checks.

 defrauding five other people by listing the same property for rent that did not belong to her using
 Craigslist.
