**NOTICE IS HEREBY GIVEN** that your license to work as a pharmacy technician in the State of California has been **AUTOMATICALLY SUSPENDED**, pursuant to California Business and Professions Code section 4311, subdivision (a), due to your incarceration, after being convicted of one felony count of violating Penal Code section 187, subd. (A) [Murder – Second Degree], in Case Number FVI23001263, in Superior Court of California, County of San Bernardino.

The suspension will remain in effect for the duration of your incarceration. It is your responsibility to provide information to the Board along with any and all supporting documentation indicating you are no longer incarcerated. Where appropriate, certified copies of court documents may be required. The suspension will remain in effect until a final decision on an accusation is rendered thereon.

You may, but need not, be represented by counsel (at your own expense) at any or all stages of any proceeding brought against your license by the State Board of Pharmacy.
