

Prescribers with Restricted Authority to Prescribe Controlled Substances

Pursuant to Health and Safety Code section 11161.7(b), the California State Board of Pharmacy is distributing this list of prescribers whose authority to prescribe controlled substances has been restricted by the Medical Board of California. The Board of Pharmacy is making this information available to prevent the dispensing of prescriptions for controlled substances issued by restricted prescribers.

Names with a strikethrough indicate the restriction is no longer effective. Names in **bold** indicate there has been an update to the action the Medical Board of California took.
