To Whom It May Concern at the Arizona State Board of Pharmacy:

I am writing to urge you to participate in the MOU process to protect consumer choice for compounded medications, specifically allowing compounding pharmacies to continue to ship medication across state lines.

A policy prohibiting compounding pharmacies from shipping across state lines would have debilitating effects on patients like me who depend on parenteral nutrition every day.

Please allow me to briefly tell you about myself. I am a 39-year-old father of two with chronic intestinal pseudo-obstruction, a malabsorption and motility disorder impacting my entire GI tract. I presented at birth with this condition.

I have been on total parenteral nutrition (TPN), an IV nutrition formula uniquely calibrated for my nutritional needs and survival, for 38 years. I am dependent on TPN for the vast majority of my calories, nutrients and fluids.

Despite requiring 12 hours of nutritional infusion per day, and an additional 4 to 6 hours of hydration replacement per day, I live a full and complete life. This is thanks to my homecare company, which, working closely with my gastroenterologist and nutritionist, and based on my gastroenterologist's prescription, provides me with TPN wherever I happen to be.

From 2005 to 2014 I was a network television producer based in Washington, D.C. While working for ABC News, I covered the presidential campaign of Senator John McCain, traveling seven days a week from September 2007 through November 2008. I went to 44 states and three foreign countries with the Republican nominee. From 2012-2014, I covered the White House for CBS News, traveling domestically and internationally to 15 different countries with President Barack Obama.

In order to receive my TPN during my professional travel, my homecare company, which is called Nutrishare, sent shipments from its pharmacies in Kentucky and California to hotels on each leg of my domestic trips. Each dose of TPN is 3 liters and must be refrigerated, so carrying more than a couple of days worth at a time is impossible. My Nutrishare shipments allowed me to excel in my job and support my family.

After my journalism career, I became the Associate Vice President for Media Relations and Strategic Communications at Arizona State University. My team of pharmacists at Nutrishare mixes and sends weekly shipments of my unique formulation to my home – or wherever I may choose to travel for work or pleasure in the United States. This has allowed me to enjoy a normal life with my wife and sons, aged five and two.

None of this would be possible if compounding pharmacies were prohibited from shipping medication across state lines. Prohibiting these shipments would mean finding a new homecare company in Arizona and would presumably mean having to find a new homecare company in each state I might choose to visit. This would make all travel incredibly challenging, and unplanned travel for family emergencies or work meetings impossible. It would limit my career opportunities and my wife's career opportunities, and it would restrict the mobility of my entire family – ending the flexibility that has allowed me to thrive in spite of my serious medical condition.

I have been a patient of Nutrishare for 15 years. They are the best homecare company I have ever worked with, and my life literally depends on them. It would be incredibly troubling to start anew with a company I do not know. And if I had to use a different company each time I traveled anywhere out of my home state, I would worry intensely about quality control when dealing so often with people I do not know who are unfamiliar with my unique condition. With a daily three-liter IV infusion, any inaccuracy, inconsistency, or contamination can be life-threatening.

I am so grateful to all the regulatory agencies, from the FDA to state and local officials, who are working correct the problems that led to the 2012 New England Compounding Center tragedy. No words can express the anger I felt, as a consumer of compounded medication, to see the greed and corruption that killed 64 innocent people. I applaud the good work that regulators have undertaken in the nearly nine years since to prevent something like this from ever happening again.

But as you are considering future policy changes, I strongly urge you to maintain the ability for patients and pharmacies to work together no matter where they may be located in the country.
