


PTCB by the Numbers

- √ 760,334 pharmacy technician certifications since 1995*
- ✓ 283,000 active certified pharmacy technicians*
 - 19,846 CPhTs in California
- ✓ 42,615 CPhT exams administered in 2021*
- 1,417 secure Pearson VUE testing centers
- Administered and accepted in all 50 states, DC, Guam, and Puerto Rico



Certified Pharmacy Technician Program



Required knowledge is the same for both paths.



Education/Training Requirement

- Recognized programs must include specific knowledge in their curriculum.
- This knowledge supplements the PTCE content outline.
- All ASHP/ACPE and ABHES accredited programs are recognized.
- ✓ Program directors of non-accredited programs must attest.
- Different and separate from accreditation.
- Audits are conducted to ensure compliance with requirements.



Education/Training Requirement



Types of programs that can be recognized:

- Certificate and degree programs
- College of Pharmacy associated programs
- Employer training
- High school programs
- Military training programs

Recertification Requirements

- Complete a minimum of 20 hours of CE during the 2-year recertification period, including:
 - 1 hour in the subject of pharmacy law; and
 - 1 hour in the subject of patient safety
- ✓ CE hours earned must be in pharmacy technician subject matter as listed in the PTCE Content Outline or offered by ACPE-accredited providers with the target audience designation 'T' (technician-specific).



Recertification Process

1 EARN

CE hours during your renewal cycle.



VERIFY that your NABP e-Profile ID appears in your PTCB Account. If not, enter your NABP e-Profile ID or create an NABP e-Profile at NABP.pharmacy.



check that you have met all CE requirements and they are recorded correctly in CPE Monitor. →2 APPLY →3 PTCB

by logging into your PTCB Account to begin your application.



ATTEST that you've completed PTCB's renewal requirements and your CE activities are in CPE Monitor.



SUBMIT your application and payment. Once your payment is processed, your application will be approved, subject to review.

3 PTCB REVIEWS

your application and attempts to verify your CE information in CPE Monitor for 60 days.



PTCB RETURNS your application if you do not meet CE requirements.



RESUBMIT your returned application if you believe you met CE requirements. You have 30 days to provide documentation and resubmit.

Assessment-based Certificate Programs

- ✓ PTCB considered the idea of creating one "advanced" exam.
 - Identifying a single body of knowledge that encompassed advancedlevel practice for pharmacy technicians was not feasible given the variation of roles.
- Assessment-based certificate programs provide flexibility to pharmacy technicians, employers, and regulators to determine what is necessary for certain jobs or duties.



Advanced Certified Pharmacy Technician






Complete at least 4 certificate programs*

or

CSPT + 3 certificate programs*





Have at least 3 years of work experience in the last 8 years

Individuals who earn the CPhT-Adv credential are required to earn 5 additional CE hours to maintain their certification.
