**I. Call to Order, Establishment of Quorum, and General Announcements**

Where protection of the public is inconsistent with other interests sought to be promoted, the protection of the public shall be paramount. Dr. Barker advised all individuals the meeting was being conducted via Webex. Department of Consumer Affairs' staff provided general instructions for participating in the meeting via Webex or phone.
