Note: 7 new regulations adopted by the Board



The state Office of Administrative Law has approved seven regulations adopted by the California State Board of Pharmacy. Six of the new regulations take effect in 2022, and one takes effect January 1, 2023. The regulations are listed in Division 17 of Title 16 of the California Code of Regulations (CCR).

Information about these regulations, including the full text of each regulation, can be found under <u>Approved Regulations</u> on the Board's website, <u>www.pharmacy.ca.gov</u>.

CCR section 1746.4, Pharmacists Initiating and Administering Vaccines.

This amended regulation eliminates a mandatory requirement for pharmacists who administer vaccines to report the vaccination to the patient's primary care provider within 14 day. Under the amended regulation, pharmacists must report the vaccination to the primary care provider only if requested by the patient. The amended regulation took effect January 25, 2022.

PRESIDENT'S MESSAGE

On behalf of the California State Board of Pharmacy, congratulations to the 1,242 students who graduated from California pharmacy schools this year! Upon passing required licensure exams, you will join a dynamic and rewarding profession dedicated to providing quality patient care through the safe and effective use of pharmaceutical medications, products, and health care services. Welcome!

This is both a challenging and rewarding time for all pharmacy professionals, especially those on the front lines during the COVID-19 pandemic. Pharmacists, intern pharmacists, and pharmacy technicians have played an outsized role in protecting public health and individual patient care by administering COVID-19 vaccines and booster shots to all age groups of Americans. More recently, pharmacists have received FDA approval to independently prescribe Paxlovid, an orally administered COVID-19 therapeutic drug, to patients under certain conditions. We

look forward to hearing how this is making a positive difference in communities you serve and patients you look out for.

The Board of Pharmacy continues to support these efforts though <u>pharmacy law waivers</u> and other important <u>COVID-19 resources</u> posted online. In addition, we thank licensees for all of their work and dedication to patient care during the ongoing pandemic emergency.

Meanwhile, a growing outbreak of monkeypox has led to a second <u>declaration of emergency by</u> <u>Governor Gavin Newsom</u> and federal officials. Once again, California pharmacists are taking an active role in vaccinating and providing care to at-risk individuals. The Board is assisting those efforts with a <u>pharmacy</u> <u>law waiver related to prescribers</u> <u>dispensing Tecovirimat to</u> <u>emergency room patients</u>, which is also posted online.

In addition, the Board is concerned about the strain faced by pharmacy professionals from increasing workplace demands and the related potential risks to patient care, especially during stressful times. We have created a Medication Error Reduction and Workforce Committee to discuss and consider these issues and recommend solutions to help ensure licensees are supported in caring for California consumers. We strongly urge you to check out materials posted on the committee's webpage and participate in the committee's teleconference meetings, which are open to the public anywhere via WebEx.

A helpful resource recently considered by the committee is the Pharmacist Well-Being Index, an online tool that enables all pharmacy professionals including pharmacists, pharmacy students, and pharmacy technicians – to self-assess their mental health. Users can log on to the index and answer questions intended to assess several dimensions of distress and well-being related to work. All information collected is anonymous, and the site also offers resources to assist users whose responses indicate risk of distress.

You can find more information about the Pharmacist Well-Being Index in an article in this issue of The Script. The current newsletter also has articles with important information for licensees, including new pharmacy regulations, top citations issued in 2021-22, how to file a complaint regarding pharmacy quotas, and requirements for notifying the Board when a PIC stops acting as PIC. You can also read about recent changes on the Board, including the re-election of all officers, a welcome to new members, and a fond farewell to former members.

Whether you are a new licensee or a <u>longtime pharmacist</u>, the Board congratulates you for your education, experience, and commitment to providing the highest quality of pharmacy care to California consumers.

New regulations

CCR section 1715.6, Reporting Drug Loss. This

amended regulation eliminates excessive reporting requirements for losses of controlled substances and more closely align the state reporting requirement with federal regulatory requirements. The amended regulation took effect April 1, 2022.

CCR section 1704, Address Change Notification.

This amended regulation requires each applicant or person holding a certificate, license, permit, registration or exemption to practice issued by the Board to provide and keep current their email address with the Board. The amended regulation took effect April 1, 2022.

<u>CCR section 1709, Ownership, Management,</u> <u>and Control of Pharmacies and Other Regulated</u> <u>Business Entities</u>. This amended regulation clarifies and makes specific the standards of pharmacy and ownership disclosure as they relate to pharmacy ownership, management, and control, including through trusts. The amended regulation took effect April 1, 2022.

CCR section 1717.5, Automatic Refill Programs.

This new regulation establishes parameters for pharmacies that choose to provide automatic refill programs. The regulation took effect July 1, 2022.

CCR section 1708.1, Notification of Temporary

<u>Closure</u>. This new regulation requires permit holders – except for correctional pharmacies – to notify the Board of any temporary closure exceeding three consecutive days. The regulation takes effect October 1, 2022.

<u>CCR section 1715.65</u>, <u>Inventory Activities and</u> Inventory Reconciliation Reports of Controlled

<u>Substances.</u> This amended regulation clarifies what is an "inventory reconciliation" and defines "inventory activities"; identifies four non-Schedule II controlled substances that must be inventoried at least every 12 months; specifies when all other controlled substances must be inventoried; requires individuals in completing the inventory or preparing the report to be identified and the individual who performs the inventory to sign and date it; allows use of a digital, electronic or biometric identifier instead of a physical signature if a printed signed statement confirming the accuracy of the report is retained; and clarifies inventory requirements in hospital settings. The amendments take effect January 1, 2023.

Sign up for emails from the Board

<u>Facilities</u>, <u>pharmacists</u>, <u>pharmacy technicians</u>, <u>intern</u> <u>pharmacists</u> and <u>designated representatives</u> are required to register for email notifications from the Board of Pharmacy within 60 days of obtaining a license or at the time of license renewal. In addition, licensees must update their registration within 30 days of changing their email address. The process is easy! To register your email address and receive email notifications from the board, visit the Board's <u>website</u> and click on the link in the "Quick Hits" to <u>sign up for subscriber alerts</u>. Email addresses are confidential and are not posted in the Board's online license verification system.

Board issues waiver in response to monkeypox state of emergency



On August 1, 2022, Governor Gavin Newsom issued a <u>proclamation of emergency</u> to bolster the state's vaccination efforts against a growing outbreak of monkeypox. On August 3, 2022, the California State Board of Pharmacy issued the following pharmacy law waiver:

Prescriber Dispensing of Tecovirimat (TPOXX or ST-246) Oral Antiviral Medication to Emergency Room Patient (BPC sections 4068(a)(1), 4068(a)(5), 4068(a)(6), 4076.5 and 4427.2(a))

<u>This order</u> waives Business and Professions Code sections 4068(a)(1), 4068(a)(5), 4068(a)(6), 4076.5 and 4427.2(a) and any associated regulation related to the prohibition against a prescriber dispensing medications to an emergency room patient under the following conditions:

- 1. The medication is provided to a patient receiving care in an emergency room in California.
- The antiviral medication is prescribed and dispensed consistent with the provisions of the FDA Expanded Access Program and <u>Guidance for Tecovirimat Use Under Expanded Access Investigational New Drug</u> <u>Protocol during 2022 U.S. Monkeypox Cases</u>.

- Prior to prescribing and dispensing the medication, the prescriber reviews the patient's medication history to determine any drug interactions, contraindications, or potential for severe side effects.
- 4. The medication is labeled to include the patient's name, drug name and strength, directions for use, quantity, date of issuance, name of the prescriber, and hospital information.
- 5. Verbal consultation is provided by an authorized health care provider.
- 6. When the antiviral medication is not packaged in a child-resistant container, the patient is advised.

Effective: August 3, 2022

Expires: September 1, 2022

Check website for COVID-19 info

Amid the ongoing national and state emergencies related to the COVID-19 pandemic, the Board of Pharmacy continues to disseminate important information to licensees on its <u>website</u> and through <u>subscriber alerts</u>.

A comprehensive list of waivers, guidance documents, and additional resources issued by the Board is posted online under <u>COVID-19 Information</u>. In addition, waivers issued by the Department of Consumer Affairs are posted on the <u>DCA website</u>.

The Board and DCA most recently updated several important waivers, including:

- <u>DCA Waiver DCA-22-217 Order Waiving</u> <u>Restrictions on Pharmacists Independently</u> <u>Initiating and Furnishing Paxlovid to Individual</u> <u>Patients - AMENDED</u> – The order is effective immediately and may be further amended as circumstances require.
- <u>Remote Processing BPC section 4071.1(a)</u>
 This waiver expires 30 days after the emergency declaration is lifted.
- <u>Staffing Ratio of Pharmacists to Intern</u> <u>Pharmacists and General Supervision and</u> <u>Interprofessional Supervision - Immunizations</u> <u>- BPC section 4114</u> – The amended expiration date is December 31, 2022, or 30 days after the emergency declaration is lifted, whichever is sooner.
- <u>Mass Vaccination Sites</u> The amended expiration date is December 31, 2022, or 30 days following the declared disaster, whichever is sooner.
- Prescriber Dispensing of COVID-19 Antiviral Medication to an Emergency Room Patient (including BPC sections 4068(a)(1), 4068(a)(5), 4068(a)(6), 4076.5, and 4427.2(a)) – The amended expiration date is 30 days following the end of the declared disaster.

Important rules for changes of PIC

Pharmacies and pharmacists-in-charge (PIC) are reminded of important requirements when a PIC ceases to act as PIC or takes an extended leave from the pharmacy:

- A PIC who stops acting as PIC must notify the Board of Pharmacy in writing within 30 days of the date of that change in status, pursuant to Business and Professions Code (BPC) <u>section 4101(a)</u>. Submit a letter in writing to the Board's address or email the Board at <u>PICstatus@dca.ca.gov</u> with your name and license number, the name and license number of the pharmacy where you were PIC, and the date you ceased acting as PIC. Note: The outgoing PIC should send this notice directly to the Board in addition to signing the "Application for Change of Pharmacist in Charge (PIC)" that the employer must send to the Board.
- BPC <u>section 4113(d)</u> requires a pharmacy to notify the Board within 30 days when its PIC ceases to act as the PIC. The pharmacy must complete the <u>Application for Change</u> <u>of Pharmacist in Charge (PIC)</u> to notify the Board of a new proposed PIC or interim PIC as well identifying the PIC being replaced.
- If you are a PIC on extended leave (e.g., maternity, medical, etc.) and remain as the PIC during your absence, you are still responsible for the pharmacy's compliance with laws and regulations, unless the Board is notified of an interim PIC during your extended leave.

During recent inspections, the Board has noted an increase in the number of pharmacies failing to notify the Board when a PIC ceased acting as PIC. Pharmacies and PICs who fail to notify the Board when a PIC ceases acting as PIC are considered to be in violation of pharmacy law.

Board reports most common citations issued to licensees in fiscal year 2021/22

Business and Professions Code (BPC) <u>section 4314</u> authorizes the Board of Pharmacy to issue citations for violations of Pharmacy Law. Title 16, California Code of Regulations (CCR), sections 1775 to 1775.4 describe how the Board exercises this authority.

Citations are <u>administrative</u> actions; they are less serious than <u>disciplinary</u> actions (which may result in license probation, suspension, or revocation). The Board's <u>Enforcement and Compounding Committee</u> annually reports the most common violations that result in citations.

Mission statement

The California State Board of Pharmacy protects and promotes the health and safety of Californians by pursuing the highest quality of pharmacist care and the appropriate use of pharmaceuticals through education, communication, licensing, legislation, regulation and enforcement.

Law forbids quotas for pharmacy duties

California law prohibits a chain community pharmacy from setting certain types of quotas related to the duties of a pharmacist or pharmacy technician.

Business and Professions Code (BPC) <u>section 4113.7</u> forbids a pharmacy from setting a quota – which is defined as "a fixed number or formula" – regarding the duties of an individual pharmacist or pharmacy technician related to:

- Prescriptions filled.
- Services rendered to patients.
- Programs offered to patients.
- Revenue obtained.

In addition, BPC <u>section 4317</u> authorizes the California State Board of Pharmacy to take action against a pharmacy for violations of BPC section 4113.7.

If you believe a community chain pharmacy has established quotas for pharmacists or pharmacy technicians in violation of BPC section 4113.7, you may <u>file an</u> <u>online complaint with the Board</u> <u>of Pharmacy</u>. Fill out the boxes on the form that apply to your complaint, including a description of your complaint. The Board evaluates and, if appropriate, investigates the substance of complaints received.

Note: Before filing a complaint, be aware of important information below regarding anonymous complaints, complainant

confidentiality, and whistleblower protections.

Filing an Anonymous Complaint

The Board welcomes and investigates all complaints received, including anonymous complaints. However, investigations of anonymous complaints may be difficult to investigate because investigators may need additional information from the complainant to establish facts necessary to prove a violation.

Complainant Confidentiality

Complaints filed with the Board generally are not considered public records under California's Public Records Act, and the Board generally treats such complaints as confidential. However, the Board cannot guarantee the confidentiality of the substance of a complaint or the identity of complainants.

For example, if a complaint investigation results in disciplinary action against a pharmacy or other licensee, the Board may not be able to shield the complainant's identity from discovery requests in administrative proceedings. Similarly, the information could be released in response to a subpoena issued in a case instituted under state or federal law. There also may be other circumstances that could legally require the Board to release complaint information.

Whistleblower Protections

BPC section 4113.7 does not include whistleblower protections for licensees who file complaints. However, California labor laws provide general protections against retaliation for employees alleging employer violations of laws or regulations.

The California Labor

<u>Commissioner's Office</u> provides comprehensive information on <u>how to file a retaliation</u> <u>or discrimination complaint</u>. The resources include a <u>listing</u> <u>of California labor laws that</u> <u>specifically prohibit retaliation</u> against employees who report a violation of noncompliance with a state or federal law or regulation. Complainants alleging retaliation may want to consult with knowledgeable labor law counsel regarding the specifics of their particular case.

The California Office of the Attorney General also provides resources for <u>whistleblowers</u>, including a whistleblower hotline: (800) 925-5225. The office will refer callers to the appropriate government authority for review and possible investigation.

Pharmacy Well-Being Index

Protecting the Mental Health of Pharmacy Professionals

While numerous resources have been developed to address physician and nurse well-being, psychological distress among pharmacy professionals has remained largely unacknowledged—until now.

Amid public reports of increasing workplace demands and burnout, especially during the COVID-19 pandemic, many pharmacy professionals are using an online tool to help measure their personal levels of job stress and job satisfaction.

The <u>Pharmacist Well-Being Index</u> is a validated, self-assessment tool created by the Mayo Clinic and launched in 2019. Participants can log on via website or phone app and answer questions intended to assess several dimensions of distress and well-being related to work – including quality of life, fatigue, burnout, concern for a recent major medication error, and intent to leave the current job.

The tool is available to pharmacists, student pharmacists, and pharmacy technicians. Users can retake the assessment and track their well-being over time. **All answers are anonymous.** According to the index website, "All data is stored in secure cloud servers and provided to administrators in a de-identified aggregate format."

In addition, the index provides resources to assist users whose responses indicate risk of distress. The data collected also enable organizations to collect information to pinpoint causes of distress and make meaningful changes to maximize the mental health of participants. The American Pharmacist Association (APhA) monitors data from the Well-Being Index to determine a "distress percent" for pharmacy personnel based on pharmacy personnel who score a well-being index greater than or equal to 5, which indicates a risk of high distress. According to APhA, pharmacy personnel who are at high risk of distress also have:

- a three-fold higher risk of low quality of life.
- an eight-fold higher risk of burnout.
- a 2.5-fold higher risk of high fatigue.
- a 2.5-fold higher risk of intent to leave their job.
- a two-fold higher risk of medication error.

APhA presented information about the Well-Being Index and other reports related to pharmacy workplace issues at the Medication Error Reduction and Workforce Committee meeting on June 22, 2022. Meeting materials and a <u>webcast recording</u> of the meeting are available under <u>Medication Error</u> <u>Reduction and Workforce Committee</u> on the Board's website, <u>www.pharmacy.ca.gov</u>.

ISMP can help reduce medication errors



The <u>Institute for Safe Medication Practices</u> (ISMP), a nonprofit organization dedicated entirely to preventing medication errors, provides pharmacists with many valuable tips, training materials, and other resources to help reduce medication errors and improve consumer safety.

As an independent watchdog, ISMP is widely respected among health care professionals as the gold standard in providing information about medication safety. Founded in 1994, its staff and advisory board include pharmacists, physicians, and nurses.

The organization's website, <u>ismp.org</u>, is a portal to publications, tools and resources, and consulting and educational services to help health care professionals improve medication safety and reduce errors. Free resources for practitioners include a <u>List of Confused Drug Names</u> (medications with look-alike and sound-alike names) and a <u>List of Error-Prone Abbreviations, Symbols and Dose Designations</u>, which have been misinterpreted and involved in harmful or potentially harmful medication errors.

ISMP's chief initiative is an <u>error reporting</u> <u>system</u> that enables health care practitioners and consumers to report medication and vaccine errors. The institute analyzes the information to identify causes and contributing factors to an error. In turn, ISMP shares the lessons learned as well as ideas and techniques for preventing errors with health care professionals. The institute gets the word out through its newsletter, educational events, alerts published in syndicated trade journals, and mailing lists of health care organizations.

In addition, ISMP issues urgent advisories to a National Alert Network set up in cooperation with the American Society of Health-System Pharmacists (ASHP) and other members of the National Coordinating Council on Medication Error Reporting and Prevention (NCC MERP). Theses <u>NAN Alerts</u> warn health care providers through several national distribution channels about actual or potential medication errors that have recently caused serious harm or death.

ISMP also offers resources specifically for community pharmacies. <u>ISMP Medication Safety</u> <u>Self-Assessment for Community/Ambulatory</u> <u>Pharmacy</u> is intended to increase awareness of systems and practices related to a safe community pharmacy medication system. In addition, the institute publishes <u>ISMP Medication Safety Alert!</u> <u>Community/Ambulatory Care</u>, a monthly newsletter for practitioners in ambulatory settings, including community pharmacies, specialty pharmacies, outpatient clinics, physician offices, and state institutions.

The Board of Pharmacy encourages licensees to visit and view information and resources available at ISMP's website to improve efforts to reduce medication errors and protect patient safety. A link to ISMP is posted under "<u>Important Information for</u> <u>Licensees</u>" on the Board's website, <u>www.pharmacy.</u> <u>ca.gov</u>.

ISMP officials presented information about the organization and its resources to the Board's <u>Medication Error Reduction and Workforce</u> <u>Committee</u> January 27, 2022. Information about ISMP and its presentation can be found in the committee's meeting <u>materials</u>, <u>minutes</u>, and <u>webcast recording</u> on the Board's website.

Check prescribers with restrictions before dispensing

Checking the Medical Board of California's license verification site can provide detailed information on prescribers with pending accusations and/or any disciplinary action taken against their license, including any restrictions on prescribing controlled substances or revocation of license.

On the Board of Pharmacy's <u>homepage</u> under "Important Information for Licensees," there is a link to <u>prescribers with restricted authority for</u> <u>prescribing controlled substances</u>, per <u>Health</u> <u>and Safety Code (HSC) section 11161.7</u>. The list is typically updated each week with information provided by the Medical Board of California.

Additionally, <u>HSC section 11153(a)</u> states in pertinent part the following:

(a) A prescription for a controlled substance shall only be issued for a legitimate medical purpose by an individual practitioner acting in the usual course of his or her professional practice. The responsibility for the proper prescribing and dispensing of controlled substances is upon the prescribing practitioner, but a corresponding responsibility rests with the pharmacist who fills the prescription. ...

In conjunction, <u>Title 21 Code of Federal Regulations</u> section 1306.03 states in pertinent part:

(a) A prescription for a controlled substance may be issued only by an individual practitioner who is:
(1) Authorized to prescribe controlled substances by the jurisdiction in which he is licensed to practice his profession. ...

When in doubt about the status of a prescriber's license status, it is best to verify. Failure to do so is a violation of pharmacy law and a failure to exercise corresponding responsibility as per HSC section 11153(a).

Diabetes test makers must post, report names of authorized distributors to Board

<u>BPC 4160.5</u> requires a manufacturer of nonprescription diabetes test devices to post the names of its authorized distributors on its website and to provide the



California State Board of Pharmacy with the names for posting on the Board's website. In addition, any changes to its distributors must be posted on the manufacturer's website and reported to the Board within 30 days.

For the sake of convenience, the Board has created an email address that manufacturers of nonprescription diabetes test devices may use to provide the names of their authorized distributors to the Board: <u>diabetestest@dca.ca.gov</u>. To view distributors on the Board's website, click on the "Licensees" tab, go to "Important Information for Licensees," and click on "<u>Diabetes Test Devices</u>."

BPC 4160.5 was established by <u>Assembly Bill 602</u> (Chapter 139, Statutes of 2017), which generally defines a nonprescription diabetes test device as a glucose meter or test strip used in the treatment of prediabetic or diabetic individuals. The bill also contains related provisions, including a requirement that pharmacies that dispense these nonprescription products pursuant to a prescription retain records of their acquisition and sale for at least three years.

In addition, AB 602 authorizes the Board to embargo nonprescription diabetes test devices that were not purchased directly from the manufacturer or an authorized distributor. The law also makes it unprofessional conduct for a licensee to purchase such devices from an unauthorized distributor or to seek reimbursement for such devices that were not purchased from authorized sources.

Pharmacists need basic life support training to give immunizations

Training in cardiopulmonary resuscitation (CPR) and basic life support can help save a life and teach you what to do in a cardiac emergency – but certification in basic life support is required by pharmacy law (Business and Professions Code <u>section 4052.8(b)(2)</u> to administer immunizations. A pharmacist must have a <u>current</u> basic life support certification to administer immunizations.

The key difference between basic life support and CPR qualification is the curriculum. Basic life support training is more intensive and complex than CPR training and includes a wider variety of medical training. A CPR course may be a precursor to a basic life support certification course.

CPR is an emergency life-saving procedure that is performed on people whose hearts have stopped beating. By compressing the chest and blowing air into the mouth, the person administering CPR may keep the heart beating and keep oxygen moving throughout the body until emergency medical service professionals arrive to administer more advanced techniques.

Basic life support is a level of medical care administered by public safety professionals, first responders, health care providers, paramedics, and qualified bystanders. In addition to CPR, basic life support training teaches how to use automated external defibrillators (AED) and relieve airway obstructions in patients of every age.

In California, a pharmacist must have a <u>current</u> basic life support certification to administer immunizations. A basic life support certificate typically is valid for only two years. The American Heart Association, the American Red Cross, and other health and emergency response groups offer both CPR and basic life support training courses.

Free webinar training available to pharmacists furnishing HIV PrEP/PEP

The California State Board of Pharmacy has created free online training pharmacists may complete to furnish HIV pre-exposure (PrEP) and post-exposure prophylaxis (PEP), pursuant to California Code of Regulations, title 16, <u>section 1747</u>.

Pharmacists were authorized to independently initiate and furnish HIV PrEP/PEP by <u>Senate Bill 159</u> (Weiner, Chapter 532, Statutes of 2019).

The training webinar, "HIV Pre-Exposure and Post-Exposure Prophylaxis for California Pharmacists," is presented by Betty J. Dong, PharmD., professor of clinical pharmacy and medicine at the University of California Schools of Pharmacy and Medicine. The webinar is about 90 minutes in length, including an assessment section at the end of the presentation.

Pursuant to CCR section 1747(a)(2), participants must obtain a **passing score of 70 percent or higher** on the assessment to receive a certificate of successful completion of the program. Pharmacists who successfully complete the training also will receive 1.5 hours of continuing education (CE) credit. **Those who do not view the entire 90-minute training program or do not obtain a passing score will not receive a certificate of completion nor CE credit.**

Note: Please allow enough time to complete the entire training program in one session to receive credit for viewing the entire webinar. Because of technical limitations, credit cannot be given for viewing the entire 90-minute training program in multiple discrete sessions.

The <u>California Pharmacy Law</u> <u>Update 2022 Edition</u>, a free continuing education (CE) webinar from the California State Board of Pharmacy, is now available for viewing online at <u>www.pharmacy.ca.gov</u>.

The webinar covers important pharmacy laws enacted by the Legislature that took effect this year. In addition, the presentation includes new regulations adopted by the Board; an overview of the Board's structure and activities; and tips on how to find additional information about laws and regulations on the Board's website.

California Code of Regulations, title 16, section 1732.5(b)

requires at least two of the 30 hours of CE required for renewal of a pharmacist license be completed by participating in law and ethics courses provided by the Board of Pharmacy. In addition to the law webinar, a CE webinar on ethics is available for viewing on the Board's website. Each webinar meets one of the two hours required for law and ethics CE courses provided by the Board.

Scammers seek account information from licensees to divert drugs in transit

Pharmacies, hospitals, and distributors are being warned about scammers using sophisticated techniques to obtain account numbers and other sensitive information and unlawfully divert quantities of pharmaceutical goods in transit. In some cases, scammers pretended to represent the state's board of pharmacy or employees for a particular distributor or pharmacy.

The callers requested and obtained each pharmacy's DEA number and account purchasing information for their principal distributor. The scammers then called each distributor – pretending to be the pharmacy – and ordered between \$100,000 and \$300,000 worth of products. Common products ordered included a variety of HIV medications (Descovy, Triumeq, Odefsey) and Xarelto, Otezla, and Eliquis. Once the products were delivered, the scammers called the pharmacy – pretending to be the distributor – and advised the pharmacy the order was made in error. The scammers then arranged for a courier to pick up the diverted product.

The Healthcare

Distribution Alliance Pharmaceutical Cargo Security Coalition (HDAPCSC) has released a report about this problem: "<u>Fraud Alert: Distributor/</u> <u>Customer Product Ordering</u> <u>Scheme</u>," Version 2 (Updated June 2022). The report discusses methods being used to divert drug shipments and tips for protecting distributors and pharmacies.



The California State Board of Pharmacy urges drug distributors and pharmacists to read the report and learn how to spot fraudulent activity and prevent drug diversion. The Board also reminds licensees never to give out sensitive information over the telephone – and in case of any doubts about the legitimacy of a caller, please contact the Board of Pharmacy directly at (916) 518-3100.

California Health Workforce Research Data Center News Update

The Department of Health Care Access and Information (HCAI), formerly known as the Office of Statewide Health Planning and Development, is partnering with the Department of Consumer Affairs (DCA) and the California State Board of Pharmacy to collect important health workforce data. HCAI is the leader in collecting data and disseminating information about California's healthcare infrastructure. HCAI promotes an equitably distributed health workforce and publishes valuable information about healthcare outcomes.

With the passage of Assembly Bill 133 (Chapter 143, Statutes of 2021), HCAI is launching the California Health Workforce Research Data Center (Center). The Center will serve as the state's central repository for health workforce data, and will collect, analyze, and distribute information on educational and employment trends for healthcare occupations in the state. An annual report will be produced discussing:

- Supply and demand of the health workforce
- Geographical distribution of the health workforce
- Diversity of the health workforce, by specialty (including, but not limited to, data on race, ethnicity, and languages spoken)
- Current and forecasted demand for healthcare workers, by specialty
- Educational capacity to produce trained, certified, and licensed healthcare workers, by specialty and by geographical distribution

HCAI, in partnership with the Board of Pharmacy and DCA, **has developed a workforce survey for licensees to complete during the electronic licensure renewal process. We are asking for your help with this important data collection effort by completing this survey at time of licensure renewal**. This data will help shape the future of health workforce policy in California. The workforce survey will be available beginning July 2022. HCAI plans to present data and findings from the Center at future Board of Pharmacy meetings, social media posts and other outlets.

Board completes Strategic Plan 2022-26

The California State Board of Pharmacy has completed its <u>Strategic Plan 2022-2026</u>, which is intended to guide the Board in its mission to protect and promote the health and safety of Californians by pursuing the highest quality of pharmacist care and the appropriate use of pharmaceuticals through education, communication, licensing, legislation, regulation, and enforcement.

The Strategic Plan is a living document. It is updated on a regular basis to reflect changes in the Board's priorities as changes occur in public health, the marketplace, legislation, and other areas. The Board reviews the status of each goal in the plan annually and typically revises the plan every five years to incorporate necessary changes. The Board reviewed the plan at its meeting July 27-28, 2022, and made no changes to any of its strategic goals.

The Board carries out its mission of consumer protection through policies and initiatives proposed by its five standing committees: Communication and Public Education; Enforcement and Compounding; Legislation and Regulation; Licensing; and Organizational Development. Each committee discusses its respective goals and objectives based on the current and anticipated needs of consumers and the pharmacy profession.

The Strategic Plan 2022-2026 plan was completed after a comprehensive review by the Board. The process included a survey of stakeholders and Board staff. interviews with Board members. and a planning session facilitated by the Department of Consumer Affairs' Office of Strategic Organization,



Leadership, and Individual Development (SOLID).

The Board encourages stakeholders and the public to review its Strategic Plan and to monitor and support progress toward the goals and objectives established in the plan by participating in Board meetings, rulemakings, and other activities. Disciplinary terms explained

Accusation – An accusation is the document containing the charges and allegations of violations of the law that is filed when an agency is seeking to discipline a licensee.

Effective Date of Action – The date the disciplinary action goes into operation.

Revocation or Revoked – The license is taken back by the Board as a result of disciplinary action, and the licensee's right to practice or operate a Boardlicensed entity is ended.

Revoked, Stayed – The license is revoked, but the revocation is not effective as long as the licensee complies with specific probationary conditions, which may include a temporary suspension of the licensee's right to practice.

Stipulated Settlement – The Board and a licensee mutually agree to settle a disciplinary case brought by the board by way of a settlement agreement.

Stayed – The revocation or suspension action is not immediately effective, and the operation or practice may continue so long as the licensee fully complies with any specified terms and conditions.

Probation – The licensee may continue to practice or operate a board-licensed entity under specific terms and conditions for a specific period of time.

Voluntary Surrender – The licensee has agreed to surrender his or her license, and the right to practice or operate a Board-licensed entity is ended. The Board may agree to accept the surrender of a license through a "stipulation" or agreement.

Suspension – The licensee is prohibited from practicing or from operating a Board-licensed entity for a specific period of time.

Suspension/Probation – The right to practice or operate is contingent on compliance with specific terms and conditions during the probationary period, including a term of suspension.

PC 23 Order Issued – The licensee is restricted from practicing or operating by the terms of a court order issued under the provisions of Penal Code section 23.

Public Reprimand – Resulting from a disciplinary action, the licensee is issued a letter of public reprimand.

Reinstatement of License – A previously revoked or suspended license is reinstated with or without specified terms and conditions.

Statement of Issues – A legal document that details the factual or legal basis for which a license was denied.
