# PRESIDENT'S MESSAGE

The California State Board of Pharmacy has completed its 2024 Sunset Review process. On January 6, 2025, the final report was submitted to the legislative oversight committees. On March 11, 2025, I, along with Executive Officer Anne Sodergren, and Licensee Board Member Renee Barker testified in front of state legislatures. You can watch the testimony here. In preparation for the hearing, a background paper was released by the oversight committees that raised 32 issues. The Board provided its responses to the issues raised and looks forward to partnering with the Legislature and the Administration to advance significant consumer protection proposals. Click here to read about the issues identified and the Board's responses. Please keep apprised of this legislative process by monitoring AB 1503.

The Board has completed its work to update compounding regulations. The Board would like to thank you for your robust feedback and most importantly, your patience. The Board began

updating this regulation in 2019, in response to proposed changes to the USP Chapters. In April 2024, the Board began public comment on the proposed text. Due to the considerable amount of interest in this regulation a series of public comment periods were initiated. After a year of public rulemaking activities and modifying the proposed text four times, the Board adopted the regulation text. It will now go through the next stage of promulgation including review with a number of state agencies before becoming final. Please monitor Enforcement and Compounding Committee's activities to continue monitoring subsequent implementation activities. In the meantime, you can click here to gain an understanding of the proposed requirements.

The Board values hearing from you. Just as feedback was important for the compounding regulation, I would like to encourage you to complete the surveys we send out in our subscriber alerts. Thank you to those pharmacy technicians who submitted their replies to the Board's recent Pharmacy Technician survey. Your valuable input could assist in determining if pharmacy technician ratios, and your currently allowed functions are adequate and if additional opportunities remain in providing patient care.

Using your voice is not only important when the Board considers policy changes but also with legislators. I would also like to encourage you to engage with elected officials not only on

pending legislation but also to provide education about your role in the healthcare system. Your experience is unparalleled and invaluable for providing patient care. Please share your contribution with as many legislators as possible to share what you all do every day to help save lives, keep people out of hospitals/ERs and keep people healthy.

A new Pharmacist-in-Charge training webinar is now available on the Board website. This is a free class that pharmacists can take at any time and earn continuing education credit. This class is required prior to approval and appointment as a PIC. You may view the webinar on the Board's learning management system (PharmEd) at any time: Pharmacist-in-Charge: Overview and Responsibilities Training. In addition to the PIC training, I would like to remind licensees to review pharmacy law update, pharmacy ethics course as well as cultural competency training (Cultural competency training is not provided by the Board). All 3 CE courses must be completed every renewal cycle. We are hoping to provide you with an updated Pharmacy Ethics course by the end of this year.

Also, a reminder that self-assessment forms need to be completed by July 1, 2025 (Every odd-numbered year). We ask that you use the most updated draft forms, however, it is not legally mandatory, and you can use alternate final version. The draft forms are posted on the website.



# **Five Free Courses**

The Board of Pharmacy has a new Learning Management System (LMS) named PharmEd. PharmED has <u>free training webinars</u> that pharmacists may complete for continuing education (CE) credit. Currently, there are five free courses offered: Pharmacistin-Charge, Furnishing HIV Preexposure and Postexposure Prophylaxis (PrEP/PEP), Opioid



Safety/Naloxone, Ethics, and Pharmacy Law.

If it is your first time using PharmEd you will need to create an account to enroll.

# Continuing Education Requirement

# Two Hours in Law and Ethics

Continuing Education (CE) requirements include participating in a Board provided CE course in Law and Ethics. Pharmacists must complete at least 30.00 CE hours each renewal period (every two years).

In accordance with California Code of Regulations (CCR) section 1732.5(b), this must include 1.00 CE hour of <u>Board-provided</u> law CE <u>and</u> 1.00 CE hour of <u>Board-provided</u> ethics CE. Additionally, in accordance with Business and Professions Code (BPC) section 4231(b), this must include at least 1.00 CE hour regarding cultural competency. The Board will not be providing a course and cannot recommend or endorse a specific course. # Are You Obstructing Consumers from Obtaining Their Prescription?

# **BPC 733**

Did you know posted in your pharmacy is the Notice to Consumer poster titled "Talk to the Expert" stating:

"This pharmacy must provide any medicine or device legally prescribed for you, unless you are unable to pay the cost of the drug or device, or the pharmacist determines doing so would be against the law, or potentially harmful to the patient's health. If a medicine or device is not immediately available, the pharmacy will work with you to help you get your medicine or device in a timely manner."

Business and Professions Code section 733 states a licentiate shall not obstruct a patient in obtaining a prescription drug or device that has been legally prescribed or ordered for that patient. A violation of this section is considered unprofessional conduct.

Over the past five years, the board has received over 2200 complaints alleging their pharmacy obstructed them from obtaining their prescription with the number of complaints increasing. Approximately 25% of these complaints were substantiated causing consumers a delay in their treatment, missing doses, and rescheduling their appointments.

Whether the pharmacy refused to process a non-controlled substance veterinary prescription without a National Provider Identifier (NPI) number, failed to dispense Paxlovid to start treatment within five days from developing COVID symptoms, or failed to dispense a prescription for post-exposure prophylaxis (PEP) for HIV within 72 hours, these are just a few examples where the pharmacist obstructed the consumer from obtaining their medication in a timely manner.

As a reminder, if the pharmacy does not have a prescription drug or device in stock, the pharmacist must take one of the following actions:

- 1. Immediately notify the patient and arrange for the drug or device to be delivered to the pharmacy or directly to the patient in a timely manner.
- 2. Promptly transfer the prescription to another pharmacy known to stock the prescription drug or device that is near to ensure timely access to the drug or device.
- Return the prescription to the patient and make a reasonable effort by referring the consumer to a pharmacy that stocks the prescription drug or device that is near for timely access.

Pharmacies are not obligated to dispense a prescription drug or device if the consumer is unable to pay, if the pharmacist determines the drug or device would cause a harmful drug interaction or otherwise adversely affect the patient's medical condition, or when exercising their corresponding responsibility dispensing a controlled substance medication.

In addition, a pharmacist may decline filling a drug, based on ethical, moral or religious grounds. However, the pharmacist must "previously" notify their employer, in writing, the drug or class of drugs to which they refuse to dispense. The pharmacy must also establish protocols to ensure the consumer has timely access to the prescribed drug despite the pharmacist's refusal.

Finally, plan ahead. If there are drugs or devices that your pharmacy does not stock, become familiar with the pharmacies in your area who you could contact to determine if they have the drugs or devices in stock; have available the pharmacies phone numbers and addresses in the surrounding area of the pharmacy; and survey the pharmacy staff to determine if there is a drug or class of drugs that they decline to dispense and document in writing.

# Report a Drug Theft/Drug Loss

# **Online Portal**

The Board of Pharmacy has launched a new online portal for reporting the theft or loss of controlled substances. # Senate Bill 339 from Emergency to Permanent

# SB 339 Expands the Authority of Pharmacists When Furnishing HIV Preexposure Prophylaxis (PrEP)

Senate Bill 339 authorizes a pharmacist to furnish up to a 90-day course of preexposure prophylaxis, or preexposure prophylaxis beyond a 90-day course if specified conditions are met. Prior to this bill, pharmacists could only furnish a 30-day supply and up to a 60-day supply if certain conditions were met. An emergency regulation took effect on August 14, 2024 and became permanent on January 31, 2025.

The regulation requires that documentation of preexposure prophylaxis furnished and services provided shall be maintained in patient records, in the record system maintained by the pharmacy, for a minimum of three years from the date when the preexposure prophylaxis was furnished.

Providing PrEP and PEP consultation and treatment in pharmacies is critical to the health, safety, and general welfare of California residents and helps save lives. Pharmacists are unable to provide adequate PrEP consultation and treatment without having access to the necessary patient

records. This regulation extends the maintenance of patient records related to the furnishing of preexposure prophylaxis, ensuring pharmacists have the information they need to comply with BPC section 4052.02(e)(7) and provide patients with the medication and services they need.

# Training for Furnishing HIV Preexposure and Postexposure Prophylaxis (PrEP/PEP)

The Board of Pharmacy has updated the training webinar pharmacists may complete to independently initiate and furnish HIV pre-exposure and post-exposure prophylaxis, pursuant to California Code of Regulations, title 16, section 1747. Pharmacists who successfully complete the training also will receive 1.5 hours of continuing education (CE) credit. Click here for more information on the training.

# **California State Loan Repayment Program**

Pharmacists have the opportunity to support future licensees. A voluntary \$25 contributions may be made by pharmacists and pharmacies at the time of license renewal. This is part of the California

# Strategic Plan 2022-2026

# Mission, Vision, Values



Intended to serve as a guide for coming years, the California State Board of Pharmacy Strategic Plan is reviewed annually to ensure the Board addresses current issues consistently with its stated goals and objectives. It is a living document that provides flexibility in meeting ongoing changes in public health, the marketplace, legislation, and other spheres within a framework established by the Board.

The 2022–2026 Strategic Plan evolved from a process that included a survey of stakeholders and Board staff, interviews with Board members, and a planning session facilitated by the Department of

Consumer Affairs' Office of Strategic Organization, Leadership, and Individual Development (SOLID).

The Board historically carries out its mission of consumer protection through policies and initiatives that originate within its five standing committees:

- 1. Communication and Public Education
- 2. Enforcement and Compounding
- 3. Legislation and Regulation
- 4. Licensing
- 5. Organizational Development

The committees discuss respective strategic goals and objectives based on current and anticipated needs and demands of consumers and the pharmacy profession.

We invite stakeholders to review this Strategic Plan and to monitor and support the Board's progress toward its goals and objectives by participating in Board meetings, rulemakings, and other activities. # Wholesaler Thresholds

The Board has received public comment from patients and patient advocates expressing concern about challenges they experience in filling their controlled substances prescriptions. To gain a better understanding of this issue, the Board has received presentations from various entities seeking to better understand current practices, including wholesaler thresholds.

The Enforcement Committee received a <u>presentation</u> from the Healthcare Distribution Alliance and <u>Cardinal Health</u> on the background of the threshold policy and what pharmacies can do to update their threshold to better serve their patients.

# Background...

A threshold is set for each pharmacy depending on the data the distributor receives during the onboarding process. The threshold is not required by the U.S. Drug Enforcement Administration but are part of the injunctive relief settlements for wholesalers subject to the settlements. Thresholds are established per customer, per drug family basis by DEA base code, independent of each other. DEA does not have a role in establishing or revising thresholds for controlled substances that manufacturers or distributors may set for their customers as part of the required monitoring systems. Cardinal Health utilizes model-based thresholds and identifies orders of "unusual size, frequency, or pattern".

The thresholds are ceilings above which the distributor will not ship controlled substances within a specific accrual period. If an order exceeds a threshold, it is called a threshold event.

If an order is made above the established threshold and prompts a threshold event, the order is automatically held and cancelled. The pharmacy is immediately notified through their purchase order documentation, or a notification is sent for purchases made online. This is called a suspicious order.



A suspicious order doesn't mean illegal activity is occurring. It is a DEA term for <u>Suspicious</u> <u>Orders Report System (SORS)</u>. It means the retail pharmacy customer has hit their threshold, generating a SORS. That report is automatically provided to the California State Board of Pharmacy.

# How and why to increase your threshold...

Communication with your wholesaler is key. If a pharmacy believes they need to increase their threshold, for example, if another retail pharmacy is closing nearby and they know that customers are going to start coming into their pharmacy, the pharmacy can be proactive and put in a request to increase the threshold. Go to the distributor's website (here is Cardinal Health's user guide) and put in a request and explain why you feel you need to change your threshold. Processing times for threshold requests may vary and may take a week to process. Pharmacies are encouraged to check with their wholesalers on processing times.

Please note that consistent with the settlement provisions, established threshold limits cannot be shared with customers.

# **Become a Board of Pharmacy Inspector**

# Join a Team of Dedicated Professionals

The California State Board of Pharmacy regulates one of the largest healthcare fields in the United States, with over 35 types of licenses issued to about 140,000 individuals and facilities. Much of the Board's critical work is carried out on the front line by a dedicated staff of licensed and highly trained pharmacists who serve as Inspectors and Supervising Inspectors.

As the marketplace grows and the practice of

pharmacy evolves, the Board periodically seeks to hire additional inspectors committed to protecting the health and safety of Californians by ensuring the highest level of pharmaceutical care. Pharmacists seeking an exciting career in public service are encouraged to apply to become Board of Pharmacy inspectors.

The Board currently has 50 inspectors. Both new and experienced inspectors alike draw upon their professional backgrounds to help practicing colleagues understand and meet California's legal and regulatory requirements of the pharmacy profession.

"Each and every day is a unique work experience as an inspector, and I am glad I can continue to use my pharmacy degree in unexpected ways." Inspector Diane Mahone previously worked as a hospital director and PIC but said this role has allowed her to help protect patients and improve their care on a larger scale. "It has also given me the opportunity to provide education to a variety of licensees and in return learn from them, as well."

#### What Inspectors do

Under the direction of the Chief of Enforcement and Supervising Inspectors, Board inspectors are organized into teams specializing in key regulatory and enforcement areas, including outsourcing, compounding, compliance, probation monitoring, drug diversion and fraud, and prescription drug abuse. Inspectors are stationed throughout the state and perform their duties through a

combination of homebased work and regular travel, both locally and statewide. National travel may be required occasionally. Home office equipment is provided, and all authorized business and travel expenses are reimbursed.

Generally, inspectors perform inspections

and investigations by enforcing California pharmacy laws and regulations. In addition, inspectors provide consultation and education on laws and regulations to licensees, governmental agencies, consumers, and others.

#### **Typical tasks include:**

- Inspecting all places where drugs or medicines are compounded, dispensed, or retailed to ascertain whether licensees have valid licenses and are complying with state and federal laws and regulations.
- Providing expert consultation and interpretation of the interrelationships between state and federal laws and regulations regarding drugs and the practice of pharmacy.

- Guiding pharmacists in establishing necessary procedures and records required by law.
- Investigating complaints against licensees for alleged violations of the pharmacy laws, collecting evidence, and assisting in prosecution in court or in administrative hearings.
- Inspecting the stock and records of pharmacies to ascertain any conditions that may be hazardous and/or illegal; and inspecting the sanitary conditions of licensees' operating premises.
- Making special surveys and investigations as directed.
- Making recommendations concerning procedures and proposed legislation or regulations.
- Speaking to professional associations and consumer groups and preparing articles for publication.
- Preparing investigative reports and correspondence.
- Encouraging licensees to maintain high ethical standards.
- Keeping abreast of developments in the field and with federal and state guidelines.
- Performing other related duties.

#### Compensation

The monthly salary range for Inspectors is \$8,338 to \$11,004, plus a \$2,000 monthly pay differential. Inspectors also receive all health, retirement, and other employee benefits of state civil service.

#### Minimum qualifications

To be considered for an inspector position, applicants must have a valid California pharmacist license and a valid California driver's license. They must have at least two years of pharmacy practice experience, including direct public contact. Additional information on the position duties and required knowledge, skills, and abilities is available online in the Board of Pharmacy Inspector class specification sheet.

#### How to apply

To apply for an inspector position, you must first become ranked on a civil service exam list. Information on how to apply for a state civil service position is available online at <u>CalCareers</u>. After applying for the civil service position, you will receive notice of your ranking. This ranking is good for one year. Once your ranking has expired, to be eligible, you must reapply for the state civil service position for the inspector position. When an inspector position becomes available and is advertised, applicants who are ranked may apply for the inspector position.

# **CURES Fee Increase**

The Controlled Substance Utilization Review and Evaluation System (CURES) fee will increase from \$9 to \$15 annually for licenses expiring on and after July 1, 2025. The fee is assessed at the time of license renewal on licensees that are authorized to prescribe, order, administer, or furnish Schedule II, Schedule III, Schedule IV, or Schedule V controlled substances.

Pharmacists will see a \$30 CURES fee due to the biennial renewal cycle. The fee covers the reasonable regulatory costs of the Department of Justice for operating and maintaining CURES, a critical element in the state's continued effort to address the danger of opioid addiction stemming from prescription drug abuse.

# A Reminder Regarding Prescriptions Issued by Health Care **Providers Employed by a Tribal Health Program**

**Exemptions from California Licensure Requirements for Tribal Health Care Providers Licensed in Other States** 

Under federal law, licensed health professionals employed by a tribal health program are required to be exempt, if licensed in any state, from the licensing requirements of the state in which the tribal health program performs specified services. California law aligns with this requirement, providing an exemption from California licensure for a health care practitioner, including a physician

or pharmacist, licensed in any state who practices as part of a tribal health program.

Tribal health programs are controlled and sanctioned by Tribal Governments. A tribal health program is defined as an Indian tribe or tribal organization that operates any health program, service, function, activity, or

facility funded, in whole or part, by the Indian Health Service.[1]

California Business and Professions Code (BPC) §719 provides this exemption and states as follows:[2]

(a) A person who possesses a current, valid license as a health care practitioner in any other state and is employed by a tribal health program, as defined in Section 1603 of Title 25 of the United States Code, shall be exempt from any licensing requirement described in this division [i.e., Division 2 (Healing Arts) of the BPC] with respect

to acts authorized under the person's license where the tribal health program performs the services described in the contract or compact of the tribal health program under the Indian Self-Determination and Education Assistance Act (25 U.S.C. Sec. 450 et seq.).

(b) For purposes of this section, "health care practitioner" means any person who engages

> in acts that are the subject of licensure or regulation under the law of any other state.

but licensed in another tribal health programs.

Based upon this law, pharmacists may fill prescriptions written by physicians not licensed in California state and working at

> [1] See Section 1603 of Title 25 of the United States Code, para. (25).

> [2] In 2012, both AB 1896 and SB 1575 were enacted into law. Both bills added a new section, numbered 719, to the BPC, but used slightly different wording. As a result, the BPC includes two separate sections, both numbered 719, providing for this exemption. The statutory text printed above reflects the language added to the BPC by SB 1575 as section 719. The wording in the similar section (also numbered 719) added by AB 1896 is identical, except that the phrase "is licensed" is used in replacement of the phrase "possesses a current, valid license."

- Education of consumers and licensees,
- Promoting policies that protect patients,
- Enforcement related activities such as ensuring that pharmacists provide patients with pharmaceutical care by dispensing information,
- Ensuring minimum competency prior to issuance of a license.

# **Disciplinary Terms Explained**

**Accusation** – An accusation is the document containing the charges and allegations of violations of the law that is filed when an agency is seeking to discipline a licensee.

**Effective Date of Action** – The date the disciplinary action goes into operation.

**Revocation or Revoked** – The license is taken back by the Board as a result of disciplinary action, and the licensee's right to practice or operate a Board-licensed entity is ended.

**Revoked, Stayed** – The license is revoked, but the revocation is not effective as long as the licensee complies with specific probationary conditions, which May include a temporary suspension of the licensee's right to practice.

**Stipulated Settlement** – The Board and a licensee mutually agree to settle a disciplinary case brought by the board by way of a settlement agreement.

**Stayed** – The revocation or suspension action is not immediately effective, and the operation or practice May continue so long as the licensee fully complies with any specified terms and conditions.

**Probation** – The licensee May continue to practice or operate a board-licensed entity under specific terms and conditions for a specific period of time.

**Voluntary Surrender** – The licensee has agreed to surrender his or her license, and the right to practice or operate a Board-licensed entity is ended. The Board May agree to accept the surrender of a license through a "stipulation" or agreement.

**Suspension** – The licensee is prohibited from practicing or from operating a Board-licensed entity for a specific period of time.

**Suspension/Probation** – The right to practice or operate is contingent on compliance with specific terms and conditions during the probationary period, including a term of suspension.

**PC 23 Order Issued** – The licensee is restricted from practicing or operating by the terms of a court order issued under the provisions of Penal Code section 23.

**Public Reprimand** – Resulting from a disciplinary action, the licensee is issued a letter of public reprimand.

**Reinstatement of License** – A previously revoked or suspended license is reinstated with or without specified terms and conditions.

**Statement of Issues** – A legal document that details the factual or legal basis for which a license was denied.
